Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Florida Health Care Plan, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN AND BENEFITS

The following description of the Florida Health Care Plan, Inc. ("FHCP") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all employees of FHCP. The Plan was established January 1, 2009. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA). Employees become eligible to participate in the Plan upon employment and contributions are matched after one year of continuous service, as defined in the Plan Document. The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

B. Contributions

Each year, participants may contribute up to the maximum dollar amount allowed by the Internal Revenue Service (IRS), of pre-tax annual compensation, as defined in the Plan. The maximum dollar amount is adjusted annually by the IRS and varies based on the age of the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. FHCP may elect to contribute to the Plan a discretionary matching contribution to be determined each year by FHCP. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additional amounts may be contributed at the option of FHCP.

Effective January 1, 2018, the Plan was amended to incorporate two changes: 1) the Plan includes an auto-enrollment provision whereby all new eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant and 2) the Plan's Sponsor may make discretionary matching contributions equal to a uniform percentage of the participants' salary deferrals. Each year, the Plan's Sponsor will determine the amount of the discretionary percentage. Currently, the Plan's Sponsor matches 100% of the participants' contribution up to the first 4% of the plan participants' eligible wages.

C. Participant Accounts

Participants direct the investment of their account balance into various investment options offered by the Plan. The Plan currently offers various mutual fund options as investment options for participants, which are offered and managed by AdvisorTrust, Inc.

Each participant's account is credited with the participant's contribution and allocations of the Plan Sponsor's contribution and Plan earnings (losses) and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN AND BENEFITS (Cont'd)

D. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service. The Plan has elected to use the following graduated vesting schedule:

If the participant dies or becomes disabled while still employed by the employer, the participant becomes 100% vested.

E. Investment Options

Upon enrollment in the Plan, participants may direct employee contributions, the employer match contribution and rollover contributions in increments in any of the investment fund options. Participants may change their investment options daily using the internet and secured login access to their individual accounts on the Retirement Plan and Administrators, Inc.'s website.

F. Participants' Note Receivables

The Plan may, subject to the approval of Plan Administrators, make loans to participants or beneficiaries provided such loans are made in a uniform non-discriminatory manner. No loan will be made to the extent such loan, when added to the outstanding balance of all loans exceeds the lesser of (a) Fifty Thousand Dollars (\$50,000) reduced by the excess (if any) of the highest outstanding balance of loans from the Plan to the participant during the one-year period ending on the day before the date on which said loan is made, over the outstanding balance of loans from the Plan to the participant on the date on which such loan is made or (b) One-half (1/2) of the present value of the participant's vested account balance under this Plan, but not less than Ten Thousand Dollars (\$10,000).

Participant note receivables under the Plan must be adequately secured and repaid with principal and interest on a bi-weekly basis over a period not to exceed five (5) years, except for loans to acquire a principal residence, which shall be repaid over a reasonable period of time. Participant loans shall be repaid through payroll withholding and shall be treated as a participant directed investment. Interest rates on the loans upon issuance are based on the prime rate of interest plus 1% (currently 4.25% to 9.50%). Participants' loans outstanding were \$1,420,958 and \$1,293,295 at December 31, 2024 and 2023, respectively.

1. DESCRIPTION OF PLAN AND BENEFITS (Cont'd)

G. Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

H. Distribution to Participants

Amounts credited to an individual participant's account are distributed at termination of employment as a lump sum. Distributions may be deferred until the participant reaches the appropriate age as specified by the Internal Revenue Service, if the value of the distribution is not less than \$1,000. However, the plan agreement stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the appropriate age.

In certain hardship situations, as described in the Plan Document, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship. Participants' withdrawals are limited to required and/or optional deferred account balances and may not include any interest earned thereon.

Effective January 1, 2024, the Plan was amended to include an automatic IRA rollover if a mandatory distribution is being made to the participant because their vested interest in the Plan exceeds \$1 but does not exceed \$7,000; the Plan will rollover the participant's distribution to an IRA if the participant does not make an affirmative election to either receive or roll over the distribution.

I. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AdvisorTrust, Inc. (the trustee of the Plan).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual method of accounting.

B. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

B. Investment Valuation and Income Recognition (Cont'd)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Participants' note receivables are valued at their outstanding balances, which approximates fair value.

C. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participants' accounts and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

D. Payment of Benefits

Benefits are recorded when paid.

E. Forfeitures

Forfeitures from terminated participants' nonvested accounts may be applied to administrative fees. Forfeitures may also be used to offset future employer contributions. Total forfeitures used during the year ended December 31, 2024 was \$42,535. There was \$69,241 and \$5,901 in forfeited nonvested accounts at December 31, 2024 and 2023, respectively.

F. Corrective Distributions

Corrective distributions are recorded in the year which they are returned to the participant. During the year ended December 31, 2024, the Plan returned amounts to participants totaling \$186,277 for contributions in excess of amounts allowed by the IRS. These amounts were recorded as a reduction to contributions.

G. Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

H. Operating Expenses

All expenses to maintain the Plan are paid by the Plan.

3. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the years presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

4. INVESTMENTS

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan assets are held and managed by AdvisorTrust, Inc. The accounts are credited with contributions and earnings on the underlying investments, and charged for Plan withdrawals and administrative expenses by AdvisorTrust, Inc.

The Plan's investments (including investments bought, sold and held during the year) net change in fair value appreciated in value by \$6,875,254 during the year ended December 31, 2024.

5. TAX STATUS

The Volume Submitter Document Sponsor obtained its latest IRS Opinion Letter dated March 31, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since then. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is a qualified plan as described in Section 401(a) of the Internal Revenue Code and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's purpose would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized as of December 31, 2024.

5. TAX STATUS (Cont'd)

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine tax audits by jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for the years prior to 2021.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, FHCP has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by AdvisorTrust, Inc. AdvisorTrust, Inc. is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$374,777 for the year ended December 31, 2024. This party-in-interest transaction is exempt from the prohibited transaction rules of ERISA.

8. RISKS AND UNCERTAINTIES

A. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

B. In December 2019, an outbreak of a novel strain of coronavirus (COVID-19) originated and spread to several countries, including the United States. On March 11, 2020, the World Health Organization characterized COVID-19 as a pandemic. In addition, multiple jurisdictions in the United States declared states of emergency. The potential future disruptions to the Plan or the Plan Sponsor's operations or financial impact of these issues, if any, cannot be determined. The long-term economic impact on the business environment is unknown.

9. DATE OF MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.



