Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mathiowetz Construction Co. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mathiowetz Construction Co. Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following brief description of the Mathiowetz Construction Co. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all eligible employees of The Mathiowetz Construction Co., Mathiowetz Enterprises, Inc., and Family Tree LLC (collectively the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions and Vesting

The Plan has four components: a Davis-Bacon pension component, a pre-tax 401(k) deferral component, a Roth 401(k) deferral component, and an integrated defined contribution profit sharing component. Each of these components is described below.

Contributions to the Davis-Bacon pension component are made to satisfy the minimum wage and fringe requirements for certain government contracts. A contribution is only made for hours worked on contracts with Davis-Bacon requirements and is calculated based on the Davis-Bacon rates for that area for the job classification of the work performed. All employees are immediately eligible and are immediately 100% vested.

In the pre-tax and Roth 401(k) deferral components, participants may contribute up to 100% of eligible compensation, or up to the maximum allowed by the Internal Revenue Code (IRC). All employees are immediately eligible and immediately 100% vested in the pre-tax and Roth 401(k) deferral components of their account. All employees hired subsequent to March 31, 2012 are automatically enrolled into the pre-tax deferral provision at 5% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans.

The contribution to the profit sharing component may be made at the discretion of the Employer. All contributions are made based on the classification of the participant. The contributions are calculated using the base percentage and the integrated amount designated by the Employer each year. All employees who have completed one year of service (1,000 hours), are employed at the end of the Plan year, and are at least 21 years of age are eligible to participate in the employer profit sharing contribution within the Plan.

Contributions from the integrated profit sharing component vest ratably over six years and are 100% vested after six years of service.

Participants shall also be 100% vested upon any of the following events: the participant's death, attainment of normal retirement age as defined in the Plan, the participant's disability, or upon partial or complete termination of the Plan. Forfeitures of terminated participants' nonvested accounts are allocated based on participant account balances.

The combined contributions of all components cannot exceed 100% of compensation or the maximum allowed by the IRC, whichever is less.

Participant Accounts

Davis Bacon, pre-tax 401(k), Roth deferrals, and profit sharing contributions are allocated to separate individual accounts. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Each participant directs their contributions into investment funds, which are held by the collective investment fund. Earnings from the funds are allocated on the basis of participant account balances invested in the respective funds. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Benefit Payments

Upon termination of service, death, disability, or retirement (age 65), the participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. If a participant terminated employment and the participant's account balance was never greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan also allows for in-service withdrawals upon attainment of age 59½.

The Plan shall make automatic rollovers of vested account balances that are greater than \$1,000 but are not more than \$5,000. The participant has the option to request a distribution of the value of the entire vested portion of such account balance.

Forfeitures

Forfeitures are used to make restorations for rehired participants, to reduce Employer contributions, to pay Plan expenses, or to correct errors, omissions, and exclusions. Forfeitures of \$32 and \$7,438 were used to pay Plan expenses during the years ended March 31, 2025 and 2024, respectively. There were no forfeitures used to offset employer contributions during the years ended March 31, 2025 and 2024. Unallocated forfeitures as of March 31, 2025 and 2024 were \$-0- and \$31, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results may differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The collective investment funds are valued based on the net asset value (NAV) of units, which are based on market prices of the underlying investments, held by the Plan at year-end. NAV is a readily determinable fair value and the basis for current transactions. Participant transactions may occur daily.

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Employer incurs and pays certain administrative expenses on behalf of the Plan. In August 2023, the Plan migrated to a new investment platform to optimize the investment options available to Plan participants and minimize the cumulative fees of the Plan. As part of the migration process, administrative expenses are now separately stated to provide greater transparency to Plan participants. Previously, certain administrative expenses were included as part of the fund's performance.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan was restated effective May 16, 2025, to add installment payments as an option to receive benefits, as well as to remove the service requirement for taking in-service distributions.

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

American Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of March 31, 2025 and 2024, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of March 31, 2025.

NOTE 4 FAIR VALUE INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used as of March 31, 2025 and 2024.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020 received from the Internal Revenue Service (IRS) on the prototype Plan indicating that the prototype Plan is qualified under Section 401 of the IRC and is, therefore, not subject to current income tax law. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, the Employer will direct the trustee with respect to the distribution of accounts. Liquidation of assets and payment of benefits will be made provided that the Plan is in compliance with the applicable Plan termination requirements of ERISA and the IRC. In the event of Plan termination, participants become 100% vested in their accounts.

NOTE 8 PARTY IN INTEREST

Certain Plan investments are managed by the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
