#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## **Basis for Opinion**

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN AND BENEFITS

The following description of the Florida Health Care Plan, Inc. ("FHCP") Defined Contribution 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all employees of FHCP. The Plan was established September 7, 1997 and was subsequently amended and restated. The Plan was frozen to future contributions effective December 31, 2008. The Plan is subject to the provisions and requirements of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

B. Contributions

The Plan was frozen to future contributions effective December 31, 2008. Plan participants may elect to contribute rollover contributions or transfers representing distributions from other qualified plans if such rollovers or transfers do not jeopardize the tax-exempt status of the Plan or create adverse tax consequences for the Employer.

C. Participant Accounts

Participants direct the investment of their account balance into various investment options offered by the Plan. The Plan currently offers various mutual fund options as investment options for participants, which are offered and managed by Reliance Trust Company.

Each participant's account is credited with an allocation of Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Currently, the Plan is frozen and all participants' accounts are 100% vested if they met the credited service requirements and had not terminated employment before the Plan was frozen.

D. Vesting

Participants are immediately vested in their contributions, if any, plus actual earnings thereon. Since the Plan has been frozen, all participants' accounts are 100% vested if they met the credited service requirements and had not terminated employment before the Plan was frozen.

E. Investment Options

Each participant account is self-directed and credited with their own account's gains/losses. Participants may change their investment options daily using the internet and secured login access to their individual accounts on the Retirement Plan and Administrators, Inc.'s website.

1. DESCRIPTION OF PLAN AND BENEFITS (Cont'd)

F. Participants' Note Receivables

The Plan may, subject to the approval of Plan Administrators, make loans to participants or beneficiaries provided such loans are made in a uniform non-discriminatory manner. No loan will be made to the extent such loan, when added to the outstanding balance of all loans exceeds the lesser of (a) Fifty Thousand Dollars (\$50,000) reduced by the excess (if any) of the highest outstanding balance of loans from the Plan to the participant during the one-year period ending on the day before the date on which said loan is made, over the outstanding balance of loans from the Plan to the participant on the date on which such loan is made or (b) One-half (1/2) of the present value of the participant's vested account balance under this Plan, but not less than Ten Thousand Dollars (\$10,000).

Participant note receivables under the Plan must be adequately secured and repaid with principal and interest on a bi-weekly basis over a period not to exceed five (5) years, except for loans to acquire a principal residence, which shall be repaid over a reasonable period of time. Participant loans shall be repaid through payroll withholding and shall be treated as a participant directed investment. Interest rates on the loans upon issuance are based on the prime rate of interest plus 1% (currently 4.25% to 9.50%). Participants' loans outstanding were \$141,117 and \$165,913 at December 31, 2024 and 2023, respectively.

G. Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

H. Distribution to Participants

Amounts credited to an individual participant's account are distributed at termination of employment as a lump sum, in installments or as an annuity. Distributions may be deferred until the participant reaches the appropriate age as specified by the Internal Revenue Service, if the value of the distribution is not less than \$1,000. However, the Plan Document stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the appropriate age.

In certain hardship situations, as described in the Plan Document, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship. Participants' withdrawals are limited to required and/or optional deferred account balances and may not include any interest earned thereon.

Effective January 1, 2024, the Plan was amended to include an automatic IRA rollover if a mandatory distribution is being made to the participant because their vested interest in the Plan exceeds \$1 but does not exceed \$7,000; the Plan will rollover the participant's distribution to an IRA if the participant does not make an affirmative election to either receive or roll over the distribution.

1. DESCRIPTION OF PLAN AND BENEFITS (Cont'd)

I. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Participants' note receivables are valued at their outstanding balances, which approximates fair value.

C. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participants' accounts and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

D. Payment of Benefits

Benefits are recorded when paid.

E. Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts may be applied to administrative fees for the year. There were \$1,088 in forfeitures used during the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$781 and \$1,802, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

F. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

G. Operating Expenses

All expenses to maintain the Plan are paid by the Plan.

3. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the years presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024 there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

4. INVESTMENTS

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's assets are held and managed by Reliance Trust Company. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses by Reliance Trust Company.

The Plan's investments (including investments bought, sold and held during the year) net change in fair value appreciated in value by \$988,091 during the year ended December 31, 2024.

5. TAX STATUS

The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is a qualified plan as described in Section 401(a) of the Internal Revenue Code and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's purpose would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized as of December 31, 2024.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine tax audits by jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for the years prior to 2021.

6. PLAN TERMINATION

Effective December 31, 2008, the Plan was frozen and there will be no future employer contributions. All participants are 100% vested in their accounts if they met the credited service requirements and had not terminated employment before the Plan was frozen.

7. RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity Investments and Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$56,071 for the year ended December 31, 2024. This party-in-interest transaction is exempt from the prohibited transaction rules of ERISA.

8. RISKS AND UNCERTAINTIES

A. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. RISKS AND UNCERTAINTIES (Cont'd)

B. In December 2019, an outbreak of a novel strain of coronavirus (COVID-19) originated and spread to several countries, including the United States. On March 11, 2020, the World Health Organization characterized COVID-19 as a pandemic. In addition, multiple jurisdictions in the United States declared states of emergency. The potential future disruptions to the Plan or the Plan Sponsor's operations or financial impact of these issues, if any, cannot be determined. The long-term economic impact on the business environment is unknown.

9. DATE OF MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.
