Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of plan

The following brief description of the Entech Consulting, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) Plan covering substantially all employees of Entech Consulting, LLC (the “Company” or “Employer”) who have met certain periods of service and age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective on December 29, 2022, the Setting Every Community Up for Retirement Enhancement (“SECURE”) 2.0 Act of 2022 (the “Act”) was signed into law. The Act is inclusive of approximately 90 provisions which offer many benefits to employers and Plan participants. Certain provision changes are related to the following, but not limited to: changes to auto-enrollment and auto-escalation, age of required minimum distributions, catchup contributions, and increased dollar threshold for mandatory distributions. Depending on the specific provision, some will take effect immediately, while others begin in a future year.

The Plan has adopted the required minimum distributions at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of the SECURE 2.0 Act by December 31, 2025.

Contributions

Contributions consist of employee elective deferrals, Company safe harbor matching contributions and Company discretionary contributions. Employees may voluntarily contribute up to 100% of their compensation on a pretax or post tax basis (“Roth”), limited to \$23,000 in 2024 and \$22,500 2023, as prescribed by the Internal Revenue Code (“IRC”). Participants age 50 and older may elect to make additional catch-up contributions of \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans (“Rollovers”).

The Plan Sponsor may also make discretionary matching contributions to the Plan. The Company elected out of making discretionary employer contributions for both years. In addition, contributions are subject to other limits under the IRC.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts

A separate account is maintained for each participant, which is credited with the participant’s contributions, Rollover contributions, Employer contributions and an allocation of Plan earnings/losses and expenses, if any. Allocation of Plan earnings and expenses is based upon participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of plan (continued)

Vesting

Participants are always 100% fully vested in their voluntary contributions, Rollovers contributions and actual earnings or losses thereon. Employees are 100% vested in Employer contributions after three years of vesting service, and they are 0% vested if they have less than three years of vesting service. A year of vesting service is defined as 1,000 hours of service during the Plan year. Participants are 100% vested upon death, total and permanent disability or retirement. There are currently no forfeitures.

Notes receivable from participants

Participant loans are not permitted by the Plan.

Payment of benefits

Upon termination of service due to death, disability, retirement, resignation, or discharge, a participant may be paid a lump sum, cash only amount equal to the participant's vested account value or may elect to receive equal installments over a fixed time period. The Plan provides for hardship distributions which are available only for the purpose of meeting immediate and heavy financial needs. Participants may elect to take a partial or total distribution when they reach age 65 or at any time thereafter, even if they have not terminated employment with the Company. The Plan does not have an early retirement feature. Account balances that are under \$1,000 are distributed directly to participants in cash. Balances between \$1,000 and \$5,000 will be distributed by the Company, and may be received in cash or rolled over to an IRA account. An account must be fully vested for a participant to receive an in-service withdrawal.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year. All gains and losses are reported in the accompanying StatementS of Changes in Net Assets Available for Benefits.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Services (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions payable as of December 31, 2024 and 2023.

Payment of benefits

Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. As of December 31, 2024 and 2023, amounts payable to participants was \$575 and \$-0-, respectively.

Plan expenses

Administrative costs of the Plan may be paid by the Company and excluded from these financial statements. Costs not paid by the Company are charged to participants’ accounts. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Statement presentation

The Plan presents in the statements of changes in net assets the net appreciation/depreciation in fair value of its investments which consists of the realized gains or losses and the unrealized appreciation/depreciation on those investments.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits. The Plan, through its investment advisor, determines the appropriateness of the Plan’s investment offerings and monitors investment performance and the risks associated therewith on a regular basis, which the Plan believes minimizes these risks.

Subsequent events

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued, and there are no subsequent events requiring disclosure.

3. Fair value measurements

That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* (“ASC 820”) are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

3. Fair value measurements (continued)

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived Ascensus from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value ("NAV") of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Information certified by the Plan's Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, and interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus Trust Company ("Ascensus"), the trustee of the Plan.

5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

6. Party-in-interest transactions

During the years ended December 31, 2024 and 2023, Ascensus served as trustee of the Plan and therefore, any fees paid by the Plan to Ascensus qualify as party-in-interest transactions. Additionally, Sterling Investment Advisors, LTD ("Sterling") served as the Plan's investment advisor and therefore any fees paid to Sterling qualify as party-in-interest transactions. Aggregate fees paid by the Plan to parties-in-interest during the years ended December 31, 2024 and 2023 totaled \$45,943 and \$41,425, respectively. Additionally, certain investment related fees incurred by the Plan have been included in net appreciation/depreciation in fair value of investments as they are paid through revenue sharing rather than as a direct payment.

7. Tax status

The Plan document is a non-standardized pre-approved profit-sharing plan with CODA, which obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan document has been amended since receiving this opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan is qualified and the related trust is tax-exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
