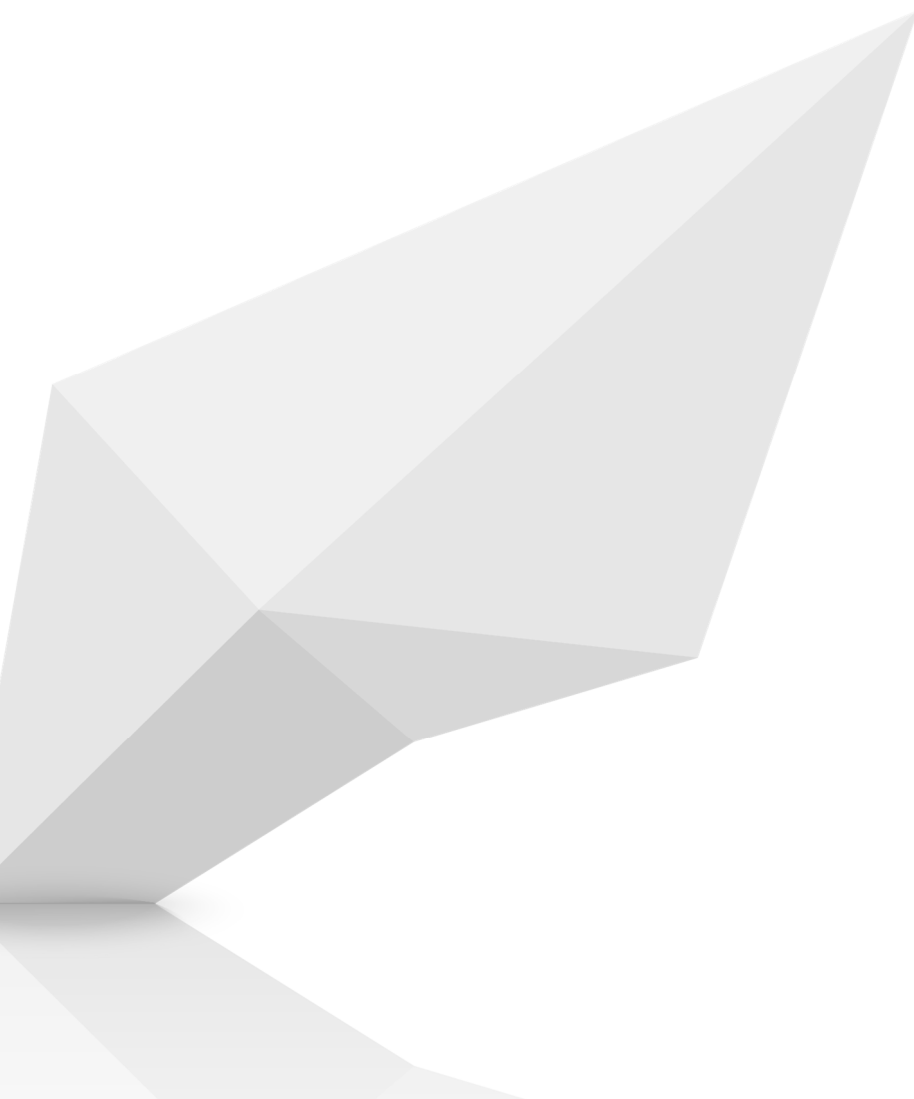

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Crate & Barrel Holdings, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Crate & Barrel Holdings, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to the Financial Statements

Note 1: Description of Plan

The following description of the Crate & Barrel Holdings, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Euromarket Designs, Inc. doing business as Crate & Barrel, CB2, and Hudson Grace (collectively the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Substantially all employees of the Company are eligible to participate in the Plan immediately upon hire. Union employees under a collective bargaining agreement, residents of Puerto Rico, leased employees, independent contractors and seasonal employees are not eligible to participate in the Plan; however seasonal employees are eligible to participate upon completing one year of service and 1,000 hours as defined by the Plan.

Contributions

Participants may contribute 75% of annual compensation, as defined by the Plan, up to the Internal Revenue Service (IRS) limits and can defer into both pre-tax and Roth after-tax options. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants have their deferral rate increased at a rate of 1% every May 1st up to a maximum of 15% of eligible compensation, unless the participant opts out of the increase.

The Plan provides for Company matching contributions to be contributed each pay period to eligible participants who have made pre-tax or Roth after-tax contributions, including catch-up contributions, in an amount equal to 50% of the participant's deferrals up to 6% of eligible plan compensation. The Company made matching contributions of \$9,190,005 for the year ended December 31, 2024. The Plan also provides for a discretionary profit sharing contribution and a discretionary financial wellness credit contribution, as defined by the Plan, for those who are employed on the last day of the Plan year. No discretionary profit sharing contribution or discretionary financial wellness credit contribution were made for the year ended December 31, 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's discretionary profit sharing and financial wellness credit contributions, (b) plan earnings, and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions, Company matching contributions, and Company discretionary profit sharing contributions, plus actual earnings thereon. Participants fully vest in their Company discretionary financial wellness credit contributions after three years of service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Interest rates on notes outstanding at December 31, 2024 ranged from 3.25% to 10.50%. Principal and interest are paid ratably through payroll deductions over a maximum of 5 years for general purpose loans and over a maximum of 20 years for principal residence loans. The maximum number of loans that a participant may have outstanding is one.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period based on the participant's life expectancy, as defined in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$110,046 and \$112,734, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the Plan document. Forfeitures of \$46,410 were used to reduce Company matching contributions related to the Plan year ended December 31, 2024. No forfeitures were used to pay administrative expenses during 2024.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 (“SECURE 2.0”), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value, except for the group annuity contract which is a fully benefit-responsive investment contract (FBRIC). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

Subsequent Events

The Company has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: The pooled separate accounts are valued at net asset value ("NAV") per unit provided by the issuer of the pooled separate account. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments owned by the fund, minus its liabilities, and divided by the number of shares outstanding.

Note 3: Fair Value Measurements (Continued)

(a) Equity funds include large, mid, and small cap growth and income funds both domestic and international and seek to provide opportunities for capital appreciation while providing a diverse mix of options for participant asset allocation preferences.

Note 4: Fully Benefit-Responsive Investment Contract (FBRICs)

The Plan invests in a FBRIC with Empower Annuity Insurance Company of America (Empower Annuity) in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. Empower Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower Annuity including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Empower Annuity to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by Trustee and Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the Trustee of the Plan, and Empower Annuity Insurance Company of America, a Custodian of the Plan.

Note 6: Party-In-Interest Transactions

Certain plan investments are managed by Empower Trust Company, LLC, the Trustee of the Plan, and Empower Annuity Insurance Company of America, a Custodian of the Plan, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also pays fees to certain service providers for administration services, professional fees, investment advisory services and recordkeeping services, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for these services were \$1,044,675 and \$1,002,417 for the years ended December 31, 2024 and 2023.

Empower Trust Company, LLC receives revenue from mutual fund service providers for services they provide to the various funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative and recordkeeping services to the Plan. For the year ended December 31, 2024, \$110,046 was remitted to the Plan, included in other income, and used to pay administrative expenses.

Notes receivable from participants also qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary financial wellness credit contributions.

Note 8: Tax Status

The Company adopted a restated and amended Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan ("Prototype Plan") sponsored by Empower Retirement LLC. The Prototype Plan obtained its latest IRS determination letter on November 14, 2022, in which the IRS stated that the Prototype Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Company is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Company's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Company. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions and loan repayments for two payrolls during the plan year ended December 31, 2023, totaling \$5,405 were remitted within the 15-day requirement but not at the earliest day reasonably segregated. This transaction constitutes a prohibited transaction as defined by ERISA. The Company remitted these contributions during 2023 and intend to remit lost earnings to participant accounts during the Plan year ending December 31, 2025.
