As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis For Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities Of Management For The Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities For The Audit Of The Financial Statements***

Except as described in the Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required By ERISA***

The supplemental schedule of assets held at end of year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of Unity Healthcare 401(k) Profit Sharing Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

#### General

The Plan is a defined contribution profit sharing plan with a 401(k) provision established on January 1, 1996, and most recently amended and restated effective January 1, 2022. The Plan covers substantially all employees of Unity Healthcare LLC (the Company or the Plan Sponsor) who have completed 12 months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan uses Matrix Trust Company as trustee and Milliman, Inc., as recordkeeper.

#### Contributions

Participants may defer salary up to 100% of eligible compensation, as defined by the Plan, not to exceed the maximum amount allowed by law. Roth contributions are also permitted under the Plan. Additionally, participants age 50 and over may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for Company safe harbor matching contributions equal to 100% of a participant's salary deferrals, up to 3% of eligible compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation. Safe harbor contributions to the Plan totaled \$608,165 and \$998,403 in 2024 and 2023, respectively. In addition, the Plan also provides for Company discretionary profit sharing contributions. The Company made discretionary profit sharing contributions of \$868,278 and \$2,259,372 in 2024 and 2023, respectively, which are reported net of forfeitures utilized.

Effective July 1, 2024, the Company no longer provides a discretionary profit sharing contribution.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions, the Company's safe harbor matching contributions, and an allocation of Company profit sharing contributions and Plan's earnings and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Vesting**

Participants are 100% vested in their deferral contributions, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon. Participants do not become vested in the Company discretionary profit sharing contributions until completing three years of service. Nonvested amounts are forfeited if an employee terminates prior to fully vesting. Participants automatically become vested in their accounts upon reaching normal retirement age of 65, or upon death or disability.

#### **Unallocated Accounts**

Forfeitures of the nonvested portions of a participant's Company discretionary profit sharing contribution may be used to reduce the Company's profit sharing contributions to the Plan. Forfeitures used to reduce the Company's profit sharing contributions totaled \$147,706 and \$46,470 in 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited nonvested account balances available for future use totaled \$16,711 and \$21,071, respectively.

The Plan maintained an ERISA expense account used to pay Plan expenses. The expense account was funded through revenue sharing. There was no available balance in the account as of December 31, 2024 and 2023. There were no expenses paid from this account during the year ended December 31, 2024. During 2023, \$16,339 of expenses were paid from this account.

#### **Payment Of Benefits**

Upon termination of service, death, disability, or attainment of normal retirement age, a participant may elect distribution of his or her account. The normal form of distribution for a participant with Employer Pension (as defined in the Plan Document) balances is a joint and survivor 50% annuity for a married participant and a single life annuity for unmarried participants. For all other participants, the normal form of distribution is a lump-sum distribution. Partial withdrawals or installment payments are only permitted for required minimum distributions under the Internal Revenue Code (IRC).

#### **In-Service Withdrawals**

The Plan allows in-service withdrawals by active participants who attain age 59-1/2 as defined by the Plan. These withdrawals are subject to certain Plan and IRC restrictions.

#### **Participant Hardship Withdrawals**

Active participants who experience a qualifying financial hardship may withdraw part of their vested funds as detailed in the Plan Document. The Plan Sponsor will approve hardship withdrawals only if they conform to Plan provisions and established IRC safe harbor hardship withdrawal provisions.

#### **Administrative Expenses**

Fees related to the administration of notes receivable from participants, distributions, investment management, and other operational expenses are charged directly to the participants' account and are included in administrative expenses. All other administrative expenses of the Plan are paid by the Plan Sponsor.

#### **Investment Options**

Participants may direct the investment of their account in various registered investment companies or in individually directed brokerage accounts.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance as of the date of the loan. Participants may only have one loan outstanding at any given time. Loans are secured by the participant's vested account balance. Interest charged to participants is at the prime rate, as published in the Wall Street Journal, as of the day preceding the loan plus one percent. Loan terms must not exceed five years. Principal and interest are paid ratably through payroll deductions, except for owners, whose loans are paid on a monthly basis from their partnership account.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting, except for benefit payments, which are recorded when paid.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable are recorded as a distribution based on the terms of the Plan Document. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Subsequent Events**

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

### 3. Certified Investment Information

#### 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Registered Investment Companies**

Registered investment companies consist of mutual funds and an exchange traded fund. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Individually Directed Brokerage Accounts**

Individually directed brokerage accounts are comprised of mutual funds, common stocks, exchange traded funds, a limited partnership, a hedge fund, corporate and municipal bonds, treasury notes, a variable annuity contract, and money market funds.

Common stocks, exchange traded funds, and certain limited partnerships are valued at the closing price reported on the active market on which the individual securities are traded.

Corporate and municipal bonds and treasury notes, are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

The variable annuity contract, certain limited partnership and hedge fund are valued at the NAV of units of the funds. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Money market funds are valued in the same manner as the mutual funds described above.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (2) Consists of the Third Point Offshore Fund, Ltd., the objective is to achieve attractive returns by using an event-driven, bottom-up, fundamental approach to evaluate various types of securities throughout companies' capital structures. The fund typically provides for quarterly redemption opportunities, but these are subject to restrictions such as aggregate quarterly caps ("gates"), possible in-kind distributions for illiquid assets, and advance notice requirements. There are no unfunded commitments.
- (3) Consists of the Bridge Multifamily Fund IV International-A LP and targets consumer real estate services sector. The fund focuses on multi-family asset class. This fund is structured as a closed-end vehicle and therefore does not typically allow investor redemptions during its term. Liquidity is usually only available at the end of the fund's life through asset sales, in connection with a continuation vehicle (if offered), or by finding a buyer in the secondary market. There are no unfunded commitments.

There have been no changes in the valuation methodologies used at December 31, 2024 or 2023.

## 5. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## 6. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balances.

### **7. Income Tax Status**

The Company adopted the Milliman, Inc. pre-approved plan document. The document sponsor has received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, in which the IRS stated that the pre-approved plan, as designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since the date of the opinion letter. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Party In Interest Transactions**

The Plan incurred fees for administrative functions through service agreements from various service providers. In addition, certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as allowable party in interest transactions.
