INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Asyst Technologies Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Asyst Technologies Retirement Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Asyst Technologies Retirement Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 18, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Asyst Technologies L.P. is the plan sponsor, employer and the plan administrator. CPI Qualified Plan Consultants, Inc., a division of CUNA Mutual Investment Corporation, is the third party administrator and the plan's tax counsel that performs various compliance tests and recordkeeper that maintains investment and participant records. CMFG Life Insurance Company ("CMFG Life"), a division of CUNA Mutual Financial Group, Inc., is the custodian that holds the plan's stable value investment and notes receivable from participants. MG Trust Company d/b/a Matrix Trust Company ("Matrix") is the custodian that holds the plan's mutual fund investments. Spectrum Investment Advisors, Inc. is the plan's investment advisor. Two officers of the plan sponsor are the plan trustees.

Investments - The plan administrator determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings, including the net appreciation (depreciation) in fair value of investments bought, sold and held during the years, are reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

Investment at contract value - The plan invests in a CMFG Life stable value account through a group annuity contract between the plan and CMFG Life. The contract is an obligation of CMFG Life and is supported by the general account assets of CMFG Life. Interest rates are adjusted quarterly and credited daily. There are no penalties assessed for benefit payments or other withdrawals taken by participants.

This guaranteed interest account meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the amount participants receive if they initiate permitted transactions under the terms of the plan. Contract value, as reported by CMFG Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The contract is subject to a market value adjustment if the plan terminates the contract and elects a lump sum distribution, which may result in a payout of less than 100% of principal and interest credited. The plan does not anticipate terminating the contract. The contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that may limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective January 1, 1984 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to participate in the plan once they have completed one month of service and have reached age eighteen. An employee can enter the plan on the first day of the month coinciding with or following meeting the eligibility requirements.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Newly eligible employees are automatically enrolled in the plan and have 4% of their compensation withheld as elective deferral contributions. These participants' elective deferral percentages then automatically increase by 1% each year until they reach a maximum of 8%. Effective January 1, 2024, these participants' elective deferral percentages automatically increase by 1% each year until they reach a maximum of 10%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Matching contributions may be made at the employer's discretion. The employer elected to contribute employer discretionary matching contributions equal to 50% of the first 6% of participants' deferrals, up to 3% of eligible compensation during 2023. These contributions were funded coinciding with each payroll with an annual true-up contribution. No such contributions were made in 2024.
- d. Effective January 1, 2024, the plan was amended and now requires safe harbor contributions equal to 100% of the first 1% and 50% of the next 5% of employee compensation contributed as elective deferral contributions. These contributions are funded coinciding with each payroll with an annual true-up contribution.
- e. Nonelective contributions may be made at the employer's discretion. No such contributions were made in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of employer contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral contributions, rollover contributions, and related earnings. Participants begin vesting in employer matching and nonelective contributions and related earnings upon one year of service, at which time they are 20% vested. Participants then vest at the rate of 20% for each year thereafter. Participants are not vested in any portion of their employer safe harbor contributions until they have completed two years of service, at which time they are 100% vested. Upon death, disability, attainment of early retirement age (defined as age 55 with 5 years of service) or normal retirement age (defined as age 59 ½) while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age while employed. Distributions may be in the form of a single lump sum, installments or partial withdrawals. In addition, hardship withdrawals are permitted under the plan.

Administrative expenses - Certain administrative expenses of the plan are paid by the plan sponsor. Certain other administrative fees are paid from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution and loan fees and non-participant directed charges for administrative, service and advisory fees. Non-participant directed charges not paid via forfeitures are allocated to participants on an account value basis.

Forfeitures - Forfeited nonvested accounts may be used to pay plan expenses or reduce the amount of the employer contributions. Forfeitures used to pay plan expenses were \$7,000 in 2024 and \$7,000 in 2023. Forfeiture used to reduce the amount of employer contributions were \$8,000 in 2024 and \$1,000 in 2023. Unapplied forfeitures were insignificant as of December 31, 2024 and 2023.

Notes receivable from participants - Participants can take out loans against their accounts with approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may only have two loans outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants have various repayment schedules through October 2029 with interest from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by the custodians as defined in Note 1. The custodians also provide certain administrative services to the plan pursuant to service agreements between the plan sponsor and the custodians. Direct fees paid to the custodians were \$20,000 in 2024 and \$18,000 in 2023. The custodians receive indirect compensation from mutual fund service providers for services the custodians provide to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed by the plan to the custodians for its administrative services to the plan. Transactions between the plan and the custodians qualify as party-in-interest transactions.

Pursuant to a service agreement between the plan sponsor and the custodians, the custodians remit certain service credits to the plan on a periodic basis. These service credits are held in an unallocated suspense account and are used by the plan to pay certain plan administrative expenses or reallocated to participants if not used by the plan in a timely manner as further described in the related plan documents. Service credits received, recorded by the plan as a component of net appreciation in fair value of investments, were \$23,000 in 2024 and \$24,000 in 2023. Service credits used to pay administrative expenses, recorded by the plan as a component of administrative expenses, were \$23,000 in 2024 and \$24,000 in 2023. Unused service credits held in the suspense account were insignificant as of December 31, 2024 and 2023.

Notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any employer contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under a CMFG Life Insurance Company pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The favorable opinion letter from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY THE CUSTODIANS

Management has obtained certifications from the custodians (as defined in Note 1), qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held, and the fair and contract values of such, and notes receivable from participants as of December 31, 2024 and 2023;
- b. Dividends and interest income on investments, net appreciation (depreciation) in fair values of investments and interest income on notes receivable from participants during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

As discussed in Note 1, the financial statements are prepared under the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred. The plan's Form 5500s were prepared under the cash basis method of accounting. As a result, the plan's financial statements differ from the Form 5500s due to recording certain additions and related assets when received rather than when earned. The following are reconciliations.
