- the information in the accompanying financial statements related to benefits provided under the Plan or assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ASTECH Corp. Employees Savings Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedules of assets (held at end of year) and schedule of delinquent participant contributions as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary schedules required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **ASTECH Corp. Employees Savings Trust Notes to Financial Statements**

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the ASTECH Corp. Employees Savings Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan, under section 401(k) of the internal revenue code (IRC), covering employees of Asphalt Surface Technologies Corporation, a/k/a ASTECH Corporation, (the "Company") who have completed 60 days of service and are at least 18 years of age. Entry dates are the first day of the month after eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may, after meeting eligibility requirements, contribute up to 100% of their compensation to the Plan subject to limitations as determined by law. Participants are automatically enrolled to withhold 6% of their compensation if they have not completed a salary deferral agreement by the time they are eligible to make deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may at its discretion make matching contributions to the Plan. Currently the Company will match 50% of the first 6% of participant contributions, for a maximum of 3%.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of any Company contributions and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are fully vested in their voluntary and rollover contributions at all times. Participants vest ratably in Company discretionary matching contributions after they complete two years of service and are fully vested at the end of six years of service. Participants are credited for a year of service for each calendar year in which they work 500 or more hours. Participants with less than two years of service have no vesting rights in Company contributions.

#### **Payment of Benefits**

Upon termination of service, death, disability, or retirement, the participants may receive the value of their vested interest in their account in the form of a lump-sum distribution or periodic installments. If a participant terminates employment and the participant's account balance is not greater than \$1,000, the plan administrator will authorize the benefit payment without the participant's consent. The Plan allows for in-service withdrawals on elective deferrals, matching contributions and rollover balances and also allows in-service withdrawals on vested balances at any time after reaching age 59½. Hardship distributions are available subject to certain restrictions as defined in the plan document.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Forfeitures**

Forfeitures result from a terminated participant's failure to be fully vested in the Company's contributions to the Plan. Forfeitures resulting from employer discretionary matching contributions may be used to pay plan expenses or reduce future Company contributions. Forfeited nonvested accounts totaled \$98,723 and \$98,635 at December 31, 2024 and 2023, respectively. During 2024, forfeitures totaling \$31,282 and \$90,298 were used to pay plan expenses and reduce matching contributions, respectively. During 2023, forfeitures totaling \$21,045 and \$50,526 were used to pay plan expenses and reduce matching contributions, respectively.

**Notes Receivable from Participants**

The Plan does not allow participants to borrow against the value of their accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustees, custodian, and investment advisor.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation represents the Plan's gains or losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Funding Policy**

Company matching contributions are generally remitted to the Plan at the same time as employee deferrals.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participants account and are included in benefit payments to participants. Investment related expenses are included in net appreciation in fair value of investments and administrative expenses.

**Subsequent Events**

The Plan has evaluated subsequent events through September 26, 2025, the date which the financial statements were available to be issued.

**NOTE 3 - CERTIFICATION**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividend income for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee, of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed interest accounts:* Fair value represents guaranteed interest account values adjusted to reflect current market interest rates only to the extent such market rates exceed contract crediting rates. This value represents contributions allocated to the guaranteed interest accounts, plus interest at the contractually guaranteed rate, less funds used to pay Plan benefits and Principal Life's administrative expenses. If the applicable interest rate is equal to or less than the interest rate on the account, the fair value is equal to the contract value. If the applicable interest rate is greater than the interest rate on the account, the fair value is the contract value reduced by a percentage. This percentage is equal to the difference between the applicable interest rate and the interest rate on the account, multiplied by the number of years (including fractional parts of a year) until the maturity date.

*Pooled separate accounts:* valued at net asset value (NAV) which is based on the fair value of its underlying investments (i.e. common stock, mutual funds, short-term securities, real estate). While the majority of the underlying asset values are quoted prices, the NAV of the pooled separate accounts is not publicly quoted and are determined by the insurance company. NAV is a readily determinable fair value and is basis for current transactions. There are currently no redemption restrictions on these investments. Participant transactions (purchases and sales) may occur daily.

*Collective investment trusts:* valued at NAV which is based on the fair value of its underlying investments. Common collective trusts contain synthetic investment contracts comprised of both underlying investment and contractual components which have observable level 1 or level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. NAV is used as an estimate of fair value, as the reporting entity has the ability to redeem its investments at NAV as of the measure date. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 30 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 - TAX STATUS**

The Company has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the IRS dated June 30, 2020. The letter states that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since adoption of the prototype plan, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are issued by the custodian or managed by the trustee. These transactions qualify as party in interest transactions.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

There were no reconciling items for 2024 and 2023 between the financial statements and Schedule H of Form 5500.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 - PROHIBITED TRANSACTIONS**

During 2023, the Company failed to remit timely, certain employee deferrals to the Plan, aggregating \$116,899. The respective deferrals and computed lost earnings were remitted to the Plan in 2024.
