## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Poly-America, L.P. Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Poly-America, L.P. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Poly-America, L.P. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Poly-America, L.P. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Poly-America, L.P. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## Notes to Financial Statements

**1 - Description of Plan**

The following description of the Poly-America, L.P. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. General - The Plan became effective on January 1, 1990 and is a defined contribution 401(k) plan, covering all full-time employees of Poly-America, L.P. (the "Sponsor" and "Administrator") and certain companies related by common ownership (the "Companies"). The Plan Administrator is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

B. Contributions - Participants may voluntarily contribute to the Plan up to 50 percent of their compensation, as defined by the Plan, not to exceed limits imposed by the Internal Revenue Service during the calendar year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Annually, the Companies may elect to contribute a matching percentage of the participants' eligible contributions. During 2024 and 2023, the Companies matched an amount equal to 100 percent of each participant's contribution up to 6 percent of the participant's compensation. The employer matching contributions, net of forfeitures, were \$12,406,022 and \$11,645,908 in 2024 and 2023, respectively.

In addition, the Companies made a discretionary employer non-elective ("profit-sharing") contribution in 2024 and 2023 equal to 1 percent of eligible participants' compensation as defined in the Plan, subject to limits imposed by Internal Revenue Service regulations. The amounts of the profit-sharing contributions were \$2,905,129 and \$2,622,051 in 2024 and 2023, respectively.

C. Participants' Accounts - Each participant's account is credited with the participant's contributions, an allocation of the Companies' matching and profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined within the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Eligibility and Vesting - Employees of the Companies become eligible to participate in the Plan once they have attained the age of nineteen and completed six months of service with the Sponsor. Effective January 1, 2016, employees are automatically enrolled in the Plan upon reaching eligibility.

Participants are immediately vested in their contributions plus the allocated earnings thereon. Vesting in the Sponsors' matching and profit-sharing contributions plus allocated earnings thereon is based on years of vesting service. A participant is 100 percent vested upon completion of three years of vesting service. A participant becomes 100 percent vested in all accounts without regard to vesting service upon the attainment of age 65, disability or death.

E. Investment Options - Participants may direct the investment of their account balances into any of the Plan's investment options selected by the Retirement Plan Committee. Participants may change their investment options daily.

F. Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Notes are available only for the purchase of a principal residence for terms not to exceed five years. Participants are permitted to only have one note outstanding at any time. Notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The range of interest rates in effect for all outstanding notes at December 31, 2024 was 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Principal and interest payments are redeposited in the participants' accounts based on their current allocation elections within the Plan.

#### 1 - Description of Plan (Continued)

G. Payment of Benefits - A participant is entitled to receive a distribution equal to the value of his or her vested account balance upon attainment of the normal retirement age of 65, termination of employment, disability or death. Payments are made to the participant or the participant's beneficiary in a lump-sum. Upon attainment of age 59-1/2, a participant may elect to withdraw all or part of his or her elective deferral contribution account balance. In-service withdrawals of a participant's elective deferral contributions are permitted for amounts necessary to satisfy a financial hardship as defined by the Plan agreement. Effective September 1, 2016, participants may elect to receive installment distribution payments upon reaching the normal retirement age of 65.

If a terminated participant does not request a distribution or direct rollover and his or her account balance is less than \$1,000, a distribution of the participant's vested account balance will be made automatically in a lump-sum payment. If a terminated participant's vested account balance is greater than \$1,000, but less than \$5,000, a distribution of the participant's vested account balance will be made automatically as a direct rollover into an IRA set up for the participant. If a terminated participant's account balance is greater than \$5,000 and the participant has reached normal retirement age, the participant may request a partial distribution of his or her vested account balance at any time.

H. Forfeited Accounts - Forfeitures of non-vested matching contributions may be used to reduce the Sponsor matching contributions. Forfeitures of non-vested profit-sharing contributions may be allocated to eligible participants based on compensation as if the forfeitures were an additional profit-sharing contribution. Forfeitures may also be used to pay plan expenses; however, none were used for that purpose in 2024 and 2023.

#### 2 - Summary of Significant Accounting Policies

A. Basis of Accounting - The accompanying financial statements were prepared on the accrual basis of accounting. Therefore, revenues are recognized when earned, and expenses are recorded when the obligation is incurred.

B. Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investments Valuation and Income Recognition - The Plan's investments are reported at fair value as determined and certified by Matrix Trust Company (the "Trustee"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment income (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds and collective investment trusts are deducted from income earned on a daily basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as a reduction of net investment income (loss) in the fair value of such investments.

D. Contributions - Participant contributions are recorded when withheld from compensation. Sponsor contributions are recorded in the period in which they become the obligations of the Companies.

E. Payment of Benefits - Benefits are recorded when paid. Corrective distributions generally represent the distribution of certain assets to employees in order for the Plan to comply with ERISA nondiscrimination rules. There were no corrective distributions for the years ended December 31, 2024 and 2023, respectively.

F. Administrative Expenses - Substantially all costs of Plan administration are paid directly by the Plan Sponsor and are excluded from these financial statements. The Plan Sponsor reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Prior to November 14, 2014, all costs of administering the Plan were paid by the Sponsor. Effective November 14, 2014, fees related to the administration of notes receivable from participants, distributions and administration of qualified domestic relations orders are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net investment income (loss).

G. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant note balance is reduced and a benefit payment is recorded.

H. Subsequent Events - The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

**3 - Information Certified by the Trustee**

The Sponsor elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified that all of the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

Net investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

**4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for that asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common collective investment trusts:* Valued at the net asset value (“NAV”) of units of a trust company investment trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Pooled separate accounts:* Valued using the NAV (or its equivalent) of units held by the Plan at year-end as provided by the Trustee and is not assigned a level in the fair value hierarchy. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the account net of investment management fees. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These investments are required to publish their daily NAV and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

**4 - Fair Value Measurements (Continued)**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

**5 - Plan Termination**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and the Sponsor may terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100 percent vested in their accounts.

**6 - Income Tax Status**

The Plan obtained its latest determination letter on March 30, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8 - Parties-in-Interest Transactions**

The Plan pays fees for various administrative and custodial services provided during the year. Fees paid using Plan assets during the years ended December 31, 2024 and 2023 for these services totaled \$81,007 and \$56,313, respectively. These fees were based on customary and reasonable rates for such services.

The Sponsor provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged and pays annual auditing fees on behalf of the Plan.
