## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
of the Victory Wholesale Group 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Victory Wholesale Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. PLAN DESCRIPTION

The following description of the Victory Wholesale Group 401(k) Plan (hereafter, the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**—The Plan is a defined contribution plan, established November 1, 1979. All full time, domestic (as defined in the Plan document) salaried as well as hourly employees of Victory Wholesale Group (“Victory” and the “Company”) who have attained age eighteen and ninety days of service are eligible to participate in the Plan. In addition, employees of certain affiliated entities (as defined in the Plan document) are also eligible to participate in the Plan when they have attained age eighteen and ninety days of service. All employees must attain one year of service for purposes of sharing in Company contributions.

The Company controls and manages the operation and administration of the Plan. John Hancock Trust Company LLC serves as the trustee for the Plan, except as it relates to the life insurance policies. The life insurance policies are held and managed by The Guardian Life Insurance Company of America. Certain administrative and recordkeeping functions are performed by John Hancock Retirement Services, an affiliate of John Hancock Trust Company LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**—Each year, participants may contribute a certain percentage of annual compensation, as defined. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may elect such contributions to be excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Unless changed by the participant, automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund. Additionally, unless changed by the participant, the deferral rate percentage shall increase by 1% every year until it reaches 10%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; these additional contributions are ineligible for a Company matching contribution.

The Company may contribute to the Plan discretionary matching contributions, which amounts are determined annually. The Company’s contributions are allocated to participants based on a defined percentage or formula. The Company declared a discretionary Company contribution to the Plan for the year ended December 31, 2024, in the amount of \$1,380,000.

Contributions are subject to limitations under the Internal Revenue Code (IRC). The Company performs certain participant discrimination testing annually in accordance with ERISA. At times, the results of these tests required certain contributions to be returned to participants for discrimination testing

compliance. No contribution amounts were required to be returned during the year ended December 31, 2024.

**Participant Accounts**—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution, allocations of the Company contributions and Plan earnings/losses and forfeitures, and charged with withdrawals from the Plan and administrative expenses, as applicable. Allocations are based on a participant’s compensation or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments**—Participants direct their contributions, as well as Company contributions to their account, into various investment options offered by the Plan, which include various mutual funds, common collective trusts and one stable value investment, the New York Life Guaranteed Interest Account (Note 4). Participants may change investments and transfer amounts between funds daily.

Certain employees were participants of a plan which was merged into the Plan during 1997 and are eligible to invest in life insurance policies. The contributions of these certain employees are first allocated to pay for the premiums of the life insurance policies and then to investment options selected by the participant.

**Vesting**—Participants are fully vested in their contributions. Vesting in the Company’s discretionary contribution is based upon years of service as follows:

**Payment of Benefits**—On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in either a lump sum amount or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

**Expenses of the Plan**—Administrative expenses of the Plan are paid by the Plan or Victory, as provided in the Plan document. Investment management fees for investments are included as a reduction of investment return and not reflected separately in the statement of changes in net assets available for benefits.

Participants also pay administrative costs for loans, distributions and qualified domestic relation orders. The remaining expense is paid by the Company and through credits provided by the recordkeeper for Plan investments.

The Plan has a revenue-sharing agreement whereby John Hancock Retirement Plan Services LLC has agreed to waive service fees to the extent it receives revenue from certain investment providers pursuant to service agreements that John Hancock Retirement Plan Services LLC or its affiliates maintains with such investment providers. Future Plan expenses can be paid from any excess remaining revenue sharing amounts. The Plan held zero undistributed administrative revenues as of December 31, 2024 and 2023, respectively.

**Forfeitures**—Upon participant termination, the non-vested portion of the participant’s account, as defined by the Plan, represents a forfeiture. Forfeitures can be used to reduce employer contributions, pay for Plan expenses or can be allocated to the participants in the Plan annually, as provided by the Plan document. The forfeiture account balance at December 31, 2024 and 2023, approximates \$17,115 and \$25,758, respectively. For the Plan year ended December 31, 2024, \$25,758 of forfeitures were allocated to the eligible participants in the Plan.

**Notes Receivable from Participants (Participant Loans)**—The Plan allows participants to take loans against their vested account balances. Loan balances shall be for a minimum of \$1,000 up to a maximum of the lesser of one-half of the participant’s vested account balance or \$50,000. All loans must be repaid within five years, unless the loan was taken for the purpose of acquiring a primary residence and the term may be extended to a period not to exceed 10 years. Loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%, fixed and determined on the date the loan is initiated. As of December 31, 2024, participant loans have maturities through 2029 at interest rates ranging from 4.25% to 9.5%. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Participant loans are classified as notes receivable from participants, segregated from Plan investments in the statements of net assets available for benefits, and measured at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are reported as an investment of the Plan for Form 5500 reporting purposes.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan provides for investments in various investment securities, including mutual funds, common collective trusts, the stable value investment and life insurance policies. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks, including global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024, the Plan had a concentration of investments in T. Rowe Price Retirement 2020 Trust A, T. Rowe Price Retirement 2030 Trust A, T. Rowe Price Retirement 2040 Trust A as well as

in the stable value investment with New York Life Insurance Company, which represented 47% of the Plan's total investments. As of December 31, 2023, the Plan had a concentration of investments in T. Rowe Price Retirement 2020 Trust A, T. Rowe Price Retirement 2030 Trust A as well as in the stable value investment with New York Life Insurance Company, which represented 40% of the Plan's total investments. A change in the value of these funds could cause the value of the Plan's net assets available for benefits to change due to this concentration.

**Investment Valuation and Income Recognition**—Shares of mutual funds are valued at the daily closing prices as reported by the fund. These mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Life insurance policies are stated at cash surrender value as determined by representatives of the life insurance company based on underlying policy assets and accumulated premiums paid.

Common collective trusts are valued at the net asset value of underlying investments. The net asset value as provided by trustee of the Plan, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. There are no participant restrictions for these investments, and redemptions can be processed daily from the fund. There are no unfunded commitments.

The Plan also invests in a stable value investment option, the New York Life Guaranteed Interest Account, with New York Life Insurance Company. The New York Life Guaranteed Interest Account invests in a broadly diversified fixed income portfolio intended to provide a stable crediting rate consistent with preservation of principal. Such investments consist primarily of an array of securities and cash equivalents. The stable value investment is reported at contract value. Contract value is the amount the Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan (Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

**Contributions**—Employee contributions and employer matching contributions are recorded when earned.

**Payment of Benefits**—Benefits are recorded when paid. There were no benefits payable to participants as of December 31, 2024 and 2023.

**Subsequent Events**—The Plan has evaluated subsequent events through October 6, 2025, the date these financial statements were available to be issued. There were no subsequent events requiring modifications or disclosures in these financial statements.

### 3. FAIR VALUE MEASUREMENTS

ASC Topic 820 establishes a single authoritative definition of fair value, sets a framework for measuring fair value, and requires additional disclosures about fair value measurements. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan classifies its investments into the following categories, with assets and liabilities classified in their entirety based on the lowest level of input that is significant to the fair value measurement:

**Level 1**—Securities valued using quoted prices from active markets for identical assets.

**Level 2**—Securities not traded on an active market but for which observable market inputs are readily available.

**Level 3**—Securities valued based on significant unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model based valuation techniques may require the transfer of financial instruments from one fair value level to another. There were no transfers between levels for the year ended December 31, 2024.

#### **4. STABLE VALUE INVESTMENT**

The Plan provides participants a fully-benefit responsive stable value investment option. The stable value investment is a fully benefit-responsive guaranteed investment contract with New York Life Insurance Company, the New York Life Guaranteed Interest Account.

New York Life Insurance Company maintains the contributions from the Plan in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals

and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Limitations on the Ability to Transact at Contract Value**—The stable value investment has certain restrictions that affect the ability of the Plan to collect the full contract value, which primarily include events initiated by the Company, such as a total or partial Plan termination, merger, spin-off, lay-offs, early retirement incentive programs, sales or closing of all or part of the Company's operations. However, Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. New York Life Insurance Company may not terminate the contract at any amount less than the contract value.

**Average Yields**—New York Life Insurance Company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan for its stable value investment. The crediting interest rate is based on a formula agreed upon with New York Life Insurance Company, but may not be less than 1.00% annually, the minimum interest rate as defined by the contract. Such interest rates are reviewed on a semi-annual basis (January 1 and July 1) for resetting. The crediting rate of the contract will track current market yields on a trailing basis.

## **5. RELATED PARTY AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the interest of all participants would immediately vest and become nonforfeitable based upon the then current individual participant account balances.

## **7. TAX STATUS**

The Plan uses a prototype plan document sponsored by John Hancock Retirement Plan Services LLC. John Hancock Retirement Plan Services LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

## **8. CERTIFIED INVESTMENT INFORMATION**
