## **INDEPENDENT AUDITORS' REPORT**

To The Plan Administrator and Participants

### **SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT**

We have performed an audit of the financial statements of Goodwill of Greater Washington Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Goodwill of Greater Washington Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 through 5 to the financial statements, is complete and accurate.

### **OPINION**

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

### 1. *Description of plan*

The following description of Goodwill of Greater Washington Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution 403(b) plan covering substantially all employees of Goodwill of Greater Washington (the "Company") who elect to participate. Participation in elective deferral contributions is immediate; however, participation in employer matching and discretionary contributions is subject to various eligibility requirements as outlined by the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - For the Plan year ended December 31, 2024, participants may contribute to the Plan the lesser of 100% of pretax annual compensation, as defined, or the maximum amount permitted under the Internal Revenue Code (\$23,000 for 2024), with a Plan mandated annual floor of \$200. In addition, participants aged 50 or older may make a "catch up" contribution of up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company currently makes a matching contribution to its professional staff and non-Service Contract (SCA) employees equal to 100% of each participant's elective deferrals, up to a maximum of 4% of eligible Plan compensation, that a participant contributes to the Plan. Highly Compensated Employees (HCE) are not eligible to receive matching contributions. The Company may also make discretionary contributions to the Plan for non-SCA employees. No discretionary contribution was made for non-SCA employees during 2024. Service Contract employees are eligible to receive a discretionary employer contribution equal to the excess of hours worked multiplied by a standard benefits rate, less the cost of health and other benefits.

Participants direct the investment of all contributions into various investment options offered by the Plan, consisting of sixty pooled separated accounts and one investment contract with an insurance company.

Participant accounts - Each eligible participant's account is credited with (a) the participant's contributions, (b) the Company's matching and/or discretionary contributions, and (c) Plan earnings, and is charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon as well as the Company's matching and/or discretionary contributions plus actual earnings thereon.

Forfeited accounts - Forfeitures, arising from excess employer matching payments, are applied to reduce administrative expenses of the Plan which would otherwise be paid by the Company, or used to reduce the Company's contributions. No forfeitures were used to reduce the Company's cash outlay for matching contributions and administrative expenses during 2024 (\$2,461 in 2023). Investment earnings on such funds during 2024 and 2023 aggregated \$0 and \$92, respectively. The balance of non-vested forfeited accounts was \$10 for the year ended December 31, 2024 and \$10 for the year ended December 31, 2023.

### 1. *Description of plan (continued)*

Participant loans - Participant loans are permitted under the Plan. Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of: (a) \$50,000 or (b) 50% of the participant's vested account balance (reduced by the highest outstanding balance of any loan made during the previous twelve months). The loans are to be repaid over a period not to exceed five years, except for loans, the proceeds of which are used to acquire a home, in which event the term is to be determined by mutual agreement between the Plan and the participant, not to exceed 20 years. The loans are issued directly to the participant from Lincoln Financial Group, the Plan's custodian, or an affiliated entity, and are collateralized by a portion of the participant's account held in a loan reserve account. The loans incur interest at a rate determined by the Plan administrator to be reasonable - currently the lesser of: (a) Moody's Corporate Bond Yield (rounded to the nearest 0.05%) or (b) the yield earned on the Lincoln Fixed Account, subject to a floor of 4.50%. Initial interest rates applicable to all active participant notes ranged from 2.95% to 4.50%. At December 31, 2024, active participant notes incurred interest at 2.95%. The loan reserve account is credited with interest at a rate equal to the interest rate on the loan minus 2.50% on the effective date of the loan. Principal and interest are paid ratably through either monthly or quarterly payments. At December 31, 2024, participants' loans in default aggregated approximately \$254,800. In the event a loan default is not cured within 90 days of the due date, the loan balance will be a deemed distribution to the respective participant. At December 31, 2024 and 2023, the balance of the loan reserve account was \$587,647 and \$531,988, respectively, and included in investment contract with insurance company on the statements of net assets available for benefits.

Payment of benefits - Generally, upon retirement, participants are to receive their benefit in the form of a lump-sum distribution. A participant may also request to receive their benefits in the form of systematic installment payments, a rollover to another qualified retirement plan or individual retirement account (IRA), or in the form of an annuity. In-service withdrawals are permitted for participants who have attained age 59½. Hardship distributions are also permitted under specific circumstances, as outlined in the Plan document.

Termination - Generally a participant may receive his or her vested account balance in a single lump sum at any time such participant ceases to be an employee.

Secure Act 2.0 - In December 2022, Congress passed the Consolidated Appropriations Act of 2023 which contains over 90 new retirement provisions with varying effective dates through 2027. Since the Secure Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan documents accordingly. Certain provisions became effective in 2024 and additional provisions will become effective thereafter. There is no material impact to the Plan's 2024 financial statements.

### 2. *Accounting policies*

Basis of accounting - The financial statements of the Plan are prepared using the accrual basis of accounting. Investment contracts held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for a discussion of fair value measurements.

### 2. *Accounting policies (continued)*

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition - The Plan's investments are stated at fair value except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date. Interest income is recorded on the accrual basis of accounting. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, if any. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits - Benefits are recognized when paid.

Administrative expenses - Certain expenses incurred in connection with the general administration of the Plan are paid by the Company. (See Note 7).

Subsequent events - The Plan has evaluated subsequent events through October 2, 2025, which is the date these financial statements were available to be issued. All subsequent events requiring recognition as of December 31, 2024 have been incorporated into these statements.

### 3. *Investments (unaudited)*

At December 31, 2024 and 2023, the Plan's investments were held by the custodian. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the custodian as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

4. *Guaranteed investment contract with insurance company (unaudited)*

The Plan has an investment contract with Lincoln, with a fixed guaranteed rate of interest. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. The contract meets the fully benefit-responsive investment contract criteria and therefore reported at contract value. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Lincoln.

Lincoln is contractually obligated to repay principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against the contract value of the guaranteed insurance contracts for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer but cannot be less than the guaranteed minimum interest rate of 4½%. Crediting rates are guaranteed during the life of the contract.

The Plan's ability to receive the amount due in accordance with fully benefit responsive investment contract is dependent on Principal Life Insurance Company's ability to meet its financial obligation. Certain events at the Plan or Plan sponsor limit the ability of the Plan to transact at contract value with the issuer. Such events include: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (b) bankruptcy of the plan sponsor or other plan sponsor events which cause a significant withdrawal from the Plan; (c) surrender charges at Principal; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Surrender charges are a feature of some of Lincoln's contracts. The surrender charge is the percentage of the withdrawal amount based on the contract year. If applicable, surrender charge schedules are included in each group annuity contract. The Plan or Plan Sponsor has no intention to surrender its interest in the group annuity contract.

The Plan Administrator does not believe that the occurrence of any event (as outlined above), which would limit the Plan's ability to transact at contract value with participants, is probable.

#### 5. *Fair value measurements (unaudited) (continued)*

Authoritative accounting guidance sets forth a framework for measuring fair value. That framework provides a fair value hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The Plan measures fair value using Level 1 inputs whenever possible because they generally provide the most reliable evidence of fair value. When the Plan cannot measure fair value using Level 1 inputs, Level 2 inputs are used when possible; Level 3 inputs are only used when Level 1 and Level 2 inputs are unavailable.

Following is a description of the valuation methodologies used by the Plan to measure fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 fair value measurements* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. At December 31, 2024 and 2023, none of the Plan's investments are traded on active markets.

*Level 2 fair value measurements* - Inputs other than quoted prices in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates, and similar data. The fair value of the pooled separate accounts is equal to the per-unit value determined by Lincoln based on the value of the underlying assets owned by the pooled separate account.

*Level 3 fair value measurements* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the assets, based on the best information available in the circumstances.

The preceding methods described may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 7. *Related party transactions*

The Company pays a portion of the Plan's administrative expenses. During the year ended December 31, 2024, Plan related fees paid or accrued by the Plan sponsor amounted to approximately \$45,500.

The Plan's investments consist of pooled separate accounts and an investment contract with an insurance company, all of which are managed by Lincoln. Under ERISA, such transactions qualify as party-in-interest transactions.

#### 8. *Risks and uncertainties*

The Plan provides for various investment options in the form of pooled separate accounts and an insurance company guaranteed investment contract. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. *Risks and uncertainties (continued)***

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist primarily of investments in pooled separate accounts that invest in bond funds and the insurance contract which is payable from the general assets of Lincoln. The Plan has offered participants investment options in various investment vehicles as a means of reducing the effects of such risks.

### **9. *Plan termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **10. *Tax status***

The Plan is operating under an adoption agreement of a non-standardized prototype plan structured by its third-party administrator. The Internal Revenue Service has reviewed the terms of the prototype plan and has indicated by a letter dated March 31, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to its terms and conditions; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021, generally for three years after the tax returns have been filed.
