## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees and Members of the  
Tampa Truck Center, 401(K) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Tampa Truck Center, 401(K) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

NOTE A - DESCRIPTION OF PLAN

The following description of Tampa Truck Center, 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan, adopted on January 1, 2010, is a defined contribution plan covering the employees of Tampa Truck Center, LLC (the "Company"). Employees become eligible to participate in the Plan after completing two months of service, during the eligibility computation period, and having attained 21 years of age. Furthermore, the Plan is subject to the Provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Plan Sponsor and Administrator

Tampa Truck Center, LLC serves as the Plan sponsor and administrator. No officer or employee of the Company receives compensation from the Plan.

3. Contributions

Participants contribute amounts to the Plan elected as a whole dollar amount or as a percentage of their compensation as a deferral of compensation. Participants may elect to contribute to the Plan for any plan year, during which they are participants, subject to Internal Revenue Service limitations. The Plan also permits participants to make Roth elective deferrals, and eligible participants are permitted to make catch-up contributions.

Upon eligibility, participants are automatically enrolled into the Plan. If participants do not specifically elect an alternative deferral amount (including zero), the employer will automatically elect to withhold 3% of the employee's compensation on the employee's behalf. Effective June 1, 2024, the employer will automatically elect to withhold 4% of the employee's compensation on the employee's behalf. Effective June 1, 2024, the deferral automatically increases 1% on the first day of each year until the deferral reaches 10% of the participant's compensation.

Employer's contribution is made each plan year on behalf of eligible participants under the Plan as a discretionary match. Compensation and limitations based on the plan year are used when the employer matching contribution is determined. For the year ended December 31, 2024, the employer match is calculated as 50% of the participants' elective deferral, not to exceed \$1,500. For the year ended December 31, 2023, the employer match is calculated as 50% of the first 6% of the participants' compensation that is deferred as an elective deferral, not to exceed \$1,500.

Rollover contributions are permitted from eligible participants.

4. Participant Accounts

Each participant in the Plan has a separate account which is funded with an annual employer match contribution, participant's elected compensation deferrals, and the allocation of the Plan's earnings or losses. Allocations are based on the prorated earnings of the participant compared to the total earnings of all participants within the same investment.

5. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer match contribution portion of their accounts, plus actual earnings or losses thereon is based on years of service.

A participant is vested in employer match contribution as follows:

One hundred percent vesting occurs, regardless of the number of years of service, when a participant dies, or becomes totally and permanently disabled.

6. Payment of Benefits

Benefit payments are made in the form of a lump-sum, substantially equal installments, or partial withdrawals. Upon normal retirement of age 65, death, or becoming permanently disabled, Plan participants will be entitled to 100% of their account balance. If employment is terminated for any reason other than those previously mentioned, the participant will only be entitled to the vested portion of the employer contributions. However, participants are entitled to 100% of the account balance of all elected compensation deferrals made on their own behalf.

7. Forfeitures

Forfeited non-vested account balances are used to reduce employer contributions and to reduce plan expenses paid by the Sponsor. Forfeitures from non-vested accounts were approximately \$18,000 and \$7,700 at December 31, 2024 and 2023, respectively. The Plan applied forfeitures of approximately \$7,700 to reduce employer contributions during the year ended December 31, 2024.

8. Administrative Expenses

The employer absorbs significant cost of administrative expenses. Administrative expenses paid by the Plan for transaction processing services amounted to \$34,148 for the year ended December 31, 2024. Administrative expenses are comprised of record keeping fees of \$3,120 and investment advisory fees of \$31,028 during the year ended December 31, 2024.

9. Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, employer's contributions to participants accounts will become 100 percent vested, and not forfeited.

Some Plan participants have terminated employment from the Company but have not had their vested balances paid to them by year end. These unpaid benefits approximated \$860,000 and \$739,000 at December 31, 2024 and 2023, respectively. However, there were no material balances related to participants who requested their benefits paid to them but had not received their benefit distributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

1. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting and accordingly reflect all significant receivables, payables and other liabilities.

2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein as well as the related disclosures. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's investments consist of mutual funds as of December 31, 2024 and 2023. The Plan's investments are reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Upon discontinuance of the contract with Reliance Trust Company, the Plan would be paid in a single sum, the contract value of the investments as of the termination date.

4. Payment of Benefits

Benefits are recorded when processed by the Plan.

NOTE C - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement), unadjusted quoted prices in active markets for similar assets or liabilities (level 2 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year end.

NOTE D - CONCENTRATION OF CREDIT RISK

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE E - TAX STATUS

The trust established under the Plan to hold its assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service. The Plan sponsor believes that the Plan continues to qualify and to operate as designed. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE F - CERTIFICATION FROM TRUSTEE

The investments of the Plan were held and administered by Reliance Trust Company (the "Trustee") as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The Trustee has supplied the Plan administrator with certain information utilized in preparing the financial statements and supplemental schedule for their respective fiduciary periods. The Plan administrator has obtained a certification from the Trustee certifying that the information provided by the Trustee is complete and accurate. In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has elected not to have this information audited by the Plan's independent certified public accountants.
