**1. Description of Plan**

The following description of the Bonadio & Co., LLP 401(k) & Profit Sharing Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the plan document.

***General***

The Plan is a defined contribution plan covering all employees of Bonadio & Company, LLP, and certain other related entities (the “Employer”) who have attained age 20 ½ and have completed two months of service, with the exception of residents from Puerto Rico, (the “Participants”). Part-time, temporary, and seasonal employees who complete 1,000 hours of service in a twelve consecutive month period, as defined, will become eligible to participate in the Plan on the next regular entry date. Effective March 1, 2023, the Plan was amended to exclude interns from the Plan.

Empower Trust Company, LLC (the “Custodian”) provides asset custodian services for the Plan and serves as the Plan’s trustee. The Plan Sponsor has contracted JP Morgan Asset Management (“JP Morgan”) to provide certain recordkeeping and administrative services to the Plan. JP Morgan has retained Empower Institutional as a subcontractor to provide services on behalf of JP Morgan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are Participant-directed.

On November 1, 2023, due to an acquisition, employees of Howard LLP. (“Howard”) became employees of Bonadio & Co. LLP and therefore can participate in the Plan once the eligibility requirements have been met. The Plan was amended to allow credit for eligibility purposes for prior service at Howard. An aggregate \$1,635,706 was rolled into the Plan by these Participants during the year ended December 31, 2024, and is included in rollover contributions on the statement of changes in net assets available for benefits.

***Plan Administration***

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged with an allocation of administrative expenses, if not paid by the Employer. Individual accounts are charged directly for loan recordkeeping, if applicable. Expenses that are paid by the Employer are excluded from these financial statements.

***Subsequent Events***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which is September 26, 2025.

**1. Description of Plan (*continued*)**

***Participant Contributions***

Participants may defer up to 100% of their eligible compensation for the Plan year, as defined, not to exceed a dollar limit established under the Internal Revenue Code (the "IRC"). Participants may make pre-tax or Roth contributions to their accounts. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, Participants may also rollover amounts representing distributions from other qualified plans ("Participant Rollovers").

Employees, upon eligibility to participate in the Plan, will be automatically enrolled to defer 6% of their eligible compensation, as defined. A Participant may choose not to defer or may choose a different percentage once enrolled. Automatic enrollment deferrals are invested in the Vanguard Target Date funds based upon the Participant's expected retirement date unless otherwise elected. Each year on the first day of the Plan year, all Participants who are still automatically enrolled will have an automatic deferral escalation of 1%, not to exceed 15% of total increases.

***Employer Contributions***

The Employer, at its discretion, may make employer non-elective contributions to the Plan as determined by its retirement committee. Any discretionary employer non-elective contribution is allocated at the Employer's discretion to classifications of employees, as defined, based on a percentage of eligible compensation, within the classification. To be eligible, Participants must have completed at least 1,000 hours of service during the Plan year and be employed by the Employer on the last day of the Plan year. For the year ended December 31, 2024, the Employer made non-elective employer contributions of \$3,377,654, net of forfeitures of \$254,589.

The Employer, at its discretion, may elect to contribute a matching contribution as determined by the retirement committee. To be eligible, Participants must have completed at least 1,000 hours of service during the Plan year, be employed by the Employer on the last day of the Plan year and have made elective contributions during the Plan year. For the year ended December 31, 2024, the Employer elected not to make matching contributions.

***Participant Accounts***

Each Participant's account is credited with the Participant's deferral contributions, the respective Employer contributions, an allocation of the Plan's investment earnings or losses, and is charged with an allocation of certain administrative expenses, if applicable. Allocations are based on Participant compensation, classification, or account balance, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

***Vesting***

Participants are immediately vested in their participant and rollover contributions plus allocated earnings thereon. Upon termination due to death, disability, or attainment of retirement age, a Participant is fully vested in all of their accounts. Vesting in employer matching and employer non-elective contributions are as follows:

***Payment of Benefits***

Upon termination of service due to death, disability, termination, or retirement, a Participant or beneficiary may elect to receive a lump-sum distribution, installment payments or partial distributions in an amount equal to the vested value of the Participant's account. The payment can either be a cash distribution to the Participant or beneficiary or a tax-free rollover to an Individual Retirement Account ("IRA") or another qualified plan. If a Participant's account balance is less than \$7,000, the plan administrator, after notification, may distribute the benefit into an IRA. If the Participant's account balance is less than \$1,000, the plan administrator, after notification, may distribute the benefit to the Participant as a lump-sum distribution.

In service withdrawals from a Participant's vested account balance are permitted upon reaching age 59 ½. In service withdrawals are also permitted due to financial hardship, as defined. Hardship withdrawals may be taken from the Participant's deferral contributions, rollover account or vested Employer contribution accounts.

***Notes Receivable from Participants***

Subject to approval by the plan administrator, Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years (or longer for the purchase of a primary residence). Loans are secured by the balance in the Participant's account and bear interest at a rate equal to 1% over the prime rate on the first business day of the month before the loan originated. Principal and interest are paid ratably through payroll deductions or by check if the employee has terminated employment.

Interest rates for outstanding loans range from 4.25% to 9.50% at December 31, 2024 and 2023 and loans mature through March 2047.

***Forfeitures***

A Participant who leaves the employment of the Employer forfeits any non-vested balance. Forfeited balances of terminated Participants' accounts are used to pay administrative expenses and to reduce Employer contributions in the year of forfeiture. During 2024, \$63,908 of forfeitures were used to reduce Employer contributions. At December 31, 2024 and 2023, unused forfeiture balances amounted to \$188,431 and \$56,703, respectively. Subsequent to year end, \$254,589 was used to fund the 2024 employer profit sharing contributions receivable.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

***Fair Value Measurements (continued)***

*Common collective trust fund:* Valued at the NAV of units in the collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units which are valued daily. The fund earns dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants' accounts are charged or credited with the number of units properly attributable to each Participant. The collective investment fund has no unfunded commitments at December 31, 2024 and 2023.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

***Investments, Investment Valuation, and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative fees and expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded as soon as a distributable event occurs.

***Payments of Benefits***

Benefit payments to Participants are recorded during the period in which they are paid.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i, Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian as of December 31, 2024 and 2023 and for the year ended December 31, 2024, a qualified institution.

**4. Risks and Uncertainties**

The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the Participants' account balances and the amounts reported in the statements of net assets available for benefits.

**5. Party-In-Interest Transactions**

Plan investments include funds that are managed by JP Morgan. Therefore, these transactions qualify as exempt party-in-interest transactions. Administrative fees of \$136,355 were paid to JP Morgan during 2024. Administrative fees of \$37,500 were paid to On Digital, TopCo LLC d.b.a. Resources Investment Advisors, the Employer's investment advisor, during 2024. Notes receivable from Participants qualify as exempt party-in-interest transactions as defined by ERISA.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

**7. Tax Status**

The underlying volume submitter prototype plan has received an opinion letter from the Internal Revenue Service (“IRS”) dated November 14, 2022, stating that the form of the plan is qualified under Section 401(a) of the IRC, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan’s policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan as of December 31, 2024 or 2023.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
