1. Description of Plan:

The following description of Labrie U.S. Employees 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Labrie Environmental Group USA, Inc., Labrie Parts Corporation, and Enviroquip Parts, LLC, (collectively referred to as the “Plan Sponsor”). The Plan covers all employees who are at least twenty-one years of age and are not employees covered under a collective bargaining agreement, non-resident aliens who do not receive any compensation from U.S. sources, leased employees, or employees whose primary employment is not based in the United States. Participants are not eligible to receive employer matching contributions until they have completed at least one hour of service during the first six months of employment and work at least 1,000 hours during the 12-month period immediately following your date of hire. Employees are eligible to make deferrals on the first day of the month once eligibility requirements have been met, as defined. Employees are eligible to receive employer contributions on January 1st or July 1st once eligibility requirements have been met, as defined, and must be employed on the last day of the year to be eligible for the employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrator determines the appropriateness of the Plan’s investments, monitors investment performance, and reports to the Plan Sponsor.

Contributions

*Participant Contributions:* Each year, participants may defer a portion of their pre-tax annual compensation, as defined, subject to certain statutory limitations. Participants may also elect to make Roth 401(k) contributions, which are subject to federal income taxes in the year of deferral. For 2024 and 2023, the deferred amount may not exceed \$23,000 and \$22,500, respectively. Additionally, the Internal Revenue Code (“IRC”) allows for participants over the age of 50 to make additional contributions (catch-up contributions) in excess of these limits. The maximum catch-up contributions for 2024 and 2023 may not exceed \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

*Employer Contributions:* The Plan Sponsor makes a matching contribution of 100% of a participant’s contribution up to 2% of their eligible compensation. In addition, the Plan Sponsor may elect to make a discretionary nonelective contribution in an amount to be determined by the Plan Sponsor for each plan year. The participant must be employed on the last day of the Plan year and must work at least 1,000 hours during the first six months of employment to receive Plan Sponsor contributions. For the years ended December 31, 2024 and 2023, the Plan Sponsor elected not to make a discretionary nonelective contribution to the Plan.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant’s account is credited with the participant’s pre-tax contributions, Roth 401(k) contributions, the Plan Sponsor’s matching contributions, the Plan Sponsor’s discretionary nonelective contributions, if any, plan earnings or losses, and administrative expenses which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled to is the benefit that can be provided from the participant’s vested account.

1. Description of Plan (continued):

Vesting

*Participant Contributions*: Participants are vested at all times in their pre-tax contributions, Roth 401(k) contributions, and earnings or losses thereon.

*Employer Contributions*: Participants vest at a rate of 20% per year of employment and are fully vested after five years of employment in the Plan Sponsor's matching contributions, the Plan Sponsors' discretionary nonelective contributions, and earnings or losses thereon. Participants will also fully vest upon death, disability, or the attainment of sixty-five years of age, the Plan's normal retirement age.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, subject to a minimum of \$1,000 and a maximum of \$50,000, reduced by the excess of the participant's highest outstanding participant loan during the 12-month period ending on the date of the loan. Loan transactions are treated as a transfer between the investment funds and the loan fund. Loan terms range from one to five years, or up to fifteen years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at the prime rate as established by the Associated Bank, N.A. plus two percentage points. Principal and interest are paid ratably through payroll deductions. If repayment is not made by payroll deduction, a loan shall be repaid to the Plan by payment to the Plan Sponsor. The maximum number of Plan loans a participant may have outstanding at one time is one.

Benefits Paid to Participants

Upon termination of service, a participant may elect to receive a lump-sum payment, a partial lump-sum payment, or installment payments over a specified period not to exceed the life or life expectancy of the participant and a designated beneficiary. Participants may withdraw vested amounts while employed if they are at least sixty-two years of age or incurred a hardship in accordance with the hardship provision of the Plan.

Forfeited Accounts

Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. These accounts will be used to reduce future employer contributions or may be used to pay administrative expenses of the Plan. At December 31, 2024 and 2023, and for the years ended, forfeited non-vested accounts and forfeited non-vested balances used to pay administrative expenses were:

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit loss has been recorded. If a participant does not make loan repayments, and the plan administrator considers the participant note receivable to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan agreement.

Excess Contributions Payable

At December 31, 2024 and 2023, excess contributions payable to participants are as follows:

The excess contributions payable are for participant contributions in excess of amounts allowed by the Internal Revenue Service ("IRS"). The corrective distributions are recorded as a liability and are included in corrective distributions in the accompanying statements of changes in net assets available for benefits. The Plan distributed the 2024 and 2023 excess contributions to the participants prior to March 15, 2025 and 2024, respectively.

Benefits Paid to Participants

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expense are included in the net appreciation (depreciation) in fair value of investments. Fees for distributions as well as the administration of notes receivable from participants are included in the administrative expenses and charged directly to the participants' accounts.

4. Fair Value Measurements:

Fair value measurement guidance under GAAP defines fair value, establishes a consistent framework for measuring fair value, and establishes a fair value hierarchy based on the observability of inputs used to measure fair value. The objective of a fair value measurement is to determine the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Accordingly, the fair value hierarchy gives the highest priority to quoted prices (unadjusted) in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of fair value hierarchy under are described as follows:

- Level 1            Unadjusted quoted market prices in active markets for identical unrestricted assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2            Other significant observable inputs, including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, and others. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There are no plan assets requiring use of Level 3 inputs for the periods presented.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Level 1 and Level 2 Fair Value Measurements:*

Mutual Funds: Valued at the daily closing price as reported by the fund. Net asset values ("NAV") are generally obtained from The National Securities Clearing Corporation, directly from the fund house, and/or a secondary processing source.

Collective trust funds: Valued at the daily closing price as reported by the fund. NAV are generally obtained from The National Securities Clearing Corporation, directly from the fund house, and/or a secondary processing source.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fair Value Measurements (continued):

The Plan invests in a collective trust fund, which trades at the NAV per share practical expedient of the fund. The fund is not categorized within the fair value hierarchy.

5. Tax Status:

The Internal Revenue Service (“IRS”) has determined and informed the trustee by a letter dated June 30, 2020 that the volume submitter plan on which the Plan is based, and the related trust as then designed was in accordance with applicable regulations of the IRC. The volume submitter plan has been amended subsequent to that date. However, the Plan Sponsor believes that the Plan was, at all times during the years ended December 31, 2024 and 2023, designed and operated in compliance with the applicable requirements of the IRC, and that the Plan and related trust continued to be tax-exempt.

GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS, U.S. Department of Labor, and/or Georgia Department of Revenue. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination:

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

7. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statements of net assets available for benefits.

8. Related-Party Transactions and Party-in-Interest Transactions:

Certain plan investments are managed by affiliates of the Plan's trustee and recordkeeper. The Plan also engages service providers, including the trustee, recordkeeper, and investment managers, who are considered parties in interest as defined by ERISA. All such transactions are conducted in the ordinary course of business and are exempt from the prohibited transaction rules under ERISA Section 408(b)(2), provided that the services are necessary for the operation of the Plan and no more than reasonable compensation is paid.

The Plan has entered into agreements with certain investment providers under which a portion of the investment management fees charged to the Plan's investment options are shared with the Plan's recordkeeper and other service providers. These revenue sharing payments are intended to offset certain administrative expenses of the Plan. The amounts received under these agreements are used to pay for recordkeeping, administrative, and other plan-related services. Any excess amounts not used to pay plan expenses are either allocated to participants' accounts or retained in an unallocated expense account, in accordance with the Plan's policies. During the years ended December 31, 2024 and 2023, no revenue sharing credits were used to offset administrative expenses of the Plan or allocated to the participants' accounts.

The Plan fiduciaries monitor the reasonableness of all fees paid, including those paid through revenue sharing agreements, to ensure compliance with ERISA's fiduciary requirements. The Plan has procedures in place to periodically review the total compensation paid to service providers, including both direct and indirect compensation, to confirm that such amounts are reasonable in relation to the services provided.

9. Assets Allocated to Terminated Participants:

Net assets available for benefits include amounts allocated to the accounts of participants who were terminated prior to year-end but had not yet received payment. At December 31, 2024 and 2023, the vested account balances of terminated participants were:
