Note 1 - Plan Description

The following brief description of the Houston Plating & Coatings 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Houston Plating & Coatings, LLC (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on January 1, 2007 and has since been amended and restated.

Houston Plating & Coatings, LLC serves as the plan administrator. An officer of the Company is the named trustee. John Hancock Life Insurance Company (U.S.A.) serves as the Plan's asset custodian and recordkeeper of the Plan.

Eligibility

The Plan is provided for all eligible employees of the Company, as defined. Participation is available for all employees who have completed six consecutive months of service or 1,000 hours of service, whichever comes earlier. The Plan includes a savings feature designed to permit the employee and the Company to contribute to the Plan, at amounts allowable under Section 401(k) of the Internal Revenue Code (IRC).

Contributions

Participants may contribute employee pre-tax contributions of up to 90% of their annual compensation and up to 100% of any bonus received. Participants may designate all or a portion of their contribution as Roth contributions, as defined, subject to the maximum limit allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain other qualified sources as defined in the plan document.

The Company makes safe harbor matching contributions equal to the sum of 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation plus 50% of the participant's elective deferrals that exceed 3% of the participant's compensation but in total do not exceed 5% of the participant's compensation. Each year, the Company may make profit-sharing contributions based on a discretionary formula. For the year ended December 31, 2024, no profit-sharing contributions were made.

Participant Accounts

Participants direct the investment of their accounts into various investment options offered by the Plan. Earnings and losses are allocated to the participants' accounts daily according to an allocation formula provided in the plan document.

Vesting and Forfeitures

Participants are immediately vested in their contributions, their safe harbor matching contributions, plus earnings thereon. Vesting in Company profit-sharing contributions is based on years of service. Employees begin vesting at 20% after one year of service and receive an additional 20% after each additional year of service until they are 100% vested after five years of service. Regardless of the vesting schedule, participants become automatically vested in their employer contributions upon death, disability, normal retirement age, or termination of the Plan. There were \$27 of forfeitures available for use at December 31, 2024 and December 31, 2023. Forfeitures are used to reduce employer contributions or to pay administrative expenses of the Plan. No forfeitures were utilized to reduce employer contributions or to pay administrative expenses during 2024.

Benefit Payments

Distributions may be made to participants upon termination of employment, death, disability, or retirement. Under certain circumstances, withdrawals may be made by active participants upon attainment of age 59½, due to financial hardship or for any other reason as permitted by the Plan in the plan document. Upon termination of employment, participants with an account balance of \$1,000 or less shall receive an automatic lump sum distribution from the Plan. For participants with an account balance greater than \$1,000 but less than \$7,000, the plan administrator shall make a direct rollover into an individual retirement account. Withdrawals from the Plan may be subject to federal income tax on contributions and income earned.

Notes Receivable from Participants

Notes receivable from participants are loans to participants secured by the vested portion of their accounts. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the preceding 12 months, or 50% of their vested interest in the Plan. The minimum loan is \$1,000. Loans to participants are secured by their respective participant account balance as allowed by the Plan and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are repaid through payroll deductions. Loans are to be repaid within five years unless the purpose of the loan is to acquire a principal residence, in which case the term can be extended at the discretion of the plan administrator.

Note 2 - Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Accounting principles followed by the Plan and the methods of applying those principles are summarized below:

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation in the fair value of the investments includes realized gains and losses on investments bought and sold during the year, as well as unrealized appreciation or depreciation of the investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. In general, notes receivable from participants are considered in default in the calendar quarter following the quarter in which an expected payment is not made. Defaulted loans are accounted for as distributions based upon the terms of the plan document when a distributable event has occurred.

Benefit Payments

Benefit payments to participants or beneficiaries are recorded when paid.

Administrative Expenses

Administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant loans or benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation or depreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by the Plan's Asset Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from John Hancock Life Insurance Company (U.S.A.) as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all the information provided is complete and accurate. Information included in the accompanying financial statements, the notes to the financial statements and the supplemental schedule regarding investments, notes receivable from participants, net appreciation in fair value of investments and interest income on notes receivable from participants is presented solely in reliance upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements, and the supplemental schedule.

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: These funds are valued at their net asset value (NAV) as determined by the issuer based on quoted market prices of the underlying investments, when available. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than reported NAV.

The pooled separate accounts that are measured using NAV as a practical expedient have been excluded from the fair value hierarchy in accordance with GAAP.

The following table provides additional information for the pooled separate accounts as of December 31, 2024 and 2023. There were no plan or participant redemption restrictions for the investments.

- (a) The strategy of these investments is to achieve as high a total return on an annual basis as is considered consistent with prudent investment risk and the preservation of capital by investing in a combination of mutual funds and money market funds, using an asset allocation strategy designed for investors expecting to retire around a specific target date.

Note 5 - Federal Income Tax

The Plan has adopted a pre-approved plan, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan has since been amended; however, the plan administrator, through its adoption of the pre-approved plan, believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Party-in-Interest Transactions

The Plan engages in investment transactions with funds issued by John Hancock Life Insurance Company (U.S.A.), the Plan's asset custodian. These transactions qualify as party-in-interest transactions and are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.
