## **Actuarial value of assets**

The method of computing the actuarial value of assets complies with rules governing the calculation of such values under the Pension Protection Act of 2006 (PPA). As a result, the actuarial value of assets will be lower than the market value in some years and greater in other years. However, over the long term under PPA's smoothing rules, the method has a significant bias to produce an actuarial value of assets that is below the market value of assets.

## **Benefits not valued**

All benefits described in the Plan Provisions section of this report were valued. WTW has reviewed the plan provisions with MCMLLC and, based on that review, is not aware of any significant benefits required to be valued that were not.

## **Assumption Rationale - Significant Economic Assumptions**

### **Interest rate**

The basis chosen was selected by the plan sponsor from among choices prescribed by law, all of which are based on observed market data over certain periods of time.

### **Lump sum conversion rate**

As required by IRC 430, lump sum benefits are valued using "annuity substitution", so that the interest rates assumed are effectively the same as described above for the discount rate.

In consultation with MCMLLC, no assumptions were made for missing or apparently inconsistent data elements.

We are not aware of any errors or omissions in the data that would have a significant effect on the results of our calculations.

## Source of Prescribed Methods

**Funding methods** The methods used for funding purposes as described in Appendix A, including the method of determining plan assets, are “prescribed methods set by law”, as defined in the actuarial standards of practice (ASOPs). ## Deferred Retirement

### Monthly Benefit:

If retirement occurs on a deferred retirement date, the late retirement income will be based on the greater of:

- The retirement benefit calculated at the late retirement date multiplied by a fraction, the numerator of which will be the “unit value” as determined at the normal retirement date and the denominator of which will be the “unit value” as determined at the late retirement date. A participant’s “unit value” as of any date will be the then “present value” of one dollar of monthly retirement income payable for life with 180 months certain, determined according to the plan’s actuarial assumptions.
- The income provided by the single-sum present value of the retirement income payable as of normal retirement date, as if employment had then terminated, accumulated with interest at 7.00% per annum for the period beginning on the normal retirement date and ending on the actual retirement date.

## Early Retirement

### Monthly Benefit:

Accrued benefit at early retirement date, reduced 1/2% for each month by which the benefit payment commencement date precedes the first day of the month coincident with or next following the attainment of age 60. The commencement date can be deferred to any date prior to the Normal Retirement Date.

### Special Monthly Benefit:

Additional monthly benefit of \$50 times years of credited service (to a maximum of 12 years). Eligibility is limited to those who retire due to disability on or after January 1, 1990, who have met the early retirement eligibility conditions and whose age and years of credited service total at least 75.

## Disability Benefit

The monthly income actuarially equivalent to what would have been paid to the beneficiary as a death benefit if the disabled participant had died on his/her disability retirement date.

## Death Benefit

### Death in Active Service or during Military Leave:

In the event of death prior to eligibility for normal retirement, a single sum equal to the present value of accrued retirement benefits (assuming commencement at the date of death or, if later, the date the participant would have attained 60, and without reduction for such assumed commencement prior to age 65) will be payable to the beneficiary. In the event of death after eligibility for normal retirement, a single sum equal to the present value of accrued retirement benefits, assuming commencement of benefit payments immediately prior to the participant's death, will be payable to the beneficiary.

### Death as Terminated Participant:

If a deferred vested participant dies prior to the receipt of any payments under the plan, a single sum equal to the present value of accrued retirement benefits calculated based on the participant's credited service and compensation up to the time of his termination of employment (assuming commencement at the date of death or, if later, the date the participant would have attained 60, and without reduction for such assumed commencement prior to age 65) will be payable to the beneficiary.

### Payment Terms:

If the participant is survived by a spouse, the death benefit will be paid to the surviving spouse in an actuarially equivalent monthly benefit for life, with a guarantee that if the total amount paid to the spouse is less than the lump sum death benefit otherwise payable, the difference will be paid in the form of a lump sum to the spouse's estate. If the participant was 65 or older or had completed at least 10 years of credited service at his death, the spouse's benefit commences on the first of the month following the later of the date of death or the date the participant would have attained age 55. In all other cases, the spouse's benefit commences on the first of the month following the date the participant would have attained age 65. However, in all cases, the spouse may elect to begin actuarially equivalent payments at any time after the death of the participant. In lieu of monthly annuity payments, the surviving spouse may elect to receive the death benefit in a single lump sum. If the employee has no spouse at death or has elected a non-spouse beneficiary with spousal consent, the participant's death benefit will be paid in a single sum is paid to the designated beneficiary(ies) as soon as practicable after the date of the participant's death.

The company also maintains a defined contribution plan that benefits largely identical groups of participants. In the event that the plan is top-heavy, minimum benefits paid to non-key employees who are also covered under the company's defined contribution plan will be offset by benefits provided under the defined contribution plan.
