1. Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the plan administrator.

General

The Plan Sponsor, Transtecs Corporation (the Company), amended and restated the Transtecs Corporation Employees' Money Purchase Pension Plan (Plan), adopting the Datair Volume Submitter Defined Contribution Plan effective January 1, 2018.

The Plan is a defined contribution plan covering all employees of the Company who have completed one hour of service, with the exception of leased employees and members of collective bargaining units. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute amounts representing distributions from other qualified plans (rollovers). Participants direct all contributions, including employer contributions, into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts invested in mutual funds and guaranteed interest accounts as investment options for participants. Contributions are subject to certain limitations.

The employer, for each plan year, shall allocate a fixed percentage as prescribed by either state prevailing wage statutes or federal rules promulgated under the Davis-Bacon Act, and as earned by the participant for services performed which are covered by such statutes and rules. Employer contributions for salaried participants were equal to 5% of the participant's compensation January 1, 2024 through December 31, 2024.

Participant Accounts

Each participant's account is credited with participant's contributions from other qualified plans, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All participants are immediately vested in their voluntary contributions from other qualified plans and in the Company's contributions, with the exception of non-Davis Bacon employees as follows.

Effective July 1, 2011, non-Davis Bacon employees vest in Company contributions based on a 6-year graded vesting schedule as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2	0%
After 2	20%
After 3	40%
After 4	60%
After 5	80%
After 6	100%

The non-vested balance is forfeited following (1) five consecutive 1-year breaks in service or termination of service, or (2) distribution of the entire vested portion of the Participant's account. Forfeitures are used to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$371 and \$365, respectively. Forfeitures applied to reduce employer contributions amounted to \$71,496 for the year ended December 31, 2024.

A participant's account balance becomes 100% vested upon disability, attaining normal retirement age, or death of the participant.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the account, or a joint or survivor annuity if the participant's vested account balance exceeds \$5,000.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. FASB Accounting Standards Codification 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Valuation of Investments and Income Recognition (continued)

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

All financial instruments held by the Plan are participant directed investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

3. Investments/Insurance Contract

Upon enrollment in the Plan, a participant may direct participant and employer contributions in any of the numerous investment options made available to them. During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought, sold and held during the year, plus interest and dividends) appreciated in value by \$746,780.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued based on the market value of its underlying investments. Although the pooled separate accounts are not available in an active market, the value is approximated based on the quoted prices of the underlying investments that are traded in an active market and prices are declared and posted daily and available to participants. The Company has no unfunded commitments related to any of these investments and there are no Plan initiated redemption restrictions on these investments. There are no redemption restrictions on participant's holdings in the investments and the Plan can redeem these investments daily.

Guaranteed interest accounts: Valued by comparison of rates in effect on the valuation date to stated guaranteed rates and maturities on accounts. Rates for specified terms are directly observable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

The Plan had guaranteed interest accounts with John Hancock in 2024 and 2023 which provide for a guaranteed interest rate for periods of three, five and ten years. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by John Hancock. The accounts are not fully benefit-responsive, and as such, are reflected at fair value. The guaranteed interest rate is determined by averaging the rates in effect on each day during which deposits are directed to the deposit accounts. All rates credited during the 12-month deposit year are averaged into a single composite rate. The average yield interest rates were 0% and 2.08% as of December 31, 2024 and 2023, respectively.

4. Information Certified by Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodian, John Hancock Life Insurance Company, has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023, except for \$17,816 and \$17,032 held by an investment manager as of December 31, 2024 and 2023, respectively.
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – schedule of assets (held at end of year), December 31, 2024, except for \$17,816 held by an investment manager.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Plan Tax Status

The Internal Revenue Service had previously issued a letter dated August 30, 2001, stating the form of plan adopted by the Company qualified under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan was amended and restated effective January 1, 2018, adopting the Dataair Volume submitter Defined Contribution Plan. The Internal Revenue Service has issued a letter dated March 31, 2014, stating the form of the restated plan, adopted by the Company effective January 1, 2018, qualifies under Section 401(a) of IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believe the Plan is qualified and tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan has not taken any uncertain tax positions that would subject the Plan to a tax liability or asset.

6. Related Party Transactions and Party-in-Interest Transactions

Plan investments are maintained in pooled separate accounts or guaranteed interest accounts managed by John Hancock Life Insurance Company, the asset custodian. Therefore, these transactions qualify as party-in-interest transactions.

The Plan incurs expenses related to general administration and recordkeeping. Certain of these expenses relating to the Plan are paid by the plan sponsor.

7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balance.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
