Report of Independent Auditors

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the Indiana Farm Bureau Companies Employees' 401(k) Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General — The Plan is a defined contribution plan covering substantially all employees of United Farm Family Life Insurance Company (the "Company", "Plan Sponsor", or "Plan Administrator"), United Farm Family Mutual Insurance Company, Indiana Farm Bureau, Inc., and any corporation in which the Company owns 50% or more of the outstanding shares of the stock which may adopt the Plan (collectively referred to as the "Companies"). Fidelity Management Trust Company serves as Trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions — Employees may defer up to 75% of base salary through periodic payroll deductions. Maximum contributions are limited by applicable Internal Revenue Service ("IRS") regulations. Plan participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation. Employees may elect to enroll in or opt out of auto-escalation at any time.

The Companies' matching contributions equal 50% of each employee's contribution up to 4% of compensation with a maximum match of 2% of the employee's compensation. Participants can designate both their contributions and the matching contributions be invested in any of the investment funds offered by the Plan. All amounts in participants' accounts are participant-directed. Allocations of investment earnings (losses) are based on participant earnings or account balances, as defined.

The Plan also provides for a qualified, non-elective defined contribution, covering substantially all employees of the Companies. The contribution is determined based on eligible earnings, age and date of employment. Gross contributions of approximately \$9.9 million and \$10.3 million in 2024 and 2023, respectively, are reflected in employer contributions receivable on the statement of net assets available for benefits.

Vesting — Participants immediately vest in their own contributions plus earnings and vest in employer contributions after three years of service. Participants are entitled to benefits beginning at normal retirement age of 65. The Plan also permits early retirement at age 55 plus 10 years of vesting services. All benefits are paid in one or more lump sum payments.

Notes Receivable from Participants — Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or may exceed five years for the purchase of a primary residence. The loans are collateralized by the participant's vested account and bear interest at a rate commensurate with that of the prevailing market. Principal and interest are paid ratably through monthly payroll deductions. Should the participant terminate employment, the balance of the outstanding loan becomes due and payable at the

end of the cure period as defined in the Plan document, or the participant can rollover the balance to a qualified plan within 90 days of termination.

Payments of Benefits — If an employee terminates employment due to death, disability or retirement, all amounts in the participant's account become vested. Upon termination of employment for reason other than death, disability or retirement, a participant's benefit is equal to the vested amount in the participant's account. If the participant's account exceeds \$5,000, such distribution shall not be made without the participant's consent. If the participant's account exceeds \$1,000 but is less than \$5,000, and the participant does not elect a direct rollover to an eligible retirement plan or cash payment, Fidelity Management & Research Company ("FMR") (the "Recordkeeper"), under instruction from the Plan Sponsor, shall pay the distribution in a direct rollover to an individual retirement account plan designated by the Plan Sponsor.

A participant in the Plan may make a complete or partial hardship withdrawal of the amounts held in the participant's account attributable to the participant's contributions (exclusive of any earnings thereon or the Companies' matching contributions) at any time and will be paid the market value of the account. The withdrawal must meet the Plan Definition of Financial Hardship and be deemed on account of immediate and heavy financial needs of the participant that cannot be satisfied by any other source, including any available plan loans. Active participants may make in-service withdrawals at or after age 59 1/2.

Forfeitures — If an employee is terminated by reason other than death or disability, the nonvested Companies' contributions and related income thereon are forfeited and used to reduce employer contributions remitted in the subsequent plan year. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$73,189 and \$29,899, respectively. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$28,441 and \$54,364, respectively, from forfeited nonvested accounts.

Plan Termination — Although they have not expressed the intent to do so, the Companies have the right to terminate the Plan subject to the terms of ERISA. In the event the Plan is terminated, each participant's account shall be nonforfeitable with respect to both the participant's and the Companies' contributions and the net assets are to be set aside for the payment of withdrawals to the participants. The Companies have the right to suspend contributions to the Plan at any time, either permanently or temporarily, for any length of time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition — The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the commingled stable value fund is determined by using the net asset value ("NAV"), as a practical expedient, based on the audited financial statements. NAV is based on the fair value of the underlying investments of the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment at an amount different than the reported NAV. Registered investment companies (mutual funds) have values that are readily determinable based on the value of the fund at the close of regular trading.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold during the year as well as on investments held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses — Administrative expenses such as those for record-keeping, legal and accounting services are either paid by the Companies or are deducted from a revenue sharing holding account that is funded by the Trustee pursuant to an agreed-upon percentage of fees for each investment fund. Management fees and operating expenses charged to the Plan for investments in mutual funds and the commingled stable value fund are deducted from income earned on a daily basis and are not separately reflected. Fees related to the administration of notes receivable from participants are charged to the participant's account and are included in administrative expenses.

From time to time, when the level of funding in the revenue sharing account exceeds projected Plan expenses, the Plan Administrator will allocate those excess funds to Plan participants. The funds are allocated based on participants' respective account balances. The excess revenue sharing funds allocated to the participant accounts were \$2,495 and \$0 as of December 31, 2024 and 2023, respectively.

Payment of Benefits — Benefit payments to participants are recorded upon distribution.

3. INVESTMENTS AND FAIR VALUE MEASUREMENT

ASC 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets that the Plan has the ability to access; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available and observable for substantially the full period; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

In accordance with Subtopic 820, the commingled stable value fund that is measured at fair value using net asset value per share (or its equivalent) as a practical expedient has not been classified in the fair value hierarchy. Registered investment companies (mutual funds) are level 1 investments in the fair value hierarchy.

4. COMMINGLED STABLE VALUE FUND

The T. Rowe Price Stable Value Trust Fund A (the "Fund") is a commingled stable value fund managed by the T. Rowe Price Trust Company. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's constant net asset value ("NAV") of \$1 per unit. Distribution to the Fund's unit holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable net asset value of \$1 per unit, although there is no guarantee that the Fund will be able to maintain this value.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at NAV.

5. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fiduciary Management Trust Company.

6. FEDERAL INCOME TAX STATUS

Effective July 16, 2021, the Plan adopted a volume submitter 401(k) and profit sharing plan sponsored by FMR which does not require an application for a determination letter from the Internal Revenue Service ("IRS"). The volume submitter plan has received an advisory opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code ("IRC"). The Plan Sponsor has determined that it is eligible to and has chosen to rely on the current IRS volume submitter plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC

to maintain its qualified status. The Plan Sponsor is not aware of any course or series of events that have occurred that might adversely affect the Plan's qualified status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments are shares of commingled stable value fund and mutual funds managed by the Trustee as defined by the Plan. Therefore, transactions with the Trustee qualify as exempt party-in-interest transactions. Indirect expenses are paid to the Trustees by the Plan as described in Note 2.
