Scope and Nature of the *ERISA Section 103(a)(3)(C)* Audit

We have performed audits of the accompanying financial statements of Unified Group Services 401K Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 (ERISA)*, as permitted by *ERISA Section 103(a)(3)(C)*. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Unified Group Services 401K Retirement Plan's financial statements performed in accordance with *ERISA Section 103(a)(3)(C)* pursuant to 29 CFR 2520.103-8 of the *Department of Labor's Rules and Regulations for Reporting and Disclosure* under *ERISA*. As permitted by *ERISA Section 103(a)(3)(C)*, our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the *Department of Labor's Rules and Regulations for Reporting and Disclosure* under *ERISA* (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of *ERISA Section 103(a)(3)(C)*.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Unified Group Services 401K Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management's election of the *ERISA Section 103(a)(3)(C)* audit does not affect management's responsibility for the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of Unified Group Services 401K Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution Plan covering all employees of Unified Group Services, Inc. (the Company), who have met eligibility requirements. The Plan became effective on January 1, 2009. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*. The Plan was restated effective June 1, 2022.

Eligibility – Employees become eligible to participate when they attain the age of 18.

Voluntary and Safe Harbor Contributions – Participants may make voluntary contributions ranging from 1% to 85% of their compensation but may not exceed the maximum contribution limitations established annually by the Internal Revenue Service. Participants direct the investment of their contributions, as well as all Company contributions, into various investment options offered by the Plan. The Plan also allows participants to make voluntary after-tax Roth contributions and qualifying rollover contributions. Effective June 1, 2023, the Plan adopted an automatic deferral provision of 3% of compensation with no escalation clause. This change did not affect existing participants. The Company makes a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation.

Profit Sharing and Matching Contributions – The Company may contribute profit sharing contributions annually to eligible participants based on the percentage of the participant's compensation to total compensation of all participants eligible to share. Discretionary matching contributions equal to a uniform percentage of salary deferrals may also be made on an annual basis. No profit sharing or matching contributions were made during the years ended December 31, 2024 and 2023.

Participant Accounts – Each participant's account is credited with the participant's contribution, Plan sponsor contributions, and investment earnings based on the investment options selected. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are fully vested in their contributions, employer contributions, and earnings thereon.

Forfeitures – All account balances are 100% vested. There were no unallocated forfeitures as of December 31, 2024 and 2023.

Benefit Distributions – Benefits generally are distributed upon the participant's termination, normal retirement, disability retirement, or death. Benefits are payable either as a lump sum in an amount equal to the sum of the participant's individual vested account, or installments but only with respect to minimum required distributions. There are also provisions for in-service and hardship distributions.

1. DESCRIPTION OF PLAN (continued)

Date of Plan Administrator Review – The Plan’s administrator has evaluated subsequent events through the date on which the financial statements were made available to be issued. The date is the same as the independent auditor’s report date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan’s administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

3. PLAN TERMINATION

While the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in *ERISA*. In the event of Plan termination, payment of benefits would be made as provided in the Plan agreement.

4. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated August 19, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

5. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

6. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by American United Life Insurance Company (AUL). AUL is the custodian as defined by the Plan and, therefore, these investments and investment transactions qualify as exempt party-in-interest transactions. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Certain expenses for maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. For the years ended December 31, 2024 and 2023, the Plan incurred expenses of \$1,320 and \$736, respectively, for administrative fees.

7. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 inputs were not available. There were no Plan assets requiring the use of Level 1, 2, or 3 inputs for the periods presented.

Pooled Separate Accounts – The Plan invests in pooled separate accounts which are valued at the net asset value of accumulation units. The net asset value is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.

NOTES TO FINANCIAL STATEMENTS

8. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The contract value of the investment contract at December 31, 2024 and 2023, was \$89,031 and \$106,901, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.0%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate as of December 31, 2024 and 2023, was 2.70% and 2.95%, respectively. The average yield for the years ended December 31, 2024 and 2023, was 2.20% and 2.30%, respectively.

Certain events limit the Plan's ability to transact at contract value with AUL. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under *ERISA*. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
