### **Basis for Opinion**

**NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

---

**1. DESCRIPTION OF PLAN**

The following brief description of Wayne County Action Program, Inc. 403(b) Thrift Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**General**

The Plan is a defined contribution retirement plan established to provide retirement benefits to employees of Wayne County Action Program, Inc. d/b/a Finger Lakes Community Action (Wayne CAP). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Board of Directors of Wayne CAP. Capital Group - American Funds is the recordkeeper of the Plan's assets and Rimkus, Marciano & Associates, Inc. is the third party administrator of the Plan. Capital Bank and Trust Company and Mutual of America Life Insurance Company (Mutual of America) are the custodians of the Plan.

**Eligibility**

All employees are immediately eligible to begin salary deferrals pursuant to a properly completed and valid salary reduction agreement. Employees who have completed 12 months of service (1,000 hours) are eligible to receive discretionary employer contributions and matching contributions throughout the plan year.

**Contributions**

Participants may make voluntary contributions subject to certain limitations under the terms of the Plan and the Internal Revenue Code (the Code). Wayne CAP made matching contributions of up to 3.25% of eligible participant compensation for 2024 and 2023. Wayne CAP can also make contributions at the discretion of the Board of Directors. In 2024 and 2023, Wayne CAP elected not to make discretionary contributions.

All investments are participant directed.

**Rollover Contributions**

The Plan will accept direct rollover contributions from a qualified plan, as defined by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, Wayne CAP's contribution, any earnings/losses thereon, and administrative expenses, if applicable. Allocations of earnings/losses and administrative expenses are based on participant account balances according to the specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary and employer contributions and actual earnings/losses thereon.

**Notes Receivable from Participants**

Plan participants may borrow up to the lesser of \$50,000 or 50% of the amount of the participant's vested interest in the Plan. The minimum loan is \$1,000. Participant loans are secured by their account balances and bear interest at rates ranging from 4.25% to 10.50%.

## 1. DESCRIPTION OF PLAN (Continued)

### **Payment of Benefits**

A participant's vested account balance may be distributed in a lump sum amount at any time after attainment of age 59 1/2, termination, death, disability, or upon incurring a hardship.

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Plan Administration Expenses**

Expenses incurred in connection with the purchase or sale of securities are charged against the investment funds whose assets are involved in such transactions. Certain administrative costs of the Plan are paid by Wayne CAP. All other expenses relating to participant transactions are deducted from those participant accounts as transactions occur.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investments Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive guaranteed interest accounts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive guaranteed interest accounts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Fully Benefit-Responsive Guaranteed Interest Accounts**

All amounts allocated to the interest accumulation account become part of Mutual of America's general account. The amount in the interest accumulation account at any time will be equal to the sum of all amounts that have been allocated to such account, including interest credited to the account, less the sum of all amounts that have been withdrawn from such account. Participants' principal and previously credited interest are guaranteed. Mutual of America assumes the investment risk of the underlying investments of the interest accumulation account. This guarantee is subject to Mutual of America's financial strength and claims-paying ability. Mutual of America's general account investment strategy is to maintain high-quality assets with excellent liquidity, strong capital adequacy, and a proper matching of assets and liabilities.

The general account is credited with interest at a rate determined by Mutual of America from time to time, and Mutual of America reserves the right to change the interest rates applicable to amounts held in this account at their discretion, but not below the minimum guaranteed interest rate of 1.50%. The crediting rate determined by Mutual of America was 2.90% and 2.85% as of December 31, 2024 and 2023, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fully Benefit-Responsive Guaranteed Interest Accounts (Continued)

The interest rate credited to amounts in the general account is a current rate and is not dependent upon the length of time the assets are invested with Mutual of America. Further, requests for withdrawal (subject to Plan provisions) can be made at any time and are processed on the day that they are received; they are not dependent on Mutual of America having to liquidate securities in order to generate a payment. The contract value is the redeemable value of the fund; there are no deferred sales charges, load assessments, interest rate adjustments, or surrender charges that would affect the value as a result of a withdrawal request. Therefore, the amounts held in the general account have been determined to be cash equivalents and are considered fully benefit-responsive.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents, including complete or partial Plan termination or merger with another plan or (2) bankruptcy of the Plan Sponsor. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### Fair Value Measurements

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Mutual funds:* valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price.

A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 4.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes are reclassified as distributions based upon terms of the Plan document. No allowance for doubtful accounts has been recorded as of December 31, 2024 and 2023.

### Payment of Benefits

Benefit payments are recorded when paid.

### Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and notes. Actual results could differ from those estimates and such differences may be significant.

#### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the administrator of the Plan has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. All distributions would be made in accordance with any applicable requirements of the Employee Retirement Income Security Act of 1974 and the Code.

#### 6. TAX STATUS

The Plan is exempt from federal and state income tax under Section 403(b) of the Code. The Plan has received a favorable opinion letter from the Internal Revenue Service, dated March 31, 2017, as a volume submitter plan's qualified status. The volume submitter plan's opinion letter has been relied upon by the Plan. The Plan has been amended since receiving the date of the opinion letter. However, the Plan Administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

#### 7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of December 31, 2024 and 2023.

#### 8. PARTY-IN-INTEREST TRANSACTION

Capital Bank and Trust Company and Mutual of America are the custodians of the Plan, Capital Group - American Funds is the recordkeeper of the Plan, Rimkus, Marciano & Associates, Inc. is the third party administrator of the Plan, and Wayne CAP is the Plan Sponsor. As such, transactions between Capital Bank and Trust Company, Mutual of America, Capital Group - American Funds, Rimkus, Marciano & Associates, Inc., Wayne CAP, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants qualify as party-in-interest transactions.

**9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
