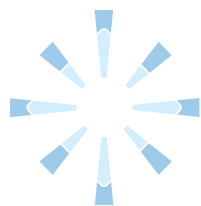

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of the Opal Foods Cooperative, Inc. Co-op 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audits does not affect management’s responsibility for the financial statements.

**Notes to Financial Statements****December 31, 2024 and 2023****1. Summary of Significant Plan Provisions**

The following description of the Opal Foods Cooperative, Inc. Co-op 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan established for the benefit of employees of Opal Foods Cooperative, Inc. (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Each employee, who is not a member of a collective bargaining agreement and is not a nonresident alien, is eligible to participate in the Plan at the next plan entry date upon attaining age 18 and completing 90 days of continuous service. Entry dates are the first day of each month.
- c. **Contributions** – Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. The maximum combined limit for pretax and Roth contributions may not exceed 50% of annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Employer will make a safe harbor matching contribution of 100% of the participant’s elective contributions up to 4% of the participant’s eligible compensation. The Employer may also make additional discretionary contributions to the Plan. No such discretionary contributions were made during the years ended December 31, 2024 or 2023. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting rights** – A participant is always fully vested in their own contributions, the Employer safe harbor matching contributions, and discretionary contributions, plus earnings/losses thereon.
- f. **Investment options** – Upon enrollment in the Plan, a participant may direct their contributions to any of the investment options offered by the Plan. Participants may change their investment selections at any time.
- g. **Notes receivable from participants** – Participants may borrow a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding note receivable balance during the preceding year over the outstanding note receivable balance at the date of the note, or 50% of the participant’s elective deferral account balance. Note terms range from one to five years or 15 years for the purchase of a primary residence. The notes are secured by the participant’s account. Notes bear interest at the current prime lending rate plus 1%. Principal and interest are paid through payroll deductions.

**Notes to Financial Statements****December 31, 2024 and 2023****1. Summary of Significant Plan Provisions (cont.)**

- h. Payment of benefits** – Upon termination of employment, participants can elect to receive the value of their vested account in a lump sum or in installment payments, or may elect to defer payment of their account balance if it exceeds \$1,000. If the participant's account balance is equal to or less than \$1,000, the balance will be automatically distributed. Participants may request an in-service withdrawal from any of their accounts if they meet the hardship requirements defined in the Plan document or attain age 59½. Participants may also elect to withdraw rollover contributions at any time.
- i. Termination of the Plan** – Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**2. Summary of Significant Accounting Policies**

- a. Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- b. Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. Investment valuation and income recognition** – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value as disclosed in Note 3. See Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- d. Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. Payment of benefits** – Benefits are recorded when paid.
- f. Administrative expenses** – Certain administrative expenses of the Plan were voluntarily paid by the Employer, which are excluded from these financial statements. Fees related to loans and distributions are charged directly to the participant's account. Other administrative expenses are allocated to participant's accounts.

**3. Fully Benefit-Responsive Investment Contracts**

The Plan has entered into fully benefit-responsive guaranteed investment contracts (“GIC”) with American General Life Insurance Company, Pacific Life Insurance Company, The Prudential Insurance Company of America and Transamerica Life Insurance Company (collectively, the “Insurance Companies”). The Insurance Companies maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Insurance Companies are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The actual crediting rate is established periodically by the Insurance Companies.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Insurance Companies, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract or termination of the Plan. The Plan’s management does not believe the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

**4. Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Charles Schwab Trust Bank (“Charles Schwab”), the trustee of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedules:

- a. Cash - noninterest-bearing as shown on the accompanying statement of net assets available for benefits of \$201 and \$1,036 as of December 31, 2024 and 2023, respectively.
- b. Total investments as shown on the accompanying statement of net assets available for benefits of \$6,757,993 and \$5,456,047 as of December 31, 2024 and 2023, respectively.

- c. Interest and dividends as shown on the accompanying statement of changes in net assets available for benefits of \$208,462 and \$156,893 for the years ended December 31, 2024 and 2023, respectively.
- d. Net change in value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$390,406 and \$523,395 for the years ended December 31, 2024 and 2023, respectively.
- e. All investment transactions that occurred during the years ended December 31, 2024 and 2023.
- f. All information included in the schedule of assets (held at end of year), excluding participant loans.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Fair Value Measurements (cont.)

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023:

*Mutual funds:* These investments are valued at quoted market prices on the last business day of the Plan year.

*Common collective trust fund:* This investment is stated at fair value based on the net asset value (“NAV”) of units held by the Plan at year-end, as calculated by the issuer. The NAV is calculated based on the fair value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. **Tax Status**

The Plan is utilizing a volume submitter plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

7. **Parties-in-Interest Transactions**

Charles Schwab is the trustee for the Plan. The Plan pays Charles Schwab for its services. Milliman, Inc. (“Milliman”) is the record keeper for the Plan. The Plan pays Milliman for its services. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions, all of which are exempt from being prohibited transactions under ERISA.
