As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of National Society of Leadership 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about National Society of Leadership 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedules listed in the accompanying index, together referred to as "Supplemental Information", as of the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying

accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



DECEMBER 31, 2024 AND 2023

NOTE 1: DESCRIPTION OF THE PLAN

General

The National Society of Leadership 401(k) Profit Sharing Plan (the "Plan") was established August 1, 2006 (and was restated effective January 1, 2024) as a defined contribution plan covering all of the eligible employees of The National Society of Leadership and Success, LLC (the "Company", or "Plan Sponsor"). The Plan is a qualified plan as defined by Section 401(a) of the Internal Revenue Code and contains a provision for salary reduction contributions under Section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective October 1, 2024, the Plan changed trustees from John Hancock Life Insurance Company to Ascensus, LLC.

Eligibility

Non-excluded employees who have reached the age of 21 years of age and have completed 90 consecutive days of service are eligible to participate in the Plan. Participants are eligible to enroll in the Plan on the first day of the month after satisfying eligibility requirements.

Contributions

Participants may elect to contribute up to 100% of their annual pre-tax compensation, as defined, to the Plan, subject to Internal Revenue Service limitations, and may direct their contributions to various investment alternatives. Participants may also designate some or all of their contributions as an after-tax Roth contribution, subject to limitations. The contribution limit applies to any calendar year and is adjusted annually by the Internal Revenue Service. For 2024, the maximum contribution allowed for any employee was \$23,000. Additionally, participants who attain age 50 during the plan year may make "catch up" contributions of up to \$7,500 for 2024. The Plan allows rollover contributions from some other qualified retirement plans. The Company matches 50% of the first 6% of employee contributions, creating a maximum 3% employer match. The Company, at the discretion of the Board of Directors, may make a nonelective profit sharing contribution to the Plan during the year. For the year ended December 31, 2024, the Company contributed \$212,218 to eligible participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) the Company's contribution and (b) investment income (less expenses). Income for each of the investment choices is allocated to the participants' accounts on a daily basis and is based on the relative units of participation.

Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

Vesting and Payment of Benefits

All participants' contributions vest immediately. Company matching contributions and non-elective contributions vest as follows:

Years of Service	Percentage Vested
Less than 1 year of service	0%
1 Year of service	20%
2 Year of service	40%
3 Year of service	60%
4 Year of service	80%
5 or More Years of service	100%

If death or permanent disability occurs during employment, an employee's entire account becomes fully vested.

Upon a participant's retirement, termination, disability, or death, a participant may elect to receive the value of his or her vested interest as a lump-sum payment. Participants, upon reaching the age of 59½, may also take an in-service distribution. Installments are required for employees over 70 ½ to meet the minimum distribution requirements of Internal Revenue Code regulations. Separating participants may elect to rollover their account into another plan, as permitted by Internal Revenue Service regulations.

Forfeitures

Forfeitures of profit sharing or matching contributions due to termination of employment are used to reduce Company contributions to the Plan. Certain forfeitures may also be used for the payment of Plan expenses. Total forfeitures for the year ended December 31, 2024 were \$6,631, and were used to reduce total employer contributions and plan fees.

Notes Receivable From Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. Notes receivable bear interest at a reasonable rate and are secured by the participant's account. Notes receivables are valued at amortized cost, which approximates fair value. Principal and interest payments are made ratably through payroll deductions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and expenses during the reporting period. Actual results could differ from those estimates.

Investments

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis.

Payment of Benefits

Normal retirement age under the Plan is 65. The Plan allows for hardship withdrawals from a participant's salary deferral account.

On termination of service before or after the normal retirement age, a participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

Benefits are recorded when paid.

On termination of service due to death, a beneficiary will receive an amount equal to the value of the deceased participant's vested interest in their account in a lump-sum pay amount.

Administrative Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and distributions from participant distributions are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 3: TAX STATUS

The Plan is an adoption of a non-standardized prototype arrangement designed by Ascensus, LLC, which received a determination letter dated January 1, 2018, from the Internal Revenue Service (IRS) that qualified the prototype arrangement as tax-exempt under the appropriate sections of the Internal Revenue Code (IRC). The Plan has not yet received its own determination letter from the IRS. Although the Plan has been amended since adoption, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4: ADMINISTRATION AND INVESTMENTS

Administration

January 1, 2024 through October 1, 2024, the Plan's investments were administered by John Hancock Life Insurance Company ("John Hancock"), the custodian of the plan. Among other duties, John Hancock receives contributions, invests and reinvests the Plan's assets, collects income and makes distributions from the Plan's assets as directed by the Administrative Committee for the Plan.

On October 1, 2024 the Administrative Committee of The National Society of Leadership 401(k) Profit Sharing Plan approved and transferred the assets into Ascensus, LLC ("Ascensus"). On October 1, 2024 through December 31, 2024, the Plan's investments were administered by Ascensus, the trustee of the plan. Among other duties, Ascensus receives contributions, invests and reinvests the Plan's assets, collects income and makes distributions from the Plan's assets as directed by the Administrative Committee for the Plan.

Investments

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, John Hancock certified that the accompanying investment balance and income information for the year ended December 31, 2023 and from January 1, 2024 through September 30, 2024 was complete and accurate. Ascensus certified that the accompany investment balances as of December 31, 2024 and income information from October 1, 2024 through December 31, 2024 were complete and accurate. Accordingly, the Plan's independent auditors did not perform any procedures with respect to this information, except comparing and reconciling such information to the financial statements.

NOTE 5: FAIR VALUE MEASUREMENTS

FASB ASC 820-10 provides standards and disclosures for assets and liabilities that are measured and reported at fair value. As defined in FASB ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). FASB ASC 820-10 requires disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements. The statement requires fair value measurements be classified and disclosed in one of the following categories:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2: Measured based upon inputs that are observable, either directly or indirectly, for the asset or liability other than quoted market prices included in Level 1. These inputs include: a) quoted prices for similar asset or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in markets that are not active c) inputs other than quoted market prices that are observable and d) inputs that are derived primarily from or corroborated by observable market data by correlation or other means.

Level 3: Measured based on unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. This input includes management's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The inputs are developed based on the best information available in the circumstances, which might include management's own data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market funds:

The fair value of mutual funds and money market funds is determined by obtaining quoted prices on nationally recognized securities exchanges, which are generally classified within Level 1 of their fair value hierarchy.

Collective trust fund:

The John Hancock Stable Value Fund ("Stable Value Fund") is the only stable value collective trust fund available to the Plan. The Plan uses the NAV per share of the Stable Value Fund provided by the trustee as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the Stable Value Fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The Stable Value Fund's units are issued and redeemed daily at the constant NAV of \$1 per unit. The Fund's investment objective is stability of principal and high current income. There were no unfunded commitments as of December 31, 2024 and 2023.

As required by FASB ASC 820-10, financial assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement.

The Company's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels.

NOTE 6: PARTY-IN-INTEREST TRANSACTIONS

As of December 31, 2024, the Plan invests in mutual funds that are managed by Ascensus who is also the custodian for the Plan. During the year ended December 31, 2024, the Plan paid John Hancock \$18,116 and Ascensus \$412, in administration fees that are included in administrative fees. The Plan believes the fees charged by Ascensus and John Hancock mutual funds and its administrative fees are no different than those that would be charged by other companies engaged in managing pension assets.

NOTE 7: RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investments securities, and are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that reductions in value can occur in the near term and that such changes could materially affect participant account balances reported in the statement of net assets available for benefits.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested.

NOTE 9: INCOME TAXES

The Plan did not have unrecognized tax benefits as of December 31, 2024 and 2023 and does not expect this to change significantly over the next twelve months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2024 and 2023, the Plan has not accrued interest or penalties related to uncertain tax positions. The Plan remains subject to income tax examinations for tax years 2021 and beyond.

NOTE 10: SUBSEQUENT EVENTS

The Plan's management evaluated subsequent events through the date on which the financial statements were issued. There were no events or transactions discovered during this evaluation that require recognition in the financial statements.
