### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Englewood Healthcare Enterprises, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## 1. Description of the Plan

The following description of Englewood Healthcare Enterprises, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan.

### General

The Plan was established effective January 1, 1998. The Plan is a defined contribution plan covering all part-time and full-time employees of Englewood Healthcare Enterprises, Inc., (Enterprises), an affiliate of Englewood Hospital and Subsidiaries (the Hospital). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Hospital's Investment Committee (Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

### Eligibility

An employee is eligible to participate in the Plan on the first day of the calendar quarter coinciding with or following the completion of one year of service and the participants' 21st birthday. Long-term part-time employees who met eligibility requirements under SECURE 2.0 Act of 2022 are also eligible to participate in the Plan.

### Contributions

Each year, participants may contribute up to 100% of pretax annual eligible compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants aged 60-63 are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Enterprises makes matching contributions equal to 50% of the first 2% of the eligible compensation deferred by the participant, up to a maximum of 1% of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of a) Enterprises' contributions and b) the Plan's earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are 100% vested at all times in their elective deferral and rollovers (if applicable), including earnings thereon. Vesting in Enterprises' contribution is based on years of continuous service. A participant is 100% vested after three years of credited service.

## Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions. Interest rates range from 4.25% to 9.50% at December 31, 2024. Loan terms range from one to five years, unless such loan is for the purchase of a participant's primary residence, in which case the repayment period may not extend beyond 15 years from the date of the loan.

## Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, a single life annuity or monthly installments over the participant's life expectancy or the joint life expectancy of the participant and spouse. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

A participant may request an in-service distribution upon reaching age 59½. Additionally, a participant may request an in-service distribution on account of a financial hardship, as defined.

## Forfeitures

If a participant terminates employment with Enterprises, the portion of the Enterprises' contributions and earnings thereon that were not vested are forfeited. Forfeitures can be used to reduce Enterprises' future contributions or to pay administrative expenses of the Plan. Forfeited nonvested accounts totaled \$9,320 and \$3,841 as of December 31, 2024 and 2023, respectively. During 2024 and 2023, forfeitures of \$441 and \$405, respectively, were used to reduce administrative expenses.

## Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance companies. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance and any accrued but unpaid interest is recorded in interest receivable on notes receivable from participants. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Enterprises. Expenses that are paid by Enterprises are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## Payment of Benefits

Benefits are recorded when paid.

## Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The insurance general account investment is valued principally from or corroborated by observable market data at contract value which approximates fair value, as disclosed in Note 4.

#### 4. Insurance General Account With Insurance Company

The Plan has entered into an investment contract with Transamerica Financial Life Insurance Company, Inc. (TFLIC). TFLIC maintains the amounts invested in an insurance general account. The contract is credited with excess Enterprises contributions, forfeitures and earnings on the underlying investments and charged for allocations of such amounts out of the contract to offset future Enterprises contributions or expenses in accordance with the plan document.

Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value, subject to certain restrictions, therefore the contract is not fully benefit responsive. TFLIC has stated that the contract value of the guaranteed interest annuity contract approximates fair value.

The general account investment with TFLIC is a deposit administration contract. The average yield and crediting rate was 0.99% and 0.16% in 2024 and 2023, respectively.

### 5. Related-Party and Party in Interest Transactions

Certain of the Plan's investments are managed by the custodians, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of Enterprises or the Hospital. No such officer or employee receives compensation from the Plan.

### 6. Plan Termination

Although it has not expressed any intent to do so, Enterprises has the right to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Enterprises' contributions.

### 7. Tax Status

The Plan adopted a volume submitter plan offered by Transamerica Retirement Solutions, LLC. The volume submitter plan received an advisory letter dated June 30, 2020, that the Plan, and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$3,723,258 concentrated in three funds and \$3,393,738 concentrated in four funds, respectively.
