## Independent Auditor's Report

To the Plan Advisory Committee

### ***Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Savings Plan for Employees of Hartig Drug Company (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## NOTES TO FINANCIAL STATEMENTS

### 1. Description Of The Plan

The following description of the Savings Plan for Employees of Hartig Drug Company (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) profit-sharing plan covering substantially all employees of Hartig Drug Company (the Employer) who have attained 21 years of age and have completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Eligible participants are automatically enrolled in the Plan with a deferral amount of 4% of eligible compensation, unless the participant elects otherwise. Entry dates to the Plan are semi-yearly on the first day of the first or seventh month of the plan year coinciding with or following eligibility.

Participants may contribute up to 100% of eligible compensation in the form of pre-tax or after-tax (ROTH) contributions not to exceed Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Under the provisions of the Plan, the Employer elected to make discretionary matching contributions equal to 50% of the first 4% of compensation deferred by each participant for the year ended December 31, 2024. Employer matching contributions begin on the first day of the first or seventh month of the plan year coinciding with or following eligibility. The Plan credits years of service with certain predecessor entities acquired by the Employer as outlined in the plan agreement.

Under the provisions of the Plan, the Employer has the option to make discretionary profit-sharing contributions. Participants are eligible for the discretionary profit-sharing contributions upon becoming eligible to make elective deferral contributions and being employed by the Employer on the last day of the plan year. The Employer did not make any discretionary profit-sharing contributions to the Plan for the year ended December 31, 2024.

### Notes To Financial Statements *(Continued)*

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and discretionary employer matching and profit-sharing contributions as well as allocations of the Plan's earnings and expenses. Allocations are based on the participant's eligible compensation, the value of account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their rollover and voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account is based on a rate of 20% for each year of credited service beginning in the second year of service. Participants are fully vested after six years of credited service or upon death, disability or attainment of the normal retirement age of 65.

#### **Hardship Withdrawals**

Participants may elect to withdraw all or a portion of their vested account balance if they incur a financial hardship. Hardship withdrawals are subject to the terms of the plan agreement and provisions of the IRC.

#### **Payment Of Benefits**

Upon termination of service due to death, disability or retirement, participants with an account balance greater than \$7,000 may elect to receive either a lump-sum amount equal to the value of the participant's account, receive installments over a period of time or leave their balance in the Plan subject to minimum distribution requirements. Under the default automatic rollover provisions, distributions greater than \$1,000 but less than \$7,000 will be made to an Individual Retirement Account without participant consent if a participant does not make a different distribution election after receiving the required notification. Participants with a vested balance of \$1,000 or less will receive a lump-sum payment upon termination.

#### **In-Service Withdrawals**

Active participants who reach age 59½ may withdraw all or part of their vested accounts.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited accounts totaled \$23,324 and \$25,745, respectively. These accounts may be used to reduce discretionary employer matching and profit-sharing contributions or to pay plan expenses. In 2024, employer matching contributions were reduced by \$23,929 and plan expenses of \$8,075 were paid from forfeited accounts.

### **2. Summary Of Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use Of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's advisory committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### **Contributions**

Contributions from plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions are recorded when declared by the Employer.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions.

#### **Payment Of Benefits**

Benefit payments to participants are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses are recorded net of amounts received under revenue sharing agreements with the fund managers. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **Reclassifications**

Certain reclassifications have been made to the 2023 financial statements, where appropriate, to conform to the 2024 presentation used.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Notes To Financial Statements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts:* Valued at the NAV of units of the trusts. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

### **5. Related-Party And Party-In-Interest Transactions**

Certain plan investments are shares of a common/collective trust managed by Principal Global Investors Trust Company, a member of the Principal Financial Group. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan, is also a member of the Principal Financial Group. Therefore, these transactions qualify as party-in-interest transactions.

The Plan receives a revenue credit under a revenue credit program from certain fund managers based on the funds participants have chosen. Revenue credits are either allocated to the participants or used to reduce plan expenses. For the year ended December 31, 2024, plan expenses were reduced by \$137 under the revenue credit program.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

### **7. Tax Status**

The Employer has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the pre-approved plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
