Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bimbo Bakeries USA Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

(1) Description of Plan

The following description of the Bimbo Bakeries USA Savings Plan (the Plan) provides only general information. Participants should refer to the plan document, including plan amendments, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers certain eligible employees of BBU, Inc. (the Company) as defined in the plan document. Earthgrains Baking Companies Inc. (Earthgrains) was acquired by the Company on November 6, 2011.

Effective January 1, 2015, each non-collectively bargained hourly employee who was a participant in the Sara Lee Plan joined the Plan. Also, effective January 1, 2015, each employee of Bimbo Bakehouse (formerly Wholesome Harvest Baking, Inc.) who was a participant in the MapleLeaf Foods USA Retirement Plan as of December 31, 2014 joined the Plan.

Effective December 31, 2018, participants and account balances from the Bays 401(k) Retirement Savings Plan (Bays Plan) merged into and became eligible to participate in the Plan.

Effective December 31, 2019, participants and account balances from the East Balt (BQSR) Plan merged into and became eligible to participate in the Plan.

Effective January 1, 2024, former employees of St. Pierre Groupe, LLC were hired as associates of the Company. Prior to January 1, 2024, these employees had the option of participation in the St. Pierre Groupe 401(k) Plan (Pierre Groupe). Each employee who was a participant in the Pierre Groupe Plan as of December 31, 2023, became eligible to participate in the Plan effective January 1, 2024. Participant accounts were transferred from the Pierre Groupe Plan to the Plan on August 28, 2024. The transfer amount is reflected in net transfers to affiliated plans (See Note 10).

The administration of the Plan is overseen by Bimbo Bakeries USA Benefits Committee (the Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan participates in the Bimbo Bakeries USA Defined Contribution Savings Plan Master Trust (Master Trust).

Contributions

Each plan year, participants may contribute from 1% up to 75% of their pre-tax annual compensation, as defined by the Plan. Participants may also elect to contribute a percentage of their after-tax annual compensation as Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment choices daily and their deferral percentages upon notification to the plan administrator.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled at 6% in the Plan unless they affirmatively elect not to participate in the Plan. Each January 1, all eligible employees who have made an affirmative election to have their salary deferred in an amount less than 6% of their compensation, shall be deemed to have elected to increase their salary deferral to 6%, unless the participant elects not to participate in this plan feature.

The Plan includes an auto-increase provision whereby each plan year following the employee's initial enrollment, the participant shall be deemed to have made an annual election to increase their deferral by an additional 1%, up to a maximum of 10%. Automatically enrolled participants may a) elect not to participate in the auto-escalation provision or b) elect to have an automatic annual increase of between 1% and 6% applied to their deferral rate each year. Automatic annual increases are effective July 1 of each year.

The Company matches 100% up to the first 6% of the participants' contributions. In addition, the Company shall contribute for certain qualifying employees a transition credit, which is based on each participant's points. The points are calculated based on the employee's age and periods of service and will entitle certain individuals to the transition credit ranging from 1% to 6% of the participant's compensation. The Company shall contribute for certain eligible Earthgrains participants a transition contribution equal to 2% of each participant's compensation.

There is an option for the Company to provide an additional discretionary contribution to the employees. However, for 2024 and 2023, the discretionary contribution was not made by the Company.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of Plan, Continued

Vesting

Participants are vested immediately in their contributions and the transition contribution portion of their accounts, plus actual earnings thereon. Vesting in the Company's matching contribution and discretionary contribution portion of their accounts, if any, is based on years of continuous service. Participants become 100% vested in their Company matching and discretionary contributions after two years of service. Participants become 100% vested in certain transition contributions upon five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balances in the participants accounts and bear interest at rates that range from 4.25% to 9.50%, based on the prime rate as reported by Reuters on the last day of the month prior to loan issuance, plus 1% at December 31, 2024. A participant may only have one general purpose loan outstanding at a time, except for a former Sara Lee participant, who transferred into the Plan on January 1, 2015, who may have up to two general purpose loans outstanding. The maximum loan term is five years, or fifteen years if the loan is used to purchase a primary residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service or due to death, disability, or retirement, participants may elect to receive lump sum amounts equal to the vested portion of their account. Effective December 31, 2019, terminated participants may elect to receive partial distributions in any amount. Certain participants may elect to receive their benefit in quarterly or annual installments over a period no greater than ten years. Amounts may not be withdrawn from the Plan while a participant is an active employee of the Company, except in cases of hardship, permanent disability, or after age 59 ½, as defined in the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,013,677 and \$1,383,839, respectively. These accounts will be used to reduce future employer contributions or to pay reasonable expenses of the Plan. Employer contributions were reduced by \$1,386,229 and \$1,321,892 from forfeited nonvested accounts to fund the 2023 and 2022 plan year's true-up employer contribution, respectively. The employer true-up contribution pertaining to 2024, in the amount of \$1,146,465, was fully funded from the forfeiture account in March of 2025. These true-up contributions were made to make certain participants whole for employer matching contributions due to them.

During 2024 and 2023, there were no administrative fee reductions from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan retains an interest in the Master Trust which holds investments in various funds (see Note 5). Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Bimbo Bakeries USA Benefits Investment Subcommittee determines the Plan's valuation policies utilizing information provided by the investment advisors and plan trustee. See Note 4 for discussion of fair value measurements.

The Plan holds investments in unallocated insurance contracts which carried over as an investment option from a previous plan. These insurance contracts are held by an insurance company and are valued at their cash surrender value in the accompanying financial statements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are treated as distributions based upon the terms of the plan document.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in the Plan's interest in Master Trust investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

(3) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from the information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Plan's interest in the Master Trust: See Note 5.

The life insurance contracts are presented at the cash surrender value and not fair value; hence, they are excluded from the scope of FASB ASC 820.

(5) Interest in the Master Trust

The Plan's investments are in the Master Trust which was established for the investment of assets of the Plan and other retirement plans sponsored by the Company. Each participating retirement plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by Fidelity.

The value of the Plan's interest in the Master Trust is based on the beginning of the year value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. At both December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust is approximately 89%. The investments in the Master Trust are allocated to the individual plan based upon the individual participant balances of those participants that are included in each respective plan.

Fidelity has certified to the accuracy and completeness of the investment in the net assets of the Master Trust as of December 31, 2024 and 2023, and the investment income for the years then ended as summarized below.

Following is a description of the valuation methodologies used for assets of the Master Trust at fair value.

Registered investment companies and money market account: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Common collective trust – fixed income: Invests in conventional and synthetic guaranteed investment contracts issued by insurance companies and banks with excess cash invested in cash equivalents. The common collective fund allows for earnings stability regardless of the volatility of the financial markets. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Common collective trusts – other: Valued at the NAV of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Pooled separate account: Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(6) Related Party Transactions and Party-In-Interest Transactions

Plan investments are investments in the Master Trust managed by Fidelity, the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transactions rules. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. Fees incurred by the Plan for the investment management services are included in the Plan's interest in Master Trust investment income. Other fees paid by the Plan to Fidelity for administrative expenses amounted to \$429,020 and \$442,800 for the years ended December 31, 2024 and 2023, respectively. The Company pays directly certain other fees related to the Plan's operations.

(7) Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(8) Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 17, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the letter, the Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan, through its interest in the Master Trust, invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(10) Transfers (to) from Affiliated Plans

During 2024 and 2023, transfers of net assets to the Plan from the Bimbo Bakeries USA Union Savings Plan (Union Plan) amounted to \$255,278 and \$676,264, respectively. Transfers of net assets from the Plan to the Union Plan amounted to \$1,013,767 and \$1,014,310 during 2024 and 2023, respectively.

On August 28, 2024, in accordance with the amendment described in Note 1, transfers of net assets to the Plan from the Pierre Groupe Plan amounted to \$147,316.
