## Notes to Financial Statements

### Note 1. Description of Plan

The following description of the American Roller Company Retirement Plan (Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering the employees of American Roller Company, LLC (Company), a wholly-owned subsidiary of American Roller Holdings Company, LLC (Parent), with the exception of union employees, non-resident aliens, and leased employees. The Plan also covers other subsidiaries of the Parent. All employees must complete 60 days of service to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Mergers:** Recent business acquisitions made by the Parent organization have merged retirement plans into the Plan.

#### Polyurethane Engineering Techniques Company, Inc.

On October 13, 2023, the Parent acquired Polyurethane Engineering Techniques Company, Inc. (PETCO), and its employees became employees of the Company.

- Effective June 3, 2024, PETCO employees received credit for their prior service.
- On July 9, 2024, assets from the PETCO Corporation 401(k) Savings Plan totaling \$2,082,913 were merged into the Plan (\$2,050,110 of investments, and \$32,813 of notes receivable to participants [participant loans]).

The following PETCO 401(k) Plan provisions were retained as protected benefits:

- Company contributions are subject to a 5-year graded vesting schedule: 1 year-20%; 2 years-40%; 3 years-60%; 4 years-80%; 5 years-100%.
- Company contributions can be withdrawn as in-service distributions upon attainment of age 59½.

#### Schaefer Rolls, Inc.

On May 24, 2024, the Parent acquired the assets of Schaefer Rolls' Covington, Virginia facility. As part of the acquisition, the employees at that location became employees of the Company.

- Effective July 1, 2024, Schaefer Rolls, Inc. employees received credit for their prior service.

#### A-Korn Rolls, Inc.

On August 19, 2024, the Parent acquired A-Korn Rolls, Inc., and its employees became employees of the Company.

- Effective August 19, 2024, A-Korn Rolls, Inc. employees received credit for their prior service.

## Notes to Financial Statements

### Note 1. Description of Plan (cont.)

**Contributions:** Each year, participants may make pre-tax and Roth contributions which are subject to certain limits defined by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make discretionary matching and/or non-elective contributions. For the year ended December 31, 2024, the Company matching contribution was equal to 50% of the first 6% of eligible compensation that a participant contributed to the Plan. There were no non-elective contributions for the year ended December 31, 2024.

Participants direct the investment of both employee and Company contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, collective trust funds, and a self-directed brokerage account as investment options for participants.

**Participant Accounts:** Each participant's account is credited with the participant's contributions, the Company contributions, Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant vests over a modified vesting schedule: 1 year-20%; 2 years-40%; 3 years-60%; 4 years-80%; 5 years-100%.

A participant will become fully vested upon retirement, death or total and permanent disability.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates equal to the prime rate plus 1% at the time the loan is initiated. Principal and interest is paid ratably through payroll deductions.

## Notes to Financial Statements

### Note 1. Description of Plan (cont.)

**Payment of Benefits:** On termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum amount, installment payments or partial withdrawals equal to the value of the participant's vested interest in his or her account. Alternatively, a participant can elect to receive their distribution in the form of an annuity. In addition, in-service withdrawals are allowed after participants reach age 59 ½ or in cases of financial hardship.

The Plan has the ability to make automatic distributions without participant consent for terminated participants that fail to affirmatively elect a distribution and have a vested account balance under \$5,000.

**Forfeited Accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$93,904 and \$62,088 respectively. These accounts will be used to pay Plan expenses or to reduce future Company contributions. No forfeited nonvested accounts were used to reduce expenses or contributions in 2024.

**Plan Expense Account:** Excess amounts generated by revenue-sharing agreements between the record keeper and the various mutual funds the Plan invests in are deposited by the record keeper in an account that can be utilized to pay allowable plan expenses. At December 31, 2024 and 2023, the balance in this account totaled \$8,145 and \$6,968, respectively. During 2024, Plan expenses of \$29,016 were paid from the plan expense account.

### Note 2. Summary of Accounting Policies

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Note 2. Summary of Accounting Policies (cont.)

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Plan pays investment advisory fees, and fees related to withdrawals and the administration of notes receivable from participants are charged directly to the participant's account; all are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of investments.

**Subsequent Events:** The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were issued.

### Note 3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

### Note 3. Fair Value Measurement (cont.)

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at the NAV of the units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

*Participant self-directed accounts:* The self-directed brokerage accounts consist of common stock, mutual funds and money market funds, which are stated at fair value, based on quoted market prices.

### **Note 5. Related-Party Transactions and Party in Interest Transactions**

Transamerica Retirement Solutions provides recordkeeping services to the Plan. These transactions qualify as exempt party-in-interest transactions. Administrative expenses of \$56,922 were paid to Transamerica Retirement Solutions for the year ended December 31, 2024.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### **Note 7. Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
