## INDEPENDENT AUDITOR'S REPORT

To the Trustee and Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Argonaut Food Partners, LLC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Argonaut Food Partners, LLC Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

NOTES TO FINANCIAL STATEMENTS

**1. Plan Description**

The following description of Argonaut Food Partners, LLC Retirement Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 1, 2020 as a 401(k) defined contribution plan covering all employees of Argonaut Food Partners, LLC and participating affiliates (collectively, the Employer). Employees are eligible to participate in the Plan upon the attainment of age 21 and at least 1,000 hours of service in a consecutive 12-month period. Eligible participants may enter the Plan on January 1 and July 1 of each Plan year. Employees whose wages are subject to a collective bargaining agreement, leased employees, and non-resident aliens are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's most recent restatement was effective January 1, 2021.

**Contributions**

Each year, participants may contribute pre-tax and post-tax compensation up to the limits provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year are eligible to make additional "catch-up" contributions. Effective January 1, 2020, the Plan automatically enrolls participants into the Plan with a 6 percent deferral rate, increasing annually on January 1 of each year by 1 percent up to 10 percent. Participants may also contribute amounts representing rollover distributions from other qualified plans.

The Plan may also make discretionary Employer matching contributions or discretionary profit sharing. Eligible participants who are employed on the last day of the Plan year receive an allocation of employer contributions. There was no Employer matching contribution for the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, the Employer made no such discretionary profit share contributions.

**Participant Accounts**

The account of each participant is credited with the participant's contribution and Plan earnings. Each participant's account is charged with any fees or expenses related to individual investment options and fees associated with loan processing. Allocations of Plan earnings are based on individual participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

The Plan's investments are held in trust funds administered by the custodians of the Plan, Empower Annuity Insurance Company of America and Empower Trust Company, LLC (previously Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC, respectively). Upon enrollment in the Plan, a participant may direct the investment of their account into any investment option provided by the Plan. Participants may change investment options at any time.

**1. Plan Description, continued**

**Payments of Benefits**

On termination of service due to death, disability, or retirement, a participant or their designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, a partial withdrawal, direct rollover to an eligible retirement plan, or annual installments over periods defined by the Plan. On termination of service other than due to death, disability, or retirement, a participant may elect a lump-sum distribution.

**Hardship Distributions**

The Plan provides for hardship withdrawals in the event of an immediate and heavy financial need in an amount not to exceed the lesser of the participant's fully vested account balance, excluding earnings or the amount of the financial need.

**Notes Receivable from Participants**

The Plan does not permit participants to take a loan from their account.

**Vesting**

Participants are immediately vested in their deferral and rollover contributions. Employer contributions are subject to a vesting schedule based on years of service. The remainder of their accounts are 100 percent cliff-vested after three years of service. The portion of an individual's account that is not vested at the time an employee terminates their employment is forfeited.

**Forfeitures**

The non-vested account of a participant will be forfeited if a participant is terminated. Non-vested accounts forfeited during the years ended December 31, 2024 and 2023 totaled \$5,468 and \$5,780, respectively. Forfeited accounts can be used to reduce employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$36,509 and \$30,535, respectively. No forfeitures were used to reduce Employer contributions or pay Plan administrative expenses.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**2. Summary of Significant Accounting Policies, continued**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Expenses of maintaining the Plan, including third party administration and audit fees, are paid by the Employer and are therefore excluded from these financial statements. Certain administrative expenses may be paid from participant accounts at the Employer's election. Investment related expenses are included in net change in fair value of investments.

**Revenue Sharing**

The plan contains a revenue sharing expense offset arrangement where the Plan is credited a fixed monthly amount which is used to pay investment advisory expenses. For the years ended December 31, 2024 and 2023, \$19,215 and \$12,526, respectively, was credited to the account and used to pay investment advisory expenses.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

**3. Information Certified by the Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations of Reporting and Disclosure under ERISA. Accordingly, the custodians of the Plan have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate as of and for the years ended December 31, 2024 and 2023. For the year ended December 31, 2024 and 2023, the custodians were Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

**4. Plan Termination**

Although it has not been expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Company contributions.

**5. Related Party and Party-in-Interest Transactions**

Certain Plan investments are maintained and managed by Empower Insurance Annuity Company (formerly Great-West), an affiliate of the custodian. Empower is the fiduciary and the custodian of the Plan. Fees paid to Empower were \$43,940 and \$31,068 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**6. Tax Status**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by The Retirement Advantage, Inc. The Internal Revenue Service has determined and informed the prototype sponsor by a favorable opinion letter dated June 30, 2020 that the prototype plan is designed in accordance with the applicable section of the Internal Revenue Code. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

## 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## 8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and have a readily determinable fair value.

**8. Fair Value Measurements**, continued

*Insurance contracts* - Contracts held by the Plan are not considered fully benefit-responsive at the Plan level and are stated at fair value, which is based on contract value. Contract value is increased by contributions and earnings on the contracts, and reduced by participant withdrawals and administrative expenses. Fair value is assessed based on analysis of interest rates, maturities, discounted cash flows, and other observable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**9. Non-Exempt Transactions**

For the years ended December 31, 2024 and 2023, participant contributions totaling \$15,027 and \$117,130, respectively, were not remitted to the Plan within the appropriate time period by the Employers. These transactions constitute prohibited transactions as defined by ERISA. The Employers are taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest, and have further implemented a procedure to ensure that all future remittances are made within the prescribed time period. The 2023 delinquent contributions that were fully corrected in 2024 were \$110,738 and the 2024 delinquent contributions that were fully corrected in 2025 were \$14,961. It is the Employers' intention to correct the remaining \$6,458 with lost earnings as soon as possible.
