## Independent Auditor's Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2021 Financial Statements***

We have performed audits of the financial statements of Iowa Tribe of Kansas and Nebraska Employee Savings Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2021, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS

December 31, 2021 and 2020

### Note 1: Description of the Plan

The following description of the Iowa Tribe of Kansas and Nebraska Employee Savings Trust (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan, established January 1, 2008, is a defined contribution plan. An employee becomes eligible to enroll in the Plan as soon as administratively feasible following attainment of one-year of service upon which 1,000 hours was worked. Employees eligible for deferrals are also eligible for company contributions. The Plan allows deferrals of 1% to 100% of compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and later amendments.

#### Participant Contributions

Participating employees may elect to defer up to 100% of their annual compensation subject to limitations in the IRC, as defined in the Plan document, to the Plan on a tax-deferred basis or in a Roth 401(k). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments through Capital Group (the Custodian) to Plan participants as core investment options.

#### Employer Contributions

The Iowa Tribe of Kansas and Nebraska (the Company) may make a matching contribution equal to a uniform percentage of the employee's salary deferral, which percentage is determined annually at the discretion of the Plan Sponsor. For 2021 and 2020, the Company matched 100% of employee deferrals up to 3% of the participants compensation.

#### Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the Company's matching contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are 100% vested in their deferrals. Participants are fully vested after two years of service in the Company match plus actual earnings. An employee who becomes disabled, dies, or reaches age 65 will be vested 100% in employer contributions.

#### Payment of Benefits

A participant, or designated beneficiary, is entitled to receive a distribution of his/her interest in the Plan when any one of the following events occurs:

1. termination of employment for any reason;
2. death;
3. total and permanent disability;
4. retirement;
5. attainment of age 59 1/2; or
6. financial hardship.

If one of the above events occurs, the current value of the participant's accounts is to be paid in one lump sum if the account is less than \$5,000. If the account exceeds \$5,000, benefit payments are determined at the option of the participant. Such methods vary from lump-sum distributions to installment payments spread over a specified period.

**Participant Loans**

Under the terms of the Plan, loans are not permitted.

**Forfeitures**

As outlined in the Plan, forfeitures of employer match and profit sharing contributions due to the non-vested portion may be used for any permissible purpose such as to pay Plan expenses or reduce employer contributions. Amounts forfeited during the years ended December 31, 2021 and 2020 were \$0 and \$0, respectively. During 2021, \$0 of forfeitures were used. The amount of forfeitures remaining in the account as of December 31, 2021 and 2020 were \$0 and \$0, respectively.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2021 and 2020, the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

**Investment Valuation and Income Recognition**

The Plan's investments are presented as determined and certified by Capital Group (the Custodian) as of the Plan's year end. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants accounts are charged directly to the participants account. Other expenses are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

**Note 2: Summary of Significant Accounting Policies (Continued)**

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy, gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Note 3: Fair Value Measurements (Continued)**

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2021 and 2020. Following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds and Money Market Funds**

Mutual funds and money market funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 4: Related Parties and Party-In-Interest**

The Company absorbs some administrative expenses of the Plan, the cost of audit fees related to the Plan and the cost of fidelity bonds. The Company provides administrative services on behalf of the Plan. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements. Also, certain Plan investments are shares of proprietary funds managed by the Custodian. These transactions qualify as exempt party-in-interest transactions.

Additional party-in-interest transactions include audit fees to Varney & Associates, CPAs, LLC, Packerland Brokerage for third party administration, and Capital Group for investment and recordkeeping services.

**Note 5: Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 6: Tax Status**

The Plan Sponsor has adopted a prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2018.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8: Information Prepared and Certified by Custodian (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2021 and 2020, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Capital Bank and Trust Company, the Custodian.

**Note 9: Subsequent Events**

Management has evaluated subsequent events through January 22, 2024, the date on which the financial statements were available to be issued.
