Note 1. Description of Plan

The following description of the Orthopaedics Northeast, P.C. Profit Sharing Plan and Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document, which legally governs the operations of the Plan for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers eligible employees of Orthopaedics Northeast, P.C. (the "Company"). There are no age or service requirements to be eligible to participate. An employee of the Company is eligible to enroll immediately in the Plan upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA").

Participant Contributions

Participants may make pre-tax and/or after-tax contributions at a rate of up to 100% of compensation up to a maximum annual amount as determined and adjusted annually by the Internal Revenue Service ("IRS").

Automatic Enrollment

At the time of automatic enrollment, each employee has a beginning contribution rate of 1%. The rate is increased by 1% every December 1st up to 6%. An employee can elect not to participate in the Plan or select his or her own contribution percentage.

Company Contributions

The Company provides a discretionary matching contribution equal to 50% of the first 6% of each participant's contribution. There are no eligibility requirements for the Company matching contribution. The Company also reserves the right to make discretionary profit sharing contributions. To participate in the discretionary profit sharing contribution, a participant must have completed twelve months of service, attained age twenty-one and must be employed on the last day of the Plan year. For the year ended December 31, 2024, the profit sharing contribution was \$1,947,857.

Investment Options

Participants may invest their accounts in (1) whole percentages in various nationally recognized mutual funds or (2) in any of five portfolio choices which range from very conservative to very aggressive, which are invested in the aforementioned mutual funds. These funds differ in potential investment return and risk and may be changed by the Company. In addition, the Plan offers a self-directed brokerage choice through Ameritrade Corporate Services, a division of Ameritrade, Inc. All amounts in participant accounts are participant-directed.

Note 1. Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings, and is charged with an allocation of administrative expenses. Allocations of the earnings and administrative expenses are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in salary deferral contributions. Vesting in Company contributions is based on years of service. A participant becomes 20% vested after two years of credited service. Vesting percentages increase 20% each year thereafter with 100% vesting after six years of credited service. Additionally, participants are 100% vested in Company contributions upon termination for death, disability or retirement.

Forfeitures

If a participant terminates employment before being fully vested, a portion of the Company contributions will be forfeited. Forfeited nonvested amounts are used to reduce future Company contributions. There were no forfeited nonvested accounts at December 31, 2024 and 2023. During the year ended December 31, 2024, forfeitures were used to reduce Company contributions by approximately \$113,000.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant may elect, subject to certain conditions, to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, a participant may elect to rollover funds in cash or property. Hardship distributions are also available.

Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right, in accordance with the Plan, to discontinue contributions at any time and terminate participation in the Plan. In the event of termination of the Plan, all amounts allocated to participants' accounts shall become vested.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

The Plan holds an investment in a collective trust that is considered to be a fully benefit-responsive investment. Fully benefit-responsive investments held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investments because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. However, these funds qualify for measuring fair value using the net asset value (NAV) practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefit payments to participants are recorded when paid.

Expenses

All expenses of maintaining the Plan are paid by the Company. Investment related expenses are included in net realized and unrealized appreciation in fair value of investments.

Expense Offset Arrangement

Investment fee rebates are recorded as other income and the expenses paid with the rebates are recorded as administrative fees.

Subsequent Events

The Plan Administrator has evaluated events and transactions for possible recognition or disclosure through October 2, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Ascensus Trust Company, the Trustee, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. All investments shown in the accompanying statements of net assets available for benefits.
- b. Net investment income from the investments, as shown in the accompanying statement of changes in net assets available for benefits, including dividends and interest income and net realized and unrealized appreciation in fair value of investments.
- c. The supplemental schedule of assets (held at end of year).

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.

Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Note 4. Fair Value Measurements (Continued)

Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective trust: Valued at the net asset value ("NAV") provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

Mutual funds: Valued at quoted market prices, which represent the net asset values ("NAV") of shares held by the Plan at year end.

Self-directed brokerage accounts: Accounts primarily consist of money market funds, mutual funds and common and preferred stocks that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Transactions with Parties-In-Interest

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for legal, accounting and other services are rendered by parties-in-interest and are paid by the Company.

Note 7. Income Tax Status

The Plan is a prototype plan which received a favorable opinion letter from the IRS dated June 30, 2020, stating that it is a qualified plan under Section 401(a) of the Internal Revenue Code (IRC). Although the prototype was amended to the Plan sponsor's specifications, the Plan Administrator believes the changes were minor and that the Plan is being operated in compliance with the applicable requirements of the IRC.

Note 7. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
