SUMMARY OF PLAN PROVISIONS

Effective Date: January 1, 2014.

Plan Year: January 1 to December 31.

Participation: An eligible employee shall participate on the January 1 or July 1 following attainment of age 20 and 1 year of service. Prior to 1/1/16 you needed to have attained age 21.

Year of Service for Vesting and Eligibility: 1000 hours of service during a plan year.

Year of Service for Benefit Computation: 1000 hours of service during a plan year.

Compensation: Form W-2 compensation that is actually paid in gross income during a plan year while a participant. If a participant enters plan mid-year, their entire compensation for that plan year is used.

Eligible Employee: An employee of the employer with the exclusion of union-employees, leased employees, and non-resident aliens.

Normal Retirement Date: First of the month coincident with or next following the participant's 65th birthday, or 5 years of participation if later.

Early Retirement Date: The plan does not provide for retirement prior to the normal retirement date.

Normal Form of Benefit: Life annuity payable monthly for single employees or actuarially equivalent qualified joint and 50% survivor annuity payable monthly for married employees.

Accrued Benefit: Actuarial equivalent, using non lump sum assumptions, of participant's cash balance account at determination date projected with interest credits to Normal Retirement.

Vesting: Shall be 100% vested with 3 or more years of vesting service. Shall also become 100% vested at death, disability, or attainment of your Normal Retirement age, while active.

Pre-Retirement Death Benefit: The participant's accrued benefit.

Principal Credits: 38% of compensation for owner, 30% of compensation for spouse of the owner, 3% of compensation for other employees that are not highly compensated employees and 0% of compensation for children of the owner and highly compensated employees other than the owner, his spouse and children. Only participants that work at least 1,000 hours during a plan year shall receive principal credits. For 2023, Eom receives 4.00% of compensation, Nesbitt receives 3.50% of compensation and Prince receives 3.75% of compensation.

Interest Credits: Interest accumulated to prior cash balance account and principal credits. Shall cease accumulating at time participant's full benefits have commenced.

Cash Balance Account: Sum of accumulated principal and interest credits.

Top Heavy: Minimum benefits shall be governed under defined contribution plan.
