INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Young Truck Sales, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Young Truck Sales, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Young Truck Sales, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Young Truck Sales, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit-sharing plan which includes an employees' savings plan established under the provisions of Internal Revenue Code Section 401(k) and covers all employees of Young Truck Sales, Inc. The plan covers employees who have completed thirty days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may make salary deferral contributions, as defined in the Plan.

The Company makes discretionary matching contributions of 100% to eligible participants' deferrals up to 1% of the participant's compensation and 50% of the next 5% of participant deferrals, up to a maximum of 3.5% of participant compensation. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts

Each participant's profit-sharing account is credited with an allocation of (a) the Companies' profit-sharing contribution, (b) Plan earnings and (c) forfeitures of terminated participants' nonvested accounts. Each participant's 401(k) account is credited with an allocation of (a) the participant's salary deferral contribution, (b) the employer matching contribution and (c) Plan earnings. Any forfeitures derived from employer matching contributions can be used to pay plan administrative expenses or reduce employer matching contributions in the current or future plan years. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

Participants' Investment Options

Participants must direct their salary deferral contributions and all matching and profit-sharing contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via direct phone access to Principal Financial, or by accessing Principal Financial online.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in employer discretionary contributions are based on a 6-year graded schedule while vesting in employer matching contributions are based on a 2-year cliff schedule.

Forfeitures

At December 31, 2024, forfeited nonvested accounts totaled \$20,719. Forfeiture amounts totaling \$253 were used to reduce the Plan's administrative expenses.

Forfeitures related to the employer matching portion of the Plan will be used to reduce employer matching contributions. During the year ended December 31, 2024, \$16,903 was used to reduce employer matching contributions.

Participant Loans

Participants may borrow from their retirement accounts a minimum of \$1,000, not to exceed the lesser of \$50,000 or 50% of their vested account balance reduced by any outstanding loan liabilities. Loan transactions are treated as a transfer to (from) the participant's investment funds from (to) the participant notes fund. Loan terms vary and are based on the individual loan agreements. The loans are secured by the balance in the participant's account and bear interest at current prevailing interest rates as defined in the plan agreement. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

In the event of a mandatory distribution greater than \$1,000 that is made in accordance with the provisions of the Plan providing for an automatic distribution to a Participant without the Participant's consent, if the Participant does not elect to have such distribution paid directly to an "eligible retirement plan" specified by the Participant in a direct rollover or to receive the distribution directly, then the Administrator shall pay the distribution in a direct rollover to an individual retirement plan designated by the Administrator.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

Payments of Benefits (Continued)

A participant whose vested account balance exceeds \$5,000 may elect to receive either (1) a lump-sum amount equal to the value of his or her account or (2) installment payments over a specified term or (3) partial withdrawal.

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments in registered investment companies are generally stated at fair value. Investments in general insurance accounts are stated at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions Receivable

Employer profit-sharing contributions, employer matching contributions and participant salary deferral contributions are recorded as additions to net assets available for benefits during the Plan year for which they are due. Rollovers are recorded as additions to net assets when received.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Plan expenses paid by the Company amounted to \$12,400 for the Plan year ended December 31, 2024.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Contracts

The Principal Guaranteed Option is a fully benefit-responsive investment contract. Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions to Principal Trust Company (Principal) under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

There are no unfunded commitments. Under the terms of the contract, the Plan sponsor must provide a minimum of 90 days' notice to Principal prior to redemption of the contract.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

FASB ASC 820, Fair Value Disclosures, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE C - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 Fair Value Measurements

The fair value of registered investment companies is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on quoted market prices.

Level 2 Fair Value Measurements

The fair value of investments in bank and investment house common/collective investment trusts and general insurance accounts for which quoted market price are not available are reported at the value reported to the Plan by those entities. Funds are invested in financial instruments issued by highly rated companies. These include guaranteed investment contracts (GICs), security backed contracts (synthetic GICs) and cash equivalents.

Level 3 Fair Value Measurements

There were no plan investments subject to Level 3 fair value measurements. This category would include investments that are not actively traded, and significant other observable inputs are not available.

NOTE D - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of mutual funds managed by Principal Life Insurance Company. This entity provides investment services, recordkeeping, and administrative support to the Plan and the Plan Administrator for the years ended December 31, 2024 and 2023.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE F - INFORMATION CERTIFIED BY THE PLAN TRUSTEE

Principal Trust Company, the trustee of the Plan, certified the following information included in the 2024 and 2023 financial statements and supplemental schedules:

- Investments, including fair value, contract value, investment transactions, and related information
- Investment income, including net unrealized appreciation (depreciation) in fair value of investments, net realized gains (losses) from sale of securities, and interest and dividend income
- Form 5500, Schedule H, 4(i) – schedule of assets held for investment purposes

NOTE G - TAX STATUS AND INFORMATION REGARDING DETERMINATION LETTER

Effective October 1, 2020, the Plan sponsor adopted a non-standardized form of a volume submitter plan sponsored by Principal Financial Group. The prototype plan has received an opinion letter as to the volume submitter plan's qualified status.

The volume submitter plan opinion letters have been relied upon by this Plan. The Plan Administrator does not plan to submit an application for determination for its adoption of such volume submitter plans. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

NOTE H - RISK AND UNCERTAINTY

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amount reported in the statements of net assets available for benefits.

NOTE I - SUBSEQUENT EVENT

The Plan has evaluated subsequent events through September 19, 2025, the date which the financial statements were available to be issued.
