## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of WiseTech Global (US), Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **Note 1 Description and Purpose of 401(k) Savings Plan**

The inception date of the WiseTech Global (US), Inc. 401(k) Plan (the “Plan”) is March 1, 2004. The Plan is a salary reduction plan allowing participants to reduce their compensation and have these amounts contributed to the plan on their behalf. Individual accounts are maintained for each participant to which all contributions are credited. A participant’s benefit under such plan is based solely on the fair market value of his or her account balance. The purpose of the plan is to account for resources to be used for retirement annuity or lump sum payments of appropriate amounts at times in the future. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. *General.* The Plan is a defined contribution plan covering all employees of the Company. Participants are eligible to participate upon hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. *Contributions.* Each year participants may contribute as much of their pretax annual compensation, defined in the Plan, as they would like up to the maximum allowed under code section 401(k). The maximum allowable contribution per participant for 2024 was \$23,000 except for participants over fifty years of age who are allowed an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. During 2022, the Plan was amended and restated to provide participants the ability to make Roth contributions. The Company makes a discretionary safe harbor matching contribution equal to 100% of the participants' salary deferral that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. Additional contributions including employer matching and profit-sharing contributions can be made at the discretion of the Company. Contributions are subject to certain limitations.
3. *Participant Accounts.* Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings, losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
4. *Investment Options.* Participants direct the investment of their contributions as well as the Company contributions into various investment options offered by the Plan. These investment alternatives and their related market values as of December 31, 2024 are identified in the Schedule of Assets (Held at End of Year).

5. *Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at one percentage point over the prime interest rate. Principal and interest is paid ratably through monthly payroll deductions. If the participant terminates employment, any remaining payments are due immediately. If the participant does not repay the loan, the outstanding balance becomes a taxable event.
6. *Vesting.* Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on four years of continuous service except for safe harbor contributions which are immediately vested.
7. *Payment of Benefits.* On termination of service due to retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or an annuity. On termination of service due to death or disability, a participant becomes 100% vested and may elect to receive either a lump-sum amount or an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
8. *Forfeited Accounts.* Forfeited nonvested accounts are used to reduce future employer contributions. Employer contributions were reduced by \$0 in 2024. The forfeited nonvested accounts totaled \$37,820 and \$7,100 as of December 31, 2024 and 2023, respectively.
9. *Merger.* During 2023, the Board of Directors approved the merger of two separate Plans (Blume Global Inc. and Envase Holdings LLC) into this Plan, effective January 1, 2024. As a result, all investments were transferred into this Plan from the other two Plans. The investments were transferred out in 2023, but did not get transferred into this Plan until 2024; therefore, a receivable has been recorded for this transfer.

**Note 2 Summary of Significant Accounting Policies**

1. *Basis of Accounting.*

The financial statements of the Plan are prepared on the accrual basis of accounting. Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

2. *Use of Estimates.*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. *Investment Valuation and Income Recognition.*

The Plan's investments are reported at fair value, except for fully benefit-responsive investments contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Participant loans are valued at their outstanding balances, which approximate fair value. See Note 4 for discussion of fair value measurements.

Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

4. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

5. *Payment of Benefits.*

Benefits are recorded when paid. A participant who reaches age 59 ½ and who is actively employed by the Company may elect to withdraw all or a portion of the participant's salary deferral contribution account and all or a portion of the participant's employer contribution account if the participant has a 100% vested interest in the account.

6. *Operating Expenses*

Certain expenses of maintaining the Plan, such as audit fees, are paid by the Company and are therefore excluded from these financial statements. Such expenses are not material to the Plan.

**Note 3**     **Asset Certification**

Ameritas Life Insurance Corp. (Ameritas) is the trustee of the Plan and has certified that the assets held by them and managed for the Plan as of December 31, 2024 and 2023 and the related transactions executed for the year ended December 31, 2024 as reflected in the financial statements are complete and accurate.

**Note 4**     **Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The following tables set forth, by level with the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023.

**Note 5 Guaranteed Investment Contract with Insurance Company**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Ameritas. Ameritas maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is obligated to repay the principal and a specified interest rate that is guaranteed by the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Ameritas, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The fair value of the investment contract at December 31, 2024 and 2023 was \$1,037,307 and \$996,346, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. The average yield for the Plan during 2024 and 2023 was 3.54% and 2.67%, respectively. Such interest rates are reviewed on a quarterly basis for resetting. The corresponding contract value of the investment contract at December 31, 2024 and 2023, was \$1,040,611 and \$998,427, respectively.

Certain events limit the Plan's ability to transact at contract value with Ameritas. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6**    **Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Ameritas. Ameritas is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**Note 7**    **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 8**    **Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 9 Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**Note 10 Subsequent Events**

Management has evaluated subsequent events through September 26, 2025, the date which the financial statements were available to be issued.
