Basis for Opinion

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. 1. Description of the Plan

The following description of Canusa Hershman Recycling 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. Effective January 1, 2025, the Plan changed its name to Canusa Hershman 401(k) Plan and amended certain plan provisions including eligibility and loans.

General

The Plan is a defined contribution plan covering all eligible employees of Canusa Hershman Recycling, LLC. and Subsidiaries (the “Company” or “Employer”) who have reached the age of twenty-one and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective January 1, 2025, service requirement for eligibility was amended to two months of service.

During 2024, assets totaling \$6,074,025 from Hershman Capital Corp. and \$1,673,756 from Evergreen Fibres, Inc. were transferred into the Plan.

Fidelity Management Trust Company (“Fidelity”) and Reliance Trust Company (“RTC”) are referred to collectively as the Trustee. Fidelity was the Plan’s trustee as of December 31, 2023 and through December 9, 2024. Effective December 10, 2024, RTC is the Plan’s trustee. Effective January 1, 2025, Transamerica Retirement Solutions became the Plan’s recordkeeper.

Contributions

Participants may contribute up to 90% of their eligible annual compensation, as defined in the Plan documents, up to a maximum allowed by the Internal Revenue Code (“IRC”) and may designate such contributions as pre-tax or after-tax (Roth) contributions. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless affirmatively elect not to participate, with a default rate of 6% of eligible compensation. Additionally, the Plan includes an auto increase provision, whereby all active participant’s rates are increase by 1% up to 10%, unless affirmatively elected not to increase. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions to the Plan as defined under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has a discretionary matching program for participants of the Plan. The matching program provides for a 50% match of employee contributions up to a maximum of 6% of the employee’s eligible compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution (b) Plan earnings (losses) and (c) administrative expenses. Allocations are based on a participant’s earnings, account balances, or specific participant transactions, as defined in the plan document.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of service as follows:

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions to any of the various investment options available under the Plan. Participants may change their investment options at their discretion.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. The Plan permits that up to two loans may be taken at one time. Loan terms range from one to five years. Loans used to acquire a principal residence may be repaid over a reasonable period of time, which may exceed five years or up to thirty years. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions. Effective January 1, 2025, the Plan was amended to permit participants to take one loan at a time.

Payment of Benefits

Upon retirement, disability, death or termination of employment, a participant shall become entitled to the value of his or her vested account determined as of the valuation date. The Plan also provides for in-service withdrawals by qualified individuals. Distributions will be paid by a lump sum. Participants may withdraw funds from their accounts who have demonstrated hardship (as defined under Internal Revenue Service Regulations).

Upon reaching age 59½, participants may elect distributions from their accounts without any tax penalty in accordance with the Internal Revenue Code.

Forfeited Accounts

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and may be used to pay administrative expenses or to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,794 and \$0. During the year ended December 31, 2024, \$45,964 of forfeited nonvested accounts were used to reduce employer contributions. During the year ended December 31, 2024, no administrative expenses were reduced from forfeited nonvested accounts

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan's investments, that were valued at fair value (mutual funds), were valued using level 1 inputs.

Investment Valuation and Income Recognition

All investments of the Plan are stated at fair value except for the insurance company general account, which is stated at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price.

The insurance company general account is reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Investment Valuation and Income Recognition (continued)

The Plan's self-directed brokerage account, primarily consisting of common stock and cash and is valued at fair value based on the quoted values of underlying shares held within the account. There are no restrictions as to redemption of investments nor does the Plan have any contractual obligation to further invest in this account. During 2024, this account was closed.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses incident to the operation of the Plan are paid by the Plan. Certain other costs for administering the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. The primary expenses paid by the Plan relate to recordkeeping, third-party administration, and trust services.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 26, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H Part IV, Line4(i) - Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, qualified institutions.

4. Insurance Company General Account

The Plan invests in the Transamerica Stable Value Ascend Option, which is designed to provide maximum return consistent with the preservation of principal. The investment credits all deposits with a uniform interest rate, set semi-annually and applied on a daily basis. The investment has no stated maturity.

The investment is backed by the general account of Transamerica Life Insurance Company ("TLIC"), and both principal and interest are guaranteed subject to the claims-paying ability of TLIC. The Fund is not insured by the FDIC or any other government agency and is not guaranteed by a bank. Contract charges may reduce credited returns. Under certain circumstances, TLIC may impose withdrawal restrictions, including a hold of up to 270 days or, in limited cases, a delay of up to 12 months at the plan level.

Because the Account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account.

The Account represent approximately 1% of the Plan's net assets available for benefits at December 31, 2024 . The credit risk of TLIC was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company (A), Standard & Poor's (A+), and Moody's Investor Services (A1).

5. Tax Status

The Internal Revenue Service ("IRS) has determined and informed the prototype document preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Code. The Plan has been amended since the letter was issued by the IRS, however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company may at any time terminate the Plan and discontinue all contributions, subject to the applicable provisions of ERISA. In the event the Plan is terminated, all participants shall become fully vested in their account balances.

7. Party-in-Interest Transactions

The Plan's insurance company general account is managed by TLIC, which is an affiliate of Transamerica Retirement Solutions, LLC ("TRS"), the Plan's recordkeeper. As TRS provided recordkeeping and other administrative services to the Plan, both TRS and TLIC are considered parties-in-interest, as defined by ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Risks and Uncertainties

The Plan invest in various investment securities that, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
