### **Independent Auditors' Report**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of Crisafulli Bros. Plumbing & Heating Contractors, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1: Description Of Plan**

The following description of Crisafulli Bros. Plumbing & Heating Contractors, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan that was established to provide retirement benefits for employees of Crisafulli Bros. Plumbing & Heating Contractors, Inc. (the Company). Eligible employees become participants in the Plan by completing a 90 day period of service and attainment of age 21, as defined in the Plan Agreement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute a percentage of annual compensation, as defined in the Plan, subject to Internal Revenue Code limitations. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants have the option of making after tax Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching and profit sharing contributions as determined each plan year. The Company made an employer matching contribution of fifty percent of the employee contributions up to a maximum of six percent for the years ending December 31, 2024 and 2023. Contributions are subject to certain limitations.

Participants' accounts - Each participants' account is credited or charged, as applicable, with the participant's contribution and allocations of the Company's contribution, if any, plan earnings (losses), payments, forfeitures, withdrawals, expenses, or transfers and distributions made to or from such accounts during the year. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon and any rollover contributions. A participant's vested interest in employer contributions is based on years of continuing service. A year of vesting service is a plan year in which an individual is credited with at least 1,000 hours of service. As defined by the Plan Agreement, a participant is 100% vested after six years of credited service.

Payment of benefits - On termination of service or separation of service, due to death, disability, or retirement, a participant or their beneficiary will be entitled to receive a distribution of their total vested account balance. Benefits will be paid in accordance with the terms of the Plan.

**Note 1: Description Of Plan (Continued)**

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and are made in accordance with the terms of the Plan. Principal and interest are paid ratably through weekly payroll deductions.

Plan termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, each participants' account will become fully vested and be distributed in accordance with the Plan Agreement.

Forfeited accounts - At December 31, 2024 and 2023, the Plan had forfeitures from terminated, non-vested participant accounts of \$-0-, and \$4,251 respectively. These amounts can be used to offset plan expenses or reduce employer contributions. During the years ended December 31, 2024 and 2023, forfeitures used to reduce employer contributions were \$15,473 and \$16,277, respectively.

**Note 2: Summary Of Significant Accounting Policies**

Investment valuation and income recognition - Accounting principles generally accepted in the United States of America establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The three levels of the fair value hierarchy in accordance with accounting principles generally accepted in the United States of America are described below:

Level 1: Unadjusted quoted prices in active markets for identical, unrestricted assets, or liabilities that the Plan has the ability to access at the measurement date;

Level 2: Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability; and

Level 3: Significant unobservable prices or inputs (including the Plan's own assumptions in determining the fair value of investments) where there is little or no market activity for the asset or liability at the measurement date.

**Note 2: Summary Of Significant Accounting Policies (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments are held by an independent trust company. Interest and dividend income is recorded on the accrual basis of accounting. Purchases and sales of securities are recorded on a trade date basis with the gain or loss based upon the average-cost method.

Notes receivable from participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Income taxes - The Plan is exempt from federal income tax under the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has adopted a volume submitter prototype plan which has an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the date of the financial statements.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and makes changes on a prospective basis when adjustments are necessary.

Presentation - Certain reclassifications, when applicable, are made to the prior year financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on net assets available for benefits or changes in net assets available for benefits.

**Note 3: Investments**

The statements of net assets available for benefits, the investment activities included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the accompanying notes to the financial statements (other than the assignment of levels) were prepared in part or entirely from information certified by Matrix Trust Company, the Custodian, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments of \$4,895,887 at December 31, 2023, and related investment income of \$919,259 for the year ended December 31, 2023. Substantially all plan assets were transferred out of the Plan effective December 31, 2024 (Note 8). The certified investment balance immediately preceding the transfer was \$6,305,901. The certified investment income for the year ended December 31, 2024 was \$697,735.

**Note 4: Fair Value Measurements**

The following is a description of the valuation methodologies used for assets at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued at quoted market prices.

*Money market account:* Valued at a constant dollar per share.

The preceding methods may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

**Note 7: Commitments And Contingencies**

The Plan follows the guidance for uncertainty in income taxes. As of December 31, 2024, the Plan believes that it has appropriate support for the income tax positions taken and to be taken on its returns based on an assessment of many factors including experience and interpretations of tax laws applied to the facts of each matter. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

**Note 8: Plan Merger**

Effective May 26, 2023, Crisafulli Bros. Plumbing & Heating Contractors, Inc. 401(k) Profit Sharing Plan (the Plan) transferred a portion of the assets of this plan to Crisafulli Mechanical LLC 401(k) Profit Sharing Plan. As a result, investments and notes receivable from participants totaling \$3,168,245 were transferred from the Plan into Crisafulli Mechanical LLC 401(k) Profit Sharing Plan on that date.

Effective December 31, 2024, the Plan transferred substantially all of the assets of this plan to Redwood Partners Retirement Plan. As a result, investments and notes receivable from participants totaling \$6,412,608, and employer contribution receivable in the amount of \$177,819, were transferred from the Plan into Redwood Partners Retirement Plan on that date.

**Note 9: Subsequent Events**

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
