Opinion

We have audited the accompanying financial statements of Grand River Rubber and Plastics Company Employee Stock Ownership Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS**

A. DESCRIPTION OF PLAN

The following brief description of the Grand River Rubber and Plastics Company Employee Stock Ownership Plan and Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Grand River Rubber and Plastics Company (the “Company”) established the Grand River Rubber and Plastics Company Employee Stock Ownership Plan and Trust effective as of December 15, 2010. The Plan was amended on May 21, 2013, effective as of December 10, 2013. The Plan was restated on July 24, 2014, effective as of December 10, 2010. The Plan was amended on November 30, 2016, effective as of January 1, 2017. The Plan was amended on December 29, 2021, effective as of January 3, 2022. The Plan operates as a employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Plan’s Board of Trustees comprising of eight persons appointed by the Company’s Board of Directors.

On January 5, 2011, the Plan purchased 21,000 shares (100%) of the Company’s common stock through loan agreements, and subsequent debt swap agreements, with the former shareholders, and holds the common stock in a trust established by the Plan. As part of the transactions, the former shareholders executed debt swap agreements whereas the ESOP notes were swapped with notes from the Company with shorter terms. The borrowings were scheduled to be repaid over a period of ten years by fully deductible Company contributions to the trust fund, but were actually repaid over a period of six years and were fully repaid in 2017. As the Plan made each payment of principle, an appropriate percentage of stock was allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

Participation Requirements

Employees, except excludable classes, of the Company are generally eligible to participate in the Plan after attaining the age of 18 and after one year of service, which is a 12-consecutive month period measured from an employee’s date of hire, in which the employee has completed at least 1,000 hours of service. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last day of the plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions

The Company’s contributions for any Plan year shall not exceed the maximum amount allowable as a deduction to the Company under the provisions on the Internal Revenue Code Section 404.

A. DESCRIPTION OF PLAN (Continued)

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account, forfeitures of terminated participants' non vested accounts, and any stock dividends and other distributions on Company stock. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation (70%), relative to total eligible compensation and on a participant's years of seniority (30%), relative to total years of seniority. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning account balance to all participants' beginning of the year balances.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants hired prior to January 2022 are 100 percent vested after three years of service. Participants hired after January 2022 are vested at twenty percent per year after two years of service.

Payment of Benefits

Distributions on account of death, disability, or retirement are made in the plan year following the event. Distributions for other separations from service commence in the fifth plan year following the separation from service. Participants whose accounts do not exceed \$1,000 will receive a lump sum as soon as administratively practicable. Participants whose accounts are between \$1,000 and \$5,000 can elect to receive a lump sum or may have the balance of their account rolled over into an eligible retirement plan. Participants whose accounts are greater than \$5,000 may receive a lump sum distribution, may have the balance of their account rolled over into an eligible retirement plan, may receive substantially equal annual payments over a period of five years, or may defer their payments until normal retirement age. Distributions will be made in whole and fractional shares of the Company stock, cash, or a combination of both. These shares are subject to a "right of first refusal" which provides that, prior to any subsequent transfer, the shares must be offered for purchase to the Company, and then the Trust, at the then fair market value. During 2024, the Company repurchased no shares from participants.

Forfeitures

Plan forfeitures are allocated to each participant's account based on a participant's eligible compensation (70%), relative to total eligible compensation and on a participant's years of seniority (30%), relative to total years of seniority. Forfeitures of terminated non vested account balances, including cash and the fair market value of shares, allocated to remaining participants at December 31, 2024 and 2023 totaled \$5,715 and \$6,884, respectively.

Voting rights

Generally, all Company stock in the Trust shall be voted by the Trustee. However, to the extent required by Code Sections 401(a)(22) and 409(e)(3) and the regulations thereunder, each participant is entitled to direct the Trustee as to the manner in which shares allocated to his or her account are to be voted. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify can receive a distribution of Company stock or cash, direct the Administrator and the Trustee as to the reinvestment of such Company stock into a self-directed account with at least three diverse investment elections, or direct the Administrator and the Trustee as to the liquidation of such Company stock and the transfer of the proceeds thereof into the Company's 401(k) Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to each such participant or his or her beneficiary at the time prescribed by the Plan terms and Code.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements and supplemental schedules are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The shares of the Company common stock are valued at estimated fair value. See Note E for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Operating Expenses

Expenses of maintaining the Plan can be paid out of trust assets or by the Company. All expenses of maintaining the plan for the years ended December 31, 2024 and 2023 were paid by the Company.

D. FAIR VALUE MEASUREMENTS

ASC Topic 820 provides a definition of fair value which focuses on an exit price rather than an entry price, establishes a framework for measuring fair value which emphasizes that fair value is a market-based measurement, not an entity-specific measurement, and requires expanded disclosures about fair value measurements. In accordance with FASB ASC 820-10, the Plan may use valuation techniques consistent with the market, income, and cost approaches to measure fair value. As a basis for considering market participant assumptions in fair value measurements, ASC Topic 820 establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair values. The hierarchy gives the highest priority to Level I measurements and the lowest priority to Level III measurements. The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level I: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

D. FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Company common stock: The fair value of the Company common stock is determined by an annual independent appraisal. This appraisal was based on a combination of the income and market valuation approaches consistent with prior years. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, merged and acquired company data, and applicable discounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. For those assets with fair value measured using Level III inputs, the Plan Administrator determines the fair value measurement policies and procedures in consultation with the Company's Board of Directors. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The Plan's policy is to recognize transfers into and out of Level III investments as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers into or out of Level III.

E. FAIR VALUE OF FINANCIAL INSTRUMENTS

Financial instruments are defined as cash, evidence of ownership interest in an entity, or a contract which creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. Fair value is defined as the amount at which a financial instrument could be exchanged in a current transaction between willing parties other than in a forced liquidation or sale. If a quoted market price is available for a financial instrument, the estimated fair value would be calculated based upon the market price per trading unit of the instrument.

Investments in Grand River Rubber and Plastics Company common stock would be considered a financial instrument. At December 31, 2024 and 2023, the carrying amount of this financial instrument approximates fair value.

F. PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, the Company absorbed all costs incurred in relation to the administration of the Plan. Such costs include but are not limited to legal and accounting fees. Such costs for the years ended December 31, 2024 and 2023 amounted to approximately \$43,191 and \$41,060, respectively.

The Plan invests in the common stock of the Plan sponsor. Therefore, related transactions qualify as related-party transactions.

G. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 26, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The determination was conditioned upon the adoption of a proposed restated plan that was submitted to the IRS. The Plan was restated on July 24, 2014. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has examined the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken.

H. RISKS AND UNCERTAINTIES

The Plan invests in the Company's common stock. Common stocks are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in the values of these securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 30, 2025, the date on which the financial statements were available to be issued.
