Independent Auditor's Report

To the Plan Administrator
Northwestern University Employee Welfare Benefit Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Northwestern University Employee Welfare Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that audits conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1 - Plan Description

The following description of Northwestern University Employee Welfare Benefit Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established to provide certain taxable and nontaxable welfare and other benefits for eligible personnel and eligible retirees of Northwestern University (the "Plan Sponsor"). While eligibility for certain health and welfare benefits may vary, eligible employees are generally those regular-status staff scheduled to work at least 18.75 hours per week; exempt staff appointed on at least a half-time basis; faculty appointed on a full-time or part-time basis for the entire academic year or on a full-time basis for half the academic year; and postdoctoral fellows, visiting scholars, and visiting personnel (either professor, associate professor, or assistant professor) appointed on at least a half-time basis. Disabled employees receiving short- or long-term disability benefits, employees on leave of absence, and reduced-work calendar staff whose department work schedule is less than the standard 26.1 pay periods per year are also eligible. The Plan is also available to certain retired employees who were eligible to participate in the Plan at the time of retirement and to survivors of these retirees. Continuing coverage is available to terminated employees through the Consolidated Omnibus Budget Reconciliation Act (COBRA) for 18 months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan Sponsor serves as the plan administrator. The Plan's investment was held in a trust fund administered by The Northern Trust Company. The Plan Sponsor stopped using the trust fund in October 2024 and began administering the Plan through the general assets of the Plan Sponsor. Blue Cross Blue Shield of Illinois and Express Scripts are the claims administrators for medical claims, pharmacy claims, and dental claims.

Health and Welfare Benefits

The Plan provides medical, dental, life insurance, long-term disability, and other benefits to eligible active employees and eligible dependents.

Medical

Participants have the choice of a preferred provider organization (PPO) plan with three different tiers or a health maintenance organization (HMO) plan. Both medical plan options have a corresponding prescription drug plan.

Dental

Participants have the choice of a PPO plan or a dental maintenance organization (DMO) plan.

Life Insurance

Participants can elect to receive basic term life insurance of up to 2½ times their annual base salary, up to a maximum coverage amount of \$250,000. Participants may elect to purchase additional supplemental coverage from 1 to 5 times their annual base salary, up to a maximum of \$2,000,000. Participants are also eligible to purchase supplemental life insurance coverage for their spouse and children in increments of \$10,000 and \$5,000, respectively. Maximum coverage for spouse term life insurance is \$500,000, while maximum coverage for child term life insurance is \$25,000 per child.

Note 1 - Plan Description (Continued)

Long-term Disability

All participants receive long-term disability coverage fully paid for by the Plan Sponsor of 50 percent of their monthly salary, up to a maximum monthly benefit of \$11,500. Participants can elect to purchase additional coverage up to 10 percent, for a total of 60 percent of their monthly salary, up to a maximum combined monthly benefit of \$13,800.

Vision

Participants may elect coverage.

Business Travel Insurance

Participants receive business travel insurance coverage, providing benefits if the participant or a covered spouse or child suffers a covered loss while traveling on plan sponsor business.

Employee Assistance Program

Participants are automatically enrolled in an employee assistance program, which provides assistance and resources with life events.

Funding Policies

Medical PPO

The Plan provides for employer and participant contributions, as determined by the Plan Sponsor. The Plan Sponsor estimates the required premiums annually using actuarial calculations. For full-time employees, Northwestern University paid approximately 77 and 74 percent of the total premium cost during 2024 and 2023, respectively. For part-time employees, Northwestern University paid approximately 52 and 50 percent of the total premium cost during 2024 and 2023, respectively. In addition to the deductibles and copayments, pre-65 retiree participants contribute 100 percent of the average actuarially determined cost of providing medical benefits to all plan participants. The Plan's postretirement liability arises because the pre-65 retirees' payment of average cost does not cover the full postretirement plan exposure. Retiree contributions funded approximately 75 percent of total retiree costs for the years ended December 31, 2024 and 2023.

Dental PPO

The Plan provides for employer and participant contributions, as determined by the Plan Sponsor. The Plan Sponsor estimates the required premiums annually using actuarial calculations. For full-time employees, the Plan Sponsor paid 59 percent of the total full-time premium cost during 2024 and 2023. For part-time employees, the Plan Sponsor paid 42 percent of the total part-time premium cost during 2024 and 2023. Retirees pay 100 percent of the active premium cost, with no plan sponsor contribution.

Other Health and Welfare Benefits

The HMO medical benefits; long-term disability benefits; DMO dental benefits; and international health, dental, and vision benefits are funded by both the Plan Sponsor and the participants, with the Plan Sponsor paying the major portion of the program's cost. The Plan Sponsor pays the entire cost of basic term life insurance, business travel insurance, and employee assistance program coverage. Eligible employees may elect to purchase vision coverage and supplemental term life coverage or participate in the flexible spending account program. These benefits are funded solely through employee pretax basis contributions.

Note 1 - Plan Description (Continued)

Flexible Spending Accounts

The flexible spending account program is a medical care reimbursement program under Section 105 of the Internal Revenue Code. Participants may allocate up to an IRS-determined limit each plan year for reimbursement of eligible medical expenses incurred during the plan year and the first 2½ months following the plan year.

The participants must elect to have their compensation reduced by an amount equal to their election for a plan year. Any amounts remaining in a participant's flexible spending account after the allowable reimbursement period will be forfeited.

Party-in-interest Transactions

Certain plan and trust assets were in an investment fund managed by The Northern Trust Company or its affiliates. The Northern Trust Company was the trustee of the Plan's trusts; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

The accompanying financial statements of the Plan have been prepared on an accrual basis in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation

The Plan's investment is stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on this investment.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Pharmacy Rebate Receivable

The Plan Sponsor receives a rebate from Express Scripts on certain eligible prescription claims by plan participants quarterly. A receivable is recorded for such rebates as they are earned. There are rebate receivables of approximately \$4,932,000 and \$5,330,000 as of December 31, 2024 and 2023, respectively. Pharmacy rebates received or receivable of approximately \$9,495,000 and \$4,869,000 for the years ended December 31, 2024 and 2023, respectively, have been netted with pharmacy payments made on behalf of participants.

Claims Paid

Claims are recorded when paid by the Plan.

Stop-loss Coverage

PPO medical benefits exceeding \$500,000 per participant in the self-insured program per calendar year are covered under the provisions of an insurance policy held with Symetra Life Insurance Company. These benefits are paid by the Plan, and the Plan is subsequently reimbursed by Symetra Life Insurance Company. A receivable is recorded for such benefits when paid by the Plan. A stop-loss coverage receivable of approximately \$0 and \$263,000 was recorded as of December 31, 2024 and 2023, respectively. Stop-loss refunds received or receivable of approximately \$59,000 and \$1,653,000 for the years ended December 31, 2024 and 2023, respectively, have been netted with medical/hospital payments made on behalf of participants.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Various administrative expenses are paid by the Plan. Certain administrative expenses were paid by the Plan Sponsor.

Claims Incurred but Not Reported

The Plan's liability for incurred but not reported claims is estimated using payments made subsequent to year end in conjunction with historical claims information. Claims can be submitted for payment up to 12 months following the date of service.

Postemployment Benefit Obligations

A postemployment benefit obligation has been recognized for health and welfare benefits for individuals currently on long-term disability. The postemployment benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to participants in long-term disability status as of the measurement date. Postemployment benefit obligations include future benefits expected to be paid to or for long-term disability participants and their covered dependents after employment but before retirement from service with the Plan Sponsor. The postemployment benefit obligation accrues as of the date of disability and represents the amount that is to be funded by contributions from the Plan Sponsor and from existing plan assets.

The postemployment benefit obligation is determined by an actuary based on the actual number of disabled participants as of the measurement date and results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims cost per participant, to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, withdrawal, or retirement) between the valuation date and the expected date of payment, and to reflect the portion of those costs expected to be borne by the participants and other providers.

For measurement purposes, the annual rate of increase in the per capita cost of covered medical benefits was 7.20 percent and 7.50 percent in 2024 and 2023, respectively. The rate is assumed to decrease gradually to 5.00 percent in 2032 and to remain at that level thereafter. Per capita medical benefit costs for disabled employees were assumed to be \$91,751 and \$74,783 in 2024 and 2023, respectively. Per capita medical benefit costs for spouses ranged from \$17,548 to \$6,045 in 2024 and \$16,323 to \$5,623 in 2023 based on age and provisions elected.

For measurement purposes, the annual rate of increase in the per capita cost of covered dental benefits was 3 percent in 2024 and 2023. Per capita dental benefit costs ranged from \$2,256 to \$648 in 2024 and \$2,196 to \$636 in 2023 based on age and provisions elected.

The following were other significant assumptions used in the valuation as of December 31, 2024 and 2023:

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postemployment benefit obligation.

Note 2 - Summary of Significant Accounting Policies (Continued)

Postretirement Benefit Obligations

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Plan Sponsor. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan Sponsor and participants and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, the annual rate of increase in the per capita cost of covered health care benefits was 7.20 percent and 7.50 percent in 2024 and 2023, respectively. The rate is assumed to decrease gradually to 5.00 percent in 2032 and to remain at that level thereafter. Per capita costs for pre-65 participants ranged from \$29,862 to \$8,759 in 2024 and \$19,406 to \$8,148 in 2023 based on age and provisions elected.

The following were other significant assumptions used in the valuation as of December 31, 2024 and 2023:

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by 1 percentage point, it would increase the obligation by \$505,756 and \$577,875 as of December 31, 2024 and 2023, respectively.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of plan benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The Northern Trust Company held the Plan's investment and executed all investment transactions. The investment balance and related investment income and losses included in the accompanying financial statements and supplemental schedule of reportable transactions for the year ended December 31, 2024 are based solely on information certified by The Northern Trust Company.

Note 4 - Tax Status

The trust established under the Plan to hold the Plan's assets was intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"), and, accordingly, the trust's net investment income was generally exempt from income taxes. The trust had obtained a favorable tax exemption letter from the Internal Revenue Service, and the Plan Sponsor believed that the trust continued to qualify and operated in accordance with applicable provisions of the Code.

Note 5 - Plan Termination

Although it has not taken steps to do so, the Plan Sponsor has the right under the Plan to amend and terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, the Plan Sponsor will contribute the amount necessary to pay its share of the benefits incurred to the date of plan termination.
