- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Other Matter – Auditors’ Report on the 2023 Financial Statements**

Predecessor auditors performed an audit of the 2023 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report, dated October 4, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of the Plan

The following brief description of the Sotheby's, Inc. Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan is a defined contribution plan and was adopted by Sotheby's, Inc. (the Company or Plan administrator) effective December 1, 1985, to provide deferred tax benefits, savings, and Company contributions to eligible employees. The Plan was amended and restated effective January 1, 2017. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Eligibility*

The Plan covers substantially all employees of the Company, except employees covered by a collective bargaining agreement, hourly employees, leased employees and temporary employees, who have reached age 21 and have completed at least 3 consecutive months of service. Employees are permitted to enter the Plan on the first day of each month after the date an employee has otherwise satisfied the eligibility requirements are met. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan.

#### *Contributions*

Participants have the option of contributing an amount between 2% and 6% of their eligible compensation, as defined in the Plan document, to the Plan on a (Basic Contribution). Each Participant who has designated a 6% Basic Contribution may make supplemental contributions not greater than 44% (Supplemental Contribution), for a total contribution of up to 50% of their eligible compensation. Effective January 1, 2018, a Participant who is a Senior Vice President may only make Supplemental Contributions not greater than 19%, for a total contribution of up to 25% of their eligible compensation. Participants aged 50 and older may also elect to make catch-up contributions. All Participant contributions are subject to certain limitations specified by the Internal Revenue Service (IRS).

The Company makes matching contributions equal to 70% of a Participant's Basic Contribution (Employer Matching Contribution) up to 6% of compensation.

Newly hired employees who become eligible to participate in the Plan are automatically enrolled at 3% pre-tax. After a Participant has been enrolled for 12 months, the contribution percentage will increase annually by 1% each April, up to 10% of compensation, unless another option is selected by participant.

Employees may deposit rollover contributions from another qualified plan. Rollover contributions are placed in a separate account and are subject to the rules for investment established in the Plan agreement.

#### *Participant Accounts*

Each Participant's account is credited with the Participant's contributions, rollovers, the Employer Matching Contribution, and earnings (losses) on the investments in their account and is charged with transaction fees for services received by the Participant. Participants direct the investment of their account into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

#### *Vesting*

Participants are fully vested in their contributions, rollovers, and the related earnings (losses) upon entry into the Plan. Employer Matching Contributions vest 40% after completion of two full years of vesting service and 20% per year in each of the subsequent three years and are 100% vested after five years of continuous service.

#### *Investments*

The Plan offers investment options through Vanguard Fiduciary Trust Company (Vanguard), the custodian of the Plan assets. All investment options are 100% Participant directed. Participants can choose from a wide array of investment options.

#### *Payment of Benefits*

Participant accounts may be withdrawn upon retirement, death, disability, or termination of employment. Account balances less than \$1,000 are distributed as a lump-sum payment. Account balances between \$1,000 and \$7,000 are distributed as a lump-sum payment or through a rollover into an individual retirement account. For account balances in excess of \$7,000, the Participant may elect to receive their balance in a single lump-sum payment. The Plan also allows for in-service withdrawals, as well as withdrawals in the event of a financial hardship.

#### *Plan Expenses*

Administrative expenses of the Plan are paid by either the Company or by the Plan, as determined by the Plan administrator. These expenses may include, but are not limited to, legal fees, accounting fees, recordkeeping fees, and other fees for services provided to the Plan.

#### *Notes Receivable from Participants*

A Participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are repayable through weekly payroll deductions and are secured by the Participant's account balance. The interest rate is determined by the Administrative Committee based on prevailing market conditions and is fixed over the life of the note. Loans must be repaid within 5 years unless used for the purchase of a primary residence, in which case the Plan administrator may permit a longer repayment term.

#### *Forfeitures*

At December 31, 2024 and 2023, forfeited accounts totaled \$696,210 and \$527,577, respectively. Forfeitures shall be used to reduce Employer Matching Contributions and or to pay Plan expenses. During the year ended December 31, 2024, forfeitures in the amount of \$404,101 were used to reduce Employer Matching Contributions.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### *Investment Valuation and Income (Loss) Recognition*

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of the fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income (loss) is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan Participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Notes Receivable*

Notes receivable from Participants represent Participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Payment of Benefits*

Benefits are recorded when paid.

### 3. Certified Information

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Vanguard, the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### 4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements).

The three levels of the fair value hierarchy under GAAP are described below:

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies* - Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Funds* - Valued at the net asset value using NAV as the practical expedient based on the last reported sales price of the underlying investments held. The Plan's interest in the collective trust funds is based on information using the audited financial statements of the collective trust funds at year-end. The investment income (loss) is allocated to Participants based on their proportionate share of the net assets of the funds.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

The Plan was amended and restated effective January 1, 2017. The IRS has determined and informed the Company by a letter dated January 30, 2018, that the amended Plan and its underlying trust qualify under the applicable provisions of the Internal Revenue Code (IRC) and, therefore, are exempt from federal income taxes. The Plan has been amended since the date of the determination letter; however, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will remain 100% vested in their accounts.

### **7. Party-In-Interest Transactions**

Vanguard and its affiliates perform services, sell products and maintain certain investments of the Plan for which fees are charged to the Plan. Party-in-interest transactions also include notes receivables from Participants. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions.

### **8. Risks and Uncertainties**

The Plan's investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect Participant's account balances and amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, 24% and 22% of the Plan's investments were invested in the Vanguard Institutional Index Fund Institutional Shares, respectively.

### **9. SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

### **10. Subsequent Events**

The Company has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.
