We have performed audits of the financial statements of ShopRite Supermarkets, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ShopRite Supermarkets, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ShopRite Supermarkets, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ShopRite Supermarkets, Inc. 401(k) Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about ShopRite Supermarkets, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### 1. Description of Plan

The following brief description of ShopRite Supermarkets, Inc. 401(k) Plan, previously known as ShopRite Supermarkets, Inc. Payroll Deduction Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

##### **General**

Effective October 1, 1988, ShopRite Supermarkets, Inc. (the "Company", "Plan Administrator" or "Sponsor"), a wholly owned subsidiary of Wakefern Food Corp. ("Wakefern"), established the Plan, a participant directed defined contribution plan that covers eligible employees who elect to participate in the Plan. The Plan is a savings plan established pursuant to Section 401(k) of the Internal Revenue Code (the "IRC") that allows employees to defer a portion of their salaries for tax purposes through contributions to the Plan from payroll deductions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was amended and restated as of January 1, 2016. The Plan has gone through a five-year amendment cycle, whereby, the Plan is required to consolidate any amendments that have occurred over the past five years into one formal Plan document that captures any and all changes. The purpose of the amendment also includes any adjustments to legal terms used within the Plan to clarify specific provisions of the Plan.

The Plan permits participants to electively transfer their investments between the Plan, the Wakefern Food Corp. 401(k) Savings Plan, and each of the other tax-qualified plans maintained by the Sponsor's affiliates, which are defined contribution plans that include a qualified cash or deferred arrangement under Section 401(k) of the IRC, following transfer of employment between the companies. For the year ended December 31, 2024, the Plan transferred \$915,921 to another affiliated plan.

##### **Eligibility**

Those employees not covered under a collective bargaining agreement who have attained the age of 21 and have completed one year (at least 1,000 hours) of service, as defined, are eligible to participate in the Plan. Plan entry dates are the first day of the calendar quarter on or after completing the eligibility requirements.

##### **Contributions**

The amount a participant may contribute on a pretax basis is between 1% and 15% of monthly compensation, as defined. The Internal Revenue Service ("IRS") has limited a participant's annual tax deferred contribution to \$23,000 for 2024. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions of an additional \$7,500 for 2024. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company matches 40% of the participant's pretax contribution based on the first 3% of the employee's compensation plus 20% of the participant's pretax contribution based on the next 3% of compensation. The Company contributed a 3% nonelective employer contribution, net of forfeitures, in 2024 in the amount of \$963,843.

Contributions are allocated at the direction of the participants to the investment options offered by the Plan.

#### **Participant Accounts**

Each participant's account includes the participant's contributions, Company contributions, a pro rata share of earnings or losses thereon and any withdrawals and fees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants' contributions and related earnings and losses are 100% vested and nonforfeitable at all times. Participants are 100% vested in the nonelective employer contributions at all times. Company matching contributions and related earnings and losses are vested at the rate of 20% per full year of service, and are fully vested after 5 years of service.

#### **Forfeitures**

Forfeited nonvested accounts are available to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$59,479 and \$56,074, respectively. During 2024, employer contributions were reduced by \$35,000 from forfeited nonvested accounts in accordance with Plan provisions.

#### **Benefits**

Upon termination of service due to death, disability or retirement, a participant is entitled to receive an amount equal to the value of the participant's vested interest in his or her account. The form of payment is generally a lump-sum distribution. Under the Plan, participants are not subject to federal income tax on the contributions and investment income credited to their accounts until such amounts are withdrawn pursuant to Section 401(a) of the IRC. Withdrawals (including withdrawals by participants separated from the service of the Sponsor for any reason) that are not rolled over into another qualified plan, may be subject to federal income taxes. The Plan also allows in-service withdrawals of a participant's vested interest in his or her accounts upon attainment of age 59 ½ or for certain hardships.

#### **Notes Receivable From Participants**

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balance or \$50,000. Interest rates on notes are determined by the Plan Administrator. Participants are limited to one outstanding loan. Notes receivable at December 31, 2024 have interest rates ranging from 3.25% to 8.50% and have maturities through 2039. Loans are repaid by payroll deductions and are collateralized by the balance in the participant's account.

#### **Plan Termination**

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and be entitled to their full account balance including all Company contributions as of the termination date.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America on the accrual basis of accounting and present the net assets available for benefits and changes in those net assets.

### **Administrative Expenses and Revenue Credit**

Administrative expenses relating to the operation of the Plan are paid by the Plan to the extent not paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments and are not readily determinable. The Plan has a revenue credit account with one of the custodians which is funded through a revenue sharing agreement. For the year ended December 31, 2024, revenue credits exceeded administrative expenses by \$22,307 from the revenue credit account.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value except for a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrative and Investment Committee administers the Plan and determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustees. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis, and gain or loss on disposition is based on average cost. The Plan presents in the statement of changes in net assets available for benefits, the net appreciation in the fair values of its investments which consists of realized and unrealized gains and losses from those investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. A default shall occur if the participant fails to make any payment due under the terms in a timely manner. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### **Benefit Payments**

Benefit payments to participants are recorded upon distribution.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires the Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities as of December 31, 2024 and 2023 and the reported amounts of additions and deductions for the year ended December 31, 2024. Actual results could differ from those estimates.

#### **Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, foreign exchange, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, two investments represented a concentration of greater than 10% of the Plan's net assets available for benefits.

### **3. Guaranteed Investment Contract with Mass Mutual Life Insurance Company**

The Plan has a benefit-responsive guaranteed investment contract with Mass Mutual Life Insurance Company ("Mass Mutual"). Mass Mutual maintains the contributions in a general account.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The traditional investment contract held by the Plan is a guaranteed investment contract. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting interest rate was 3.3% and 4.05% as of December 31, 2024 and 2023, respectively. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The complete or partial termination of the Plan;
2. The establishment or activation of, or material change in, any Plan investment fund, or amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs;
3. Plan termination or merger.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different from contract value. Examples of such events include the following:

1. A termination or partial termination of the Plan;
2. A breach of material obligation under the contract;
3. An uncured violation of the Plan's investment guidelines ;
4. A material misrepresentation; and
5. A material amendment to the agreement without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

#### 4. Information Certified by the Plan's Trustees

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Trustees of the Plan (the "Trustees"), have certified the completeness and accuracy of all investments and related investment activity, notes receivable from participants and the related interest income in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 5. Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observed for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, a Level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such investments in the fair value hierarchy. There have been no changes in valuation methodologies from prior year.

*Mutual Funds:* These investments are valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are therefore classified within Level 1 of their fair value hierarchy.

#### **6. Tax Status**

Pursuant to a letter of determination dated February 14, 2018, the IRS has ruled that the Plan qualifies under Section 401(k) of the IRC, and is, therefore, not subject to tax under current income tax law. In the opinion of the Plan Administrator, the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and there are no audits in process for the Plan.

#### **7. Parties-in-Interest**

Certain Plan investments are shares of mutual funds that are issued or managed by Mass Mutual, an affiliate of Empower the Plan's recordkeeper. The Plan's investments include the guaranteed investment contract with Mass Mutual under their group annuity contract. The investment contract is reinsured by Empower Annuity Insurance Company of America and is managed by affiliates of the Plan's Trustees. Therefore, these transactions qualify as party-in-interest transactions. The Plan's notes receivables from participants are party-in-interest transactions. All such party-in-interest transactions are exempt from the prohibited transaction rules. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employees receive compensation from the Plan.

#### **8. Subsequent Events**

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued. No subsequent events requiring disclosure were identified.
