Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Haven Savings Bank 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution.)

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion of the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the accompanying 2024 financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared by and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - 2024 Supplemental Schedules Required by ERISA

Notes to Financial Statements

1. Description of the Plan

The following description of the Haven Savings Bank 401(k) Plan (the Plan) is provided only for general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which is sponsored by Haven Savings Bank (the Company) covering all employees of the Company. The Plan effective August 1, 1985, was amended and restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2024, the Plan was amended to permit Roth elective deferrals.

Eligibility

All employees who are at least 18 years of age and have 90 days of service are eligible for participation. Enrollment is immediate once conditions are met. Long-term part-time employees who met eligibility requirements under the SECURE Act of 2022 are also eligible to participate in the Plan.

Participant Accounts

Individual accounts are maintained for each Plan Participant. Each Participant's account is credited with the Participant's voluntary contribution, any Company matching contribution, any Company discretionary profit-sharing contribution, and Plan earnings, and is debited for withdrawals, administrative expenses, and any allocation of Plan losses. Allocations are based on Participant earnings, deferrals, or account balances, as defined in the Plan document. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

Contributions

Participants are permitted to contribute a percentage of their annual compensation, as defined in the Plan document, on a tax-deferred or on an after-tax basis (Roth), subject to certain Internal Revenue Code (IRC) limitations. In addition, eligible Participants are permitted to make catch-up contributions.

When new employees complete three months of service, the Company will withhold 3% of compensation unless the Participant affirmatively elects a different percentage or elects to not participate in the Plan. This percentage automatically increases by 1% effective January 1 of each Plan year, up to a maximum of 6%. Participants may also contribute amounts representing distributions from other qualified plans or individual retirement accounts (rollovers). The Plan does not accept rollovers of after-tax employee contributions. Additional voluntary contributions are not permitted.

The Company is making a match equal to the sum of 100% of the amount of the Participant's elective deferral, including catch-up contributions, that are not in excess of 1% of the Participant's compensation, plus 50% of the amount of the Participant's elective deferral, including catch-up contributions, that exceed 1% of the Participant's compensation but are not in excess of 6% of the Participant's compensation. Catch-up contributions shall not be subject to the discretionary matching contribution. The Company may also make an additional discretionary contribution on an annual basis equal to a uniform percentage, determined by the Company, of each Participant's elective deferrals. The additional discretionary contribution was \$218,681 during the year ended December 31, 2024.

1. Description of the Plan (cont.)

Vesting

Participants are fully vested in all their accounts, including salary deferrals, rollover contributions, all Company contributions plus actual earnings thereon.

Forfeitures

There were no forfeited non-vested accounts as of December 31, 2024 and 2023. Any amounts forfeited may be used to reduce future Company contributions and/or to pay Plan expenses. During the year ended December 31, 2024, there were no forfeited funds to be used to offset Company matching contributions or to reduce Plan expenses.

Notes Receivable from Participants

Participants may borrow from their account up to \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the Participant's account and bear interest as determined by the Plan administrator. The interest rate is prime rate plus 1%. Generally, the term of the loan may not exceed five years. However, if the loan is for the purchase of a principal residence, the Plan administrator may permit a longer repayment term.

Loans are not considered distributions and are not subject to federal or state income taxes, provided they are repaid as required. Loans are repaid through bi-weekly payroll deductions, and repayment begins the first pay period after disbursement of the loan.

Payment of Benefits

Participant accounts may be withdrawn upon retirement, death, disability, or termination of employment. The Plan also allows for in-service withdrawals at age 59½, along with withdrawals in the event of a financial hardship. Distributions may be made in lump-sum payments, installment payments, or partial withdrawals and are either paid directly to the Participant or rolled over to another qualified retirement plan. If a terminated Participant's balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump-sums as designated by the Company.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Accounting Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of the contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (cont.)

Investment Valuation and Income (Loss) Recognition

The investments of the Plan are reported at fair value, with the exception of fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount Participants normally would receive if they initiate permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date (the exit price). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income (loss) is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investment includes the Plan's gains and losses on investments bought, sold, and held during the year.

Contributions

Contributions from Plan Participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments and the Plan administrator deems the Participant loan to be in default, then the Participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Distributions to Participants are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain expenses incurred from maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Administrative expenses relating to specific participant transactions are charged directly to the Participant's account.

3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements).

The three levels of the fair value hierarchy under GAAP are described below:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market asset or liability is a market in which the transaction for the asset or liability occurs with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 - Observable inputs other than Level 1 prices, such as a quoted price for similar assets or liabilities; quoted market prices in markets that are active; or model-derived valuation or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Pooled Separate Accounts - The fair value of the pooled separate accounts is based on the net asset value (NAV) of each account calculated by Voya and is based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

The Plan's investments at fair value as of December 31, 2024 and 2023 are made up entirely of pooled separate accounts, which are measured at the NAV as a practical expedient. In accordance with GAAP, certain investments that were measured as such are not classified in the fair value hierarchy. The Plan has no assets at December 31, 2024 and 2023, that are classified in the fair value hierarchy.

5. Investment in Insurance Contracts

The Voya Fixed Accounts are fully benefit-responsive guaranteed investment contracts with Voya. Voya maintains the contributions in general accounts. The accounts are credited with earnings (losses) on the underlying investments and charged for Participant withdrawals and administrative expenses. The contracts are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Voya makes this guarantee, and although Voya may credit a higher interest rate, the credited interest rate will not fall below the lifetime guaranteed minimum of 3%.

As described in Note 2, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by Voya, represents contributions made under the contracts, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Participants are probable of occurring.

6. Related-Parties and Party-In-Interest Transactions

All Plan investments are managed and provided by Voya. Voya is the contract holder and certifying entity as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The notes receivable from Participants are also defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

7. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by CCH Incorporated DBA FT William (FT William). The Internal Revenue Service (IRS) has opined and informed FT William by letter dated June 30, 2020, stating that the form of the Pre-Approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net assets Available for benefits.

The Voya Financial Fixed Account A and Voya Fixed Account, guaranteed investment contracts, represented approximately 18% and 22% of the total investments at December 31, 2024, respectively. The Voya Financial Fixed Account A and Voya Fixed Account, guaranteed investment contracts, represented approximately 18% and 24% of the total investments at December 31, 2023, respectively.

9. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, Participants would remain 100% vested in their account balances and such balances shall be distributed to Participants and beneficiaries based on their individual accounts in the Plan as of the termination date.

10. Delinquent Participant Contributions

Employee withholdings of \$5 were not remitted within the appropriate time period by the Company for the year ended December 31, 2024. The Company plans to remit the delinquent contributions and the related lost earnings during 2025. These transactions constituted prohibited transactions as defined by ERISA.

11. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management continues to evaluate the impact of the adoption and implementation of this legislation on the Plan.

12. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, September 26, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
