As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 DESCRIPTION OF PLAN

The following description of CoreMedical Group 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 2001. The Plan covers substantially all employees of CMG CIT Acquisition LLC dba: Core Medical Group (the Sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees of the Sponsor, except for union employees and nonresident aliens, having completed 60 days of service, as defined, are eligible for participation.

Contributions

A participant may contribute an amount of up to 100% of his/her compensation, pre-tax to a traditional 401(k) or post-tax to a Roth 401(k), as defined in the Plan. A participant may subsequently elect to increase or decrease the rate of contributions as of each payroll period. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Sponsor is currently matching up to 50% of the first 6% of an employee's compensation contributed to the Plan under a discretionary match formula. Both Sponsor and participant contributions are subject to certain limitations as defined in the Plan documents and in accordance with applicable regulations.

The Sponsor may make a discretionary profit-sharing contribution. There were no profit-sharing contributions for the year ended December 31, 2024.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the Sponsor's matching, discretionary profit-sharing contributions and plan earnings (losses). Allocations are based on participant earnings or account balances as defined. Allocations of matching and nonelective contributions are based on participant's compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Transamerica Life Insurance Company (Transamerica). These funds include a variety of investment options with various objectives and degrees of financial risk.

Vesting

A participant's contributions and earnings thereon are fully vested at all times. Under normal vesting circumstances, the employer matching contributions and earnings thereon are 25% vested after one year of service, and an additional 25% vested each subsequent year until 100% vested after four years of service, as defined in the Plan. A participant automatically becomes fully vested upon death, disability or attainment of age 65.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

The nonvested portion of a participant's employer matching contributions balance is tentatively forfeited at the earlier of the distribution of the entire vested portion of the participant's account who has severed employment, or the last day of the Plan year in which a participant who has severed employment incurs five consecutive one-year breaks in service, as defined in the Plan.

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$41,751 and \$14,855, respectively. For the years ended December 31, 2024 and 2023, forfeitures used to reduce employer matching contributions amounted to \$117,449 and \$69,029, respectively.

Notes Receivable from Participants

A participant may borrow against his/her vested account balance. A participant may have no more than two loans outstanding at one point in time. The participant's loans are limited to one-half of the value of his/her vested account balance, not to exceed \$50,000. The minimum loan amount is \$1,000. A loan bears interest at a fixed rate (prime plus 1%), as determined by the Plan administrator, which is credited to the participant's account. The notes currently bear interest at rates ranging from 4.25% to 9.5%. A loan is required to be repaid through after-tax payroll deductions over a period not to exceed five years; up to 15 years if the purpose of the loan was to acquire a primary residence.

Payment of Benefits

Upon termination of service due to retirement or disability, a participant may elect to receive either a lump-sum distribution or installment payments equal to the value of his/her account, or to defer receipt of his/her account balance, provided a distribution is made or commences no later than April 1st following the end of the calendar year in which the participant attains age 70 1/2. In the event of death, a participant's entire account balance will be distributed to his/her beneficiary.

Distributions to participants who otherwise terminate employment will be deferred until the age 65, unless the participant elects immediate payment or the distribution is less than \$5,000. In such cases, the participant will receive a lump-sum distribution equal to the vested value of his/her account.

Withdrawals

Withdrawals during employment are only allowed upon certain hardships outlined in the Plan document, or once the participant has attained age 59 1/2.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies which are in conformity with accounting principles generally accepted in the United States of America, consistently followed by the Plan in the preparation of its financial statements.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of sources and applications of net assets during the reporting period. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Revenue Sharing

At times, the Plan holds assets in a Plan cash account which receives deposits as a result of a revenue sharing arrangement with Transamerica. During 2024 and 2023, deposits to the account totaled \$3,223 and \$30,637, respectively, which are included in other income on the statement of changes in net assets available for benefits. Funds in the account can be used to pay qualified Plan expenses. During 2024, the Plan used \$13,650 of revenue sharing credits to pay Plan expenses.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Benefit Payments

Benefit payments to participants are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued, and no subsequent events have been noted which would require adjustment to or disclosure in the financial statements.

NOTE 3 CERTIFICATION BY THE INVESTMENT CUSTODIANS

Information presented in the accompanying statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for investments, cash, notes receivable from participants, investment income and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by Transamerica Life Insurance Company and Reliance Trust Company, the custodians, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds: Mutual funds are valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year-end.

Cash Account: Investments in cash and cash equivalents are valued based on cost, which approximates fair value in a non-inflationary economy and is protected by the FDIC.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

At December 31, 2024 and 2023, the Plan had an investment in a fully benefit-responsive investment contract with Transamerica. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Transamerica Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$570,248 and \$580,795, respectively.

The crediting interest rate is based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate for the Stable Value Option investment. Such interest rates are reviewed on a quarterly basis for resetting. At December 31, 2024 and 2023, the rates were 1.65% and 1.25%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 TAX STATUS

The Plan has adopted a non standardized prototype plan that received a favorable opinion letter from the IRS that it was in compliance with the applicable requirements of the Internal Revenue Code (the Code). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

The Sponsor has stated its intent to continue the Plan indefinitely; however, continuation of the Plan is voluntary on the part of the Sponsor, and the Sponsor reserves the right to modify or terminate the Plan at any time. In the event of Plan termination, all participants become 100% vested in their accounts, net of any expenses necessary to terminate the Plan.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by affiliates of Transamerica and Reliance Trust Company.
