Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Hazen and Sawyer 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Hazen and Sawyer, D.P.C. (the “Company”). Employees who are 21 years of age, or older, are eligible to contribute to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 75% of eligible compensation on a pre-tax or Roth basis, as defined in the Plan, subject to a maximum amount that is determined by the Internal Revenue Service (“IRS”). Participants who are age 50 or older by the end of the Plan year can make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary profit sharing contribution to the Plan allocated pro rata based on the employee’s eligible compensation. For participants to be eligible to receive the Company’s contribution, the participant must be 21 years of age and have completed one year of service. Each year, an employee must complete 1,000 hours of service to receive an allocation of the Company’s contribution. For the year ended December 31, 2024, the Company elected to contribute \$17,000,000. The Company contributions are invested in a portfolio of investments as directed by participants.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Once a participant is eligible to receive the Company’s contribution, they are immediately vested in those contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on a participant’s earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of Plan (*continued*)

Revenue Credit Account

The Plan and Fidelity Management Trust Company have entered into a revenue sharing arrangement whereby a portion of the revenue earned by certain funds is passed through to the Plan for either (1) payment of permitted Plan expenses or (2) reallocation back to participants on a pro rata basis. In order for the Plan to receive and use these credits, the Plan has created a Revenue Credit Account. The Revenue Credit Account is an account within the Plan and is used to record-keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. At December 31, 2024 and 2023, the Revenue Credit Account balance was \$63,820 and \$25,265. During 2024, no amounts were used from the revenue credit account to pay Plan expenses or were reallocated back to participants.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum, or in annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. Partial withdrawals are permitted for hardship distributions and required minimum distributions. In-service withdrawals are permitted for participants after attaining age 59 ½.

Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participants' account and bear interest at 1% above the prime rate, as defined by the Plan. Principal and interest are paid ratably through payroll deductions and must be repaid within five years unless the note is used to buy a principal residence in which case it must be repaid within ten years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies *(continued)*

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

The Plan follows U.S. GAAP guidance which removed the requirement to categorize within the fair value hierarchy investments whose fair value is measured using net asset value ("NAV").

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value. The mutual funds are valued at the daily closing price as reported by the fund. These funds are open-end funds that are registered with the Securities and Exchange Commission and are deemed to be actively traded. These funds are required to publish their daily net asset value ("NAV") and to transact at that price.

Investments held in the self-directed brokerage account are common stocks, preferred stocks, mutual funds, U.S. Government securities and corporate securities. Common and preferred stocks are valued at the closing price reported on the active market on which the individual securities are traded. U.S. Government securities and corporate securities are valued using pricing models maximizing the use of observable inputs for similar securities.

The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchase and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income from investments is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and a distributable event occurs (retirement, termination, death), the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses related to maintaining the Plan are paid by the Company and are excluded from these financial statements. Any expenses not paid by the Employer are paid by the Plan. Investment related expenses are included as a reduction in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 6, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in fair value of investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

5. Common/Collective Trusts

The Great Gray T. Rowe Price Stable Value Fund and T. Rowe Price Retirement Trusts (collectively, the "Funds") are common/collective trusts. Units of the Funds are valued each day on which the New York Stock Exchange ("NYSE") is open for trading in accordance with the valuation procedures established by the trustee. The NAV per unit of the Funds is calculated as of the close of trading on the NYSE. The NAV per unit is computed by dividing the total value of the assets of the Funds, less their liabilities, by the total number of units outstanding at the time of such computation. The Funds sell new units and repurchase outstanding units on a daily basis. Unit purchases and redemptions are transacted at the NAV of the Fund determined as of the close of business each day. Investment income earned is reinvested in the Funds and included in the determination of unit values. The Funds do not have any unfunded commitments at December 31, 2024 and 2023.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100 percent vested in their accounts for both employee and employer contributions.

7. Tax Status

The Plan is structured and follows a prototype non-standardized cash or deferred profit-sharing plan, pre-approved by the Internal Revenue Service ("IRS"). The IRS issued an opinion letter dated June 30, 2020, that the prototype non-standardized cash or deferred profit-sharing plan is acceptable in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Party-in-Interest Transactions

Fidelity Management Trust Company is the recordkeeper of the Plan and is paid fees for these services by the Plan, these transactions qualify as exempt party-in-interest transactions. Certain investments of the Plan are managed by an affiliate of Fidelity Management Trust Company, the trustee and these transactions qualify as exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

9. Prohibited Transaction

During the 2024 plan year, the Employer failed to remit to the Plan certain participants contributions amounting to \$700 within the period described by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer has made the necessary corrections to satisfy both the Department of Labor and Internal Revenue guidance for the delinquent contributions.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
