Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of The Quality Castings Company 401(k) Plan and Educational Fund ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.



NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of The Quality Castings Company 401(k) Plan and Educational Fund (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a voluntary defined contribution plan covering substantially all employees of The Quality Castings Company (the “Company”) who have attained one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective April 7, 2022, the Plan changed trustees to Fidelity Management Trust Company and all assets were transferred to Fidelity. In connection with this change, the Plan adopted a Fidelity pre-approved plan document. The adoption agreement included no substantial changes to the benefits offered under the Plan.

Any employee hired after January 1, 2020 is automatically enrolled in the Plan immediately following his completion of one year of service. Any employee rehired on or after April 1, 2020 without a break in service, is automatically enrolled in the Plan on his reemployment commencement date. Any employee rehired on or after January 1, 2020 who has incurred a break in service is automatically enrolled after one year of service from the reemployment commencement date. Participants will be enrolled at 5% of eligible compensation. At any time prior to the enrollment date, an employee can voluntarily elect to opt-out of participation by notifying the Plan administrator.

Effective December 23, 2024, the one-year requirement was amended to 90 days. Employees remain eligible for the employer matching contributions after one year of service.

Contributions

Participants may elect to make contributions pre-tax, post-tax, or both of no less than 1 percent of normal eligible wages, defined as base wages, overtime and vacation pay. The Company makes a matching contribution equal to 100 percent of employee pre-tax deferrals up to and including the first 1 percent of eligible wages and 50 percent up to and including the next 4 percent of employee pre-tax deferrals.

Rollovers

Participants may transfer eligible cash distributions from any other employer sponsored qualified plan under Section 401(a) or 403(b) of the Internal Revenue Code (“IRC”) into the Plan by a direct transfer from such other plan. Additionally, the Plan will accept a participant rollover contribution of the portion of a distribution from an Individual Retirement Account or Annuity under Section 408(a) or 408(b) that is eligible to be rolled over and would otherwise be includable in gross income.

Forfeitures

The invested portion of the employer contribution account shall be forfeited and allocated to the participant account balances or used to pay Plan expenses. At December 31, 2024 and 2023, there were \$3,536 and \$0 unallocated forfeited non-vested accounts and forfeitures amounting to \$1,900 were utilized during the year ended December 31, 2024 to pay Plan expenses.

Participant Accounts and Investment Options

Each participant has three accounts: pre-tax, post-tax and employer match contributions. Each participants’ account is credited with the participant’s contribution, the Company’s matching contribution and an allocation of earnings and forfeitures of terminated participant’s non-vested accounts, less any distributions. Allocations are based on participant account balances as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions. Vesting in the remainder of their accounts is based on credited years of service. A participant is 100 percent vested in the employer matching contribution after three years of credited service.

Payment of Benefits

The Plan document provides for two types of benefits:

- Benefit A distributions are provided upon retirement or other termination of employment.
- Benefit B distributions are an in-service withdrawal that may be made for education expenses for eligible individuals and are deducted from the participant's post-tax and employer accounts in order of priority as defined by the Plan document.

Administrative Fees

The Company pays costs of administering the Plan, except for some cash management fees, which are paid by the Plan.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth by ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amount of increases and decreases to Plan assets during the reported period. Actual results could differ from those estimates.

Fair Value of Financial Instruments

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Investment Valuation and Income Recognition

All assets of the Plan are held and invested by Fidelity Management Trust Company (the "Trustee") for the years ended December 31, 2024 and 2023. The Plan's investments are stated at fair market value as of December 31, 2024 and 2023.

Investment income consists of interest and dividend income and net appreciation (depreciation) of investments. The net appreciation (depreciation) in the fair value of investments consists of realized gains or losses and the unrealized appreciation (depreciation) on those investments. Purchases and sales of investments are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

The Income Taxes Topic of the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities.

The Plan administrator has analyzed the tax positions of the Plan and has concluded that as of December 31, 2024 and 2023 and for the year ended December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan administrator obtained a certification from the Trustee as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that such information is complete and accurate.

NOTE 4 – INVESTMENTS

The Plan’s investments are participant-directed accounts that are held by the Trustee.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1: Observable inputs such as quoted prices in active markets;
- Level 2: Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Investments that were measured at net asset value (“NAV”) per share are not classified in the fair value hierarchy. The fair value amounts presented in the below tables are intended to permit reconciliation of the fair value hierarchy to total investments at fair value. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Collective investment funds: Valued at the NAV of the underlying investments held by the funds, less any liabilities. NAV is used as a practical expedient to estimate fair value.
- Mutual funds: Valued based on quoted market prices in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methods used to value investments.

The Plan's investments in the Collective investment funds may be redeemed on dates specified by the contract and require a redemption notice of one trade day.

NOTE 5 – TAX STATUS

The prototype plan adopted by the Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies managed by the Trustee. The Trustee is the custodian, as defined by the Plan document, and therefore, these transactions are party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$4,564 for the year ended December 31, 2024. There are also indirect fees deducted directly from investment earnings of the Plan.
