To the Administrator and Participants of the Curtin Co. Employee Benefits Plan:

Opinion

We have audited the financial statements of the Curtin Co. NOTES TO FINANCIAL STATEMENTS
FOR THE PERIOD FROM FEBRUARY 1, 2024 TO DECEMBER 31, 2024
AND THE YEAR ENDED JANUARY 31, 2024

1. PLAN DESCRIPTION

The following description of the Curtin Co. Employee Benefits Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan was established February 1, 2020 to provide medical benefits to employees of Curtin Co. (the "Employer") and their covered dependents. Plan assets for the medical plan are held in a health and welfare grantor trust (the "Trust"). During the current plan year, the Plan changed its year end from January 31st to December 31st.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is also subject to the rules and regulations promulgated by the Department of Labor ("DOL") and the Internal Revenue Service ("IRS"). Failure to comply with the provisions of ERISA or the rules and regulations of the DOL and IRS could result in penalties to the Plan and/or the Employer. The Employer believes it has complied in all material respects with such rules and regulations.

Benefits - The Plan provides medical benefits to employees and to their covered dependents. All regular full-time employees of the Employer working at least thirty (30) hours per week are eligible for coverage. Employees will be enrolled into the Plan on the first of the calendar month following the waiting period. The waiting period is waived for former employees of the employer that are rehired within thirteen (13) weeks of their termination date. Certain terminated employees are entitled to participate in the Plan for a limited time under the terms of the Consolidated Omnibus Budget Reconciliation Act of 1986.

Self-Insured Benefits - With the exception of amounts reimbursed under the Plan's stop-loss coverage, the medical plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only agreements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop-Loss Coverage - The Employer has entered into a stop-loss insurance arrangement which limits its exposure for self-insured benefits incurred by the Plan. Under the terms of the stop-loss arrangement the Plan is reimbursed for medical and prescription drug claims related to any one individual participant in a calendar year with claims in excess of \$75,000. As of December 31, 2024, approximately \$782,000 of claims payable are claims that will be reimbursed by the stop-loss coverage.

Contributions - The plan document provides that the Employer make contributions to provide for the payment of benefits. The Employer contributes all amounts in excess of amounts contributed by the participants that are necessary to provide current benefit payments under the Plan. Participant contributions to the Plan are required for coverage. The Employer determines the amounts to be contributed to the Plan by the plan participants. In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections.

Concentration of Credit Risk - Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist principally of cash. As of December 31, 2024 and January 31, 2024, substantially all cash was maintained by a single major financial institution. At times, cash at this financial institution is in excess of the Federal Depository Insurance Corporation insurance limit.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities, including estimated health claims incurred but not reported and claims payable and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits - Claims payments are recorded when paid by the third-party claims administrators. Amounts due to the claims processor that have yet to be reimbursed by the Plan are recorded as claims incurred but not reported in the accompanying statement of benefit obligations and net assets available for benefits.

Stop-Loss Premiums and Reimbursements - The Employer holds a stop-loss insurance policy that covers the Plan. Premiums for the policy are paid for by the Employer. Although the Employer is entitled to the benefits under the policy, in practice, reimbursements are received directly by the Plan and have been recorded as insurance settlements on the accompanying statement of changes in benefit obligations and net assets available for benefits.

Subsequent Events - Management has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations as of December 31, 2024 and January 31, 2024 for health claims incurred by active participants but not reported at that date and for accumulated eligibility of participants are estimated by the Plan's actuary in accordance with accepted actuarial principles. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses which consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the accompanying statement of changes in benefit obligations and net assets available for benefits as administrative expenses. All other administrative expenses of the Plan, such as professional fees, are paid by the Employer on behalf of the Plan. These transactions qualify as exempt party in interest transactions.

5. PLAN TERMINATION

Although it has not expressed an intent to do so, the Employer has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA.

Benefits shall be paid only to the extent that assets held in the Plan are sufficient to pay outstanding claims. Any excess funds must be used to provide benefits for the plan participants on such equitable basis as shall be determined by the Administrative Committee.

6. TAX STATUS

The Plan constitutes a Health and Welfare Fund organized as a grantor trust. The trust is exempt from income tax as described under Section 419(e)(3)(B) of the Internal Revenue Code.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and January 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.
