INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Russell Marine 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Russell Marine 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Russell Marine 401(k) Plan (the “Plan”) provides only general information. The Plan is sponsored by Russell Marine, LLC (the “Company”). Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that covers all eligible employees of the Company except union employees, leased employees, residents of Puerto Rico, and nonresident aliens. Employees are eligible to participate in the Plan on the first day of the month following the completion of two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make salary deferral contributions to the Plan up to 100% of their eligible compensation, subject to certain limitations. Participants age 50 or over in the plan year may also make catch-up contributions to the Plan. Participants are allowed to designate a portion of their elective deferrals as Roth contributions. Newly eligible employees are automatically enrolled at a 6% pre-tax salary deferral rate of eligible pay unless the employee declines participation or elects a deferral percentage. Automatic enrollment contributions begin as soon as administratively feasible. The Plan also allows rollover contributions.

The Company may make a discretionary matching contribution in an amount equal to a percentage of elective contributions up to 6% of the participant’s eligible compensation. The Company elected to match 75% of each participant’s elective contribution up to 6% of the participant’s eligible compensation each pay period for the year ended December 31, 2024. Participants are eligible to receive employer matching contributions immediately upon entering the Plan. The Company may make additional discretionary matching contributions based on a discretionary percentage of a participant’s compensation or a discretionary dollar amount. The Company may make discretionary (“profit sharing”) contributions to the Plan, computed as a percentage of employee’s eligible compensation to the total eligible compensation of all eligible participants. Participants are eligible to receive the profit sharing contributions upon the completion of one year of service and being employed on the last day of the plan year. No additional discretionary matching or profit sharing contribution was made in 2024. The Plan is participant directed and participants may change their contribution rates at the beginning of each payroll period and may change their investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest 20% per year after one year of service and are 100% vested after five years of service.

Forfeited Accounts

Forfeitures of nonvested employer contributions shall be used to pay administrative expenses and then used to reduce the employer's contributions. The forfeitures balance at December 31, 2024 and 2023 was \$44,707 and \$14,854, respectively. The amount of forfeitures used to reduce the Company's contributions and pay Plan administrative expenses was \$66,549 and \$25,306, respectively, during 2024.

Notes Receivable from Participants

Plan participants may borrow from their account a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balance in the Plan, or \$50,000 reduced by the excess, if any, of the highest outstanding loan balance for all loans attributable to the participant from the Plan during the one-year period prior to the new loan application date. Notes receivable are paid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence in which case the period may not extend beyond ten years from the date of the note. The notes bear interest at reasonable rates as determined by the plan administrator and are secured by the participant's vested account to the extent of the principal amount of the note plus accrued interest. A participant may have only one loan outstanding unless one is for a principal residence. Participants may not initiate more than two loans in a plan year.

Benefit Payments

A participant shall be immediately vested upon death, retirement, or termination of employment due to total and permanent disability. Normal retirement age under the Plan is the date a participant attains age 65. Upon a participant's termination or retirement, the vested funds in the participant's account are available to be distributed in partial installments, equal installments, or a lump-sum payment. Participants may make withdrawals of vested funds for hardship and in-service withdrawals upon reaching the age of 59½. Participants may also make withdrawals of vested funds for qualified reservist distributions as provided in the Plan document.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time. Upon termination, participants would become 100% vested and would receive benefits based on their account balances accumulated to the date of the termination of the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, annual maintenance fees, and withdrawals are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the participant contributions are withheld from compensation. The Company discretionary profit sharing contribution is recorded in the plan year in which participant compensation is paid.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As described in Note 5, the Plan invests in a fully benefit-responsive investment contract through the Standard Stable Asset Fund A.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan's investments are measured at fair value using net asset value (NAV) per share as a practical expedient. The Plan's investments at fair value as of December 31, 2024 and 2023 are as follows:

The investments in the pooled separate accounts are valued using NAV as an estimate of fair value as reported by Standard Insurance Company (Standard) based on the value of the underlying investments. The Plan has no unfunded commitments or contractual obligations to further invest in these accounts and there are no restrictions on redemption of these accounts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 4 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard, an insurance company, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule H, line 4i - schedule of assets (held at end of year), except for participant loans, as of December 31, 2024, and the related investment income reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - STABLE ASSET FUND

The Plan has a fully benefit-responsive investment contract with Standard, the Stable Asset Fund A. The contract is included in the statements of net assets available for benefits at contract value, as reported to the Plan by Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value is a general liability against Standard on the Plan's behalf, and there are no particular segregated or identifiable assets of Standard ascribed to the Plan's contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with Standard. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan's prohibitions on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The contract may be cancelled by the Plan or by Standard at any time.

As of December 31, 2024 and 2023, the contract value of the investment in the Standard Stable Asset Fund A was \$1,092,290 and \$869,953, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. The crediting interest rate at December 31, 2024 and 2023 was 2.53% and 2.27%, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Plan investments are in pooled separate accounts and a contract account at Standard. Therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 7 - INCOME TAX STATUS

The Plan adopted a prototype defined contribution volume submitter plan, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

NOTE 7 - INCOME TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - DELINQUENT CONTRIBUTIONS

During 2024, there were unintentional delays by the Company in submitting participants' contribution and loan repayments to the Plan in the amount of \$80,503. The Company intends to compensate the affected participants' for any lost earnings resulting from these delinquent contributions in 2025.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.
