INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Rite of Passage Adolescent Treatment Centers and Schools, Inc. Retirement & Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and

certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rite of Passage Adolescent Treatment Centers and Schools, Inc. Retirement & Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Rite of Passage Adolescent Treatment Centers and Schools, Inc. Retirement & Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**1. General**

The Plan is a defined contribution plan covering substantially all employees of the Rite of Passage Adolescent Treatment Centers and Schools, Inc. (the “Organization” or the “Employer”) and meets all requirements for plan qualification under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**2. Eligibility**

All employees, except non-resident aliens, are eligible to participate in the Plan on the first day of the payroll period following their date of hire for purposes of making participant deferral contributions. All employees, except for non-resident aliens and employees covered by a collective bargaining agreement, who have completed one year of service in which at least 1,000 hours are worked are eligible to receive Organization contributions subject to quarterly entry dates.

**3. Contributions**

Participants may elect to contribute, on a tax-deferred basis, up to the maximum deferral limit per Section 402(g)(1). Additional “catch-up” contributions can be made beginning in the plan year in which a participant will be at least age 50 by the end of the plan year. The safe harbor matching contributions, non-safe harbor matching contributions, and non-safe harbor non-elective contributions are discretionary and are determined annually by the board of directors of the Organization. In 2024, the Organization made safe harbor matching contributions equal to 100% of elective contributions up to 6% of compensation.

**4. Investment Options**

Participants may direct employee and Organization contributions as desired in any of a variety of investment options offered by Nationwide Financial Services, Inc., as chosen by the Organization, and/or as chosen by participants through the Nationwide Financial Services, Inc.’s fund window. Participants may change their investment options daily.

**NOTE A - DESCRIPTION OF THE PLAN (Continued)**

**5. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, the Organization's matching contributions, and allocations of the Organization's non-safe harbor non-elective contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**6. Vesting**

Participant contributions, rollovers, Organization contributions and actual earnings on all such contributions are fully vested at all times.

**7. Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000 less the highest outstanding loan balance during the prior twelve-month period). Participants may have only one loan outstanding at any time. Loans shall bear an interest rate of one percentage point higher than the prime lending rate. Loans must be repaid within five years of the date of issuance in accordance with terms established by the plan administrator.

**8. Benefit Payments**

Upon termination of service, retirement, permanent disability, or death, a participant or a participant's beneficiary is entitled to receive a lump-sum amount equal to the total value of the participant's account balance. In-service and hardship distributions are permitted if certain criteria are met.

**9. Forfeitures**

Forfeitures attributable to any excess matching contributions may be used to pay reasonable plan expenses or to fund Employer contributions. Outstanding forfeitures available at December 31, 2024 and 2023 were not significant.

**10. Plan Termination**

Although it has not expressed such intent, the Organization reserves the right, at any time, to terminate the Plan subject to the provisions of ERISA by action of its Board of Directors. Upon termination of the Plan, further contributions to the Plan shall cease and the assets of the Plan would be distributed to the participants based on each individual participant's interest in the Plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**2. Plan Administration**

The Organization is the plan sponsor and the plan administrator. The administrator of the Plan is responsible for carrying out the duties imposed under ERISA.

**3. Investment Valuation and Income Recognition**

The investments of the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**4. Administrative Expenses**

Certain recordkeeping expenses are paid by the Plan. Investment related expenses are included in net appreciation/depreciation in fair value of investments. Substantially all out-of-pocket administrative expenses of the Plan are paid by the plan sponsor. Expenses that are paid by the plan sponsor are excluded from these financial statements.

**5. Payment of Benefits**

Benefits are recorded when paid.

**6. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**7. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**8. Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**NOTE C - CERTIFIED INVESTMENT INFORMATION**

Certain information related to investments in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends (if any) for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB and Nationwide Life Insurance Company (the custodians of the Plan), a qualified institution.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2     Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Value per share (unit) is determined and published daily and is the basis for current transactions.

*Fixed account:* The Fixed account is a fixed return investment with annual interest rate guarantees after the first period. The fair value of the Fixed account is equal to its book value less contingent deferred sales charges, if any. Deposits are guaranteed in both principal and interest by Nationwide Life Insurance Company. Amounts are held in Nationwide Life Insurance Company's general account and are credited on a net daily basis at annual effective rates. The net rate, crediting rate, and average yield was 2.37% for all of 2024. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without restrictions. In the event of contract discontinuance, the contract holder can request a lump sum distribution with a market value adjustment, or an installment payout, at contract value, over a period of years.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are held with Nationwide Trust Company, FSB and Nationwide Life Insurance Company. Nationwide Financial Services, Inc. is the record-keeper for the Plan. These transactions qualify as party-in-interest transactions. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**NOTE G - TAX STATUS**

The Organization is a tax-exempt organization under IRC Section 501(c)(3), and adopted a volume submitter 403(b) plan ("volume submitter plan") which received a favorable opinion letter dated March 31, 2017, in which the Internal Revenue Service (IRS) stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and no provision for income taxes has been reflected in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.
