### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of The Gem Group, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

## *Notes to Financial Statements*

### **Note 1 - Description of the Plan**

The following description of The Gem Group, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan established for the benefit of the employees of The Gem Group, Inc. (the “Employer”). All employees, except non-resident aliens and leased employees, become eligible to participate in the Plan on the 1<sup>st</sup>, 4<sup>th</sup>, 7<sup>th</sup> and 10<sup>th</sup> month of the Plan year upon the completion of three months of service and the attainment of age twenty-one (the “Participants”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant directed.

#### **Contributions**

##### **Participant Contributions**

Participants may defer up to 100% of their compensation for a Plan year, subject to dollar limits set by federal law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Rollovers”).

##### **Employer Matching Contributions**

The Employer may make a matching contribution equal to a discretionary percentage of base compensation that a participant contributes to the Plan. For the Plan year ended December 31, 2024, the Employer elected to contribute 50% of the first 6% of a participant’s eligible compensation.

#### **Participant Accounts**

Each participant’s account is credited with the Participant’s contributions and Employer matching contributions, as well as an allocation of Plan earnings/losses and expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant’s vested account balances.

#### **Vesting**

Participants are immediately vested in their pre-tax contributions and rollover accounts, plus actual earnings thereon. Vesting in the Employer’s matching contribution is based on years of continuous service. A participant is 100% vested after two years of credited service. Upon death, disability, or attainment of normal retirement age, a participant is fully vested in all of their accounts.

## *Notes to Financial Statements*

### **Note 1 - Description of the Plan (Continued)**

#### ***Forfeitures***

In the event of termination, a participant's non-vested portion of their account is forfeited and remains with the Plan to reduce future Employer matching contributions or to pay Plan expenses. At December 31, 2024 and 2023, the Plan had \$10,214 and \$5,632 respectively, in forfeitures available to reduce future Employer contributions or pay Plan expenses. During 2024, approximately \$29 in forfeitures were used to pay Plan expenses.

#### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount or partial payments equal to the vested balance of his or her account. For termination of service due to other reasons, a participant must receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also be entitled to receive in-service withdrawals upon reaching age 59½. Hardship withdrawals are available from the Participant's vested interest in his or her account.

#### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at a time. Loan terms are for up to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the Participant's account and bear interest at the prime rate plus 1% established at the time of the loan. Principal and interest are paid ratably through payroll deductions.

#### ***Administrative Expenses***

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. The majority of expenses incurred in the administration of the Plan are paid by the Plan, unless paid by the Employer.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The Plan's financial statements are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Contributions***

Contributions from Plan participants and the Employer matching contributions are recorded in the year in which the contributions are withheld from compensation.

### **Note 2 - Summary of Significant Accounting Policies (Continued)**

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount Participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Benefits Paid***

Benefits are recorded when paid.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

#### ***Subsequent Events***

The Employer has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

### **Note 3 - Information Certified by the Trustee and Custodians**

The mutual funds are held by the Plan's Trustee and Custodians, Empower Annuity Insurance Company of America, Employer Life & Insurance Company of New York, and Empower Trust Company (collectively "Empower"). The guaranteed interest account is held by Empower pursuant to a power of attorney from Massachusetts Mutual Life Insurance Company. Empower has certified to the completeness and accuracy of the fair and contract value of all the investments and notes receivable from participant transactions as of December 31, 2024 and 2023 and for the year ended December 31, 2024. Investment transactions include interest and dividends and net appreciation in fair values of investments. Information included in the supplemental Schedule of Assets (Held at End of Year) has also been certified as complete and accurate by Empower.

The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants may direct contributions to any of the investment options that consist of shares of mutual funds and guaranteed interest account sponsored by Empower.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of relevant observable inputs and minimize the use of the unobservable inputs. The three levels of the fair value hierarchy are described below:

*Level I* – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

*Level II* – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

*Level III* – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### **Note 4 - Fair Value Measurements (Continued)**

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The mutual fund investments at fair value held by the Plan as of December 31, 2024 and 2023 are \$26,583,343 and \$25,089,892, respectively. Based on the fair value hierarchy, the mutual funds are all Level I for the years ended December 31, 2024 and 2023.

### **Note 5 - Fully Benefit-Responsive Investment Contract**

Following is a description of the investments and valuation methodologies for fully benefit-responsive investment contracts:

#### **Fixed Interest Fund**

The Plan has a fully benefit-responsive group annuity contract with Empower. Empower maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawal and fees. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with Plan participants are probable of occurring.

The contract value of the Plan’s fully benefit-responsive fixed interest fund contract at December 31, 2024 and 2023 was \$1,201,206 and \$1,477,697, respectively.

### ***Note 6 - Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Note 7 - Related-Party Transactions and Party-in-Interest Transactions***

Plan investments include a guaranteed interest account managed by affiliates of Empower. Empower is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the Plan year ended December 31, 2024, administrative fees of \$120,002 were paid to Empower and other Plan service providers. Notes receivable from participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

### ***Note 8 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### ***Note 9 - Tax Status***

The Plan and related trust have been determined by the Internal Revenue Service (the "IRS") to be tax-exempt under Internal Revenue Code Section 401(a). The most recent favorable opinion letter from the Internal Revenue Service was received by the Plan, dated November 14, 2022. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 10 - Excess Contributions

At December 31, 2024 and 2023, the Plan was obligated to return excess contributions of \$53,263 and \$46,579, respectively, in order to satisfy the relevant nondiscrimination provisions for the Plan year. All amounts were refunded to participants prior to March 15<sup>th</sup> of the following year.
