## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### Note 1 - Plan Description

#### General

The Highland Resources, Inc. Employee Medical Plan (the Plan) was created for the purpose of providing a health and welfare program for the employees of Highland Resources, Inc. and certain affiliated companies (the Employer) and covered dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Eligibility

A full-time employee becomes eligible for coverage after completing ninety days (90) of active work.

#### Contributions

The employees and Employer make monthly contributions to the trust established under the Plan. The employees and the Employer contribute additional specified amounts to up-grade coverage and extend coverage to eligible dependents. Former employees and their dependents covered under the Plan make contributions to the Plan for the cost of such coverage. The cost of coverage usually increases each year consistent with the increase in medical costs.

#### Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

#### Benefits

The Plan provides health benefits (pharmaceutical, hospital, surgical and major medical) covering full-time employees of the Employer. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

#### Administrative Expenses

Expenses of Plan administration are paid by the Plan to the extent not paid by the Employer.

### Note 2 - Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements have been prepared using the cash basis of accounting. The cash basis of accounting means that contributions and other revenues are recognized when received and benefits, other expenses are recognized when paid. The cash basis of accounting was used because it would not be practical to determine which claims had been incurred but remained unpaid as of the end of the year. In addition, all qualified claims are contractual obligations of the Employer. If not paid by the Plan, claims must be funded when presented for payment by, either the Employee, the Employer or the Plan's insurance carrier.

Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with accounting principles generally accepted in the United States of America.

### Benefit Payments

Reimbursements due to the claims processor for claims paid are recorded when paid to the claims processor.

### **Note 3 - Federal Income Tax**

The Internal Revenue Service (IRS) has determined the Trust of the Plan to be exempt from Federal income tax. Plan management believes that the Plan is currently designed and is operating in compliance with IRS regulations.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

### **Note 4 - Insurance and Claim Liability**

The Employer contracts with an insurance company to administer claim payments and provide excess coverage for the Plan participants. Each contract is for a one-year period and extends coverage from November 1 to October 31 of the following year. Since November 1, 2004, the Employer has contracted with Blue Cross Blue Shield of Texas (BCBS). This contract was renewed for the period November 1, 2024 through October 31, 2025.

The Plan pays the insurance company a monthly service fee to administer the Plan and process claims. The Plan also pays the insurance company a monthly premium to pay for excess insurance coverage, which is included in insurance premiums and fees paid in the accompanying statement of changes in net assets available for benefits. The Plan's liability for claims paid is limited on a covered individual basis. The limitation for individuals is \$110,000 per policy year. If the amount of the claims paid exceeds the liability limit, BCBS will reimburse the Plan for the excess amount for the indicated policy period. During the years ending December 31, 2024 and 2023, total excess claims of \$1,020,432 and \$1,152,935, respectively, were offset against medical claims paid.

If the insurance policy is not renewed, BCBS will continue to pay claims that were incurred prior to the expiration date of the policy on October 31, 2025. BCBS would continue to pay such claims for 3 months after the expiration of the policy. BCBS would charge the Plan an administrative fee of approximately \$5,000 to pay such claims.

As of December 31, 2023, the Plan owed BCBS \$169,600 in administration fees and excess insurance premiums for November and December 2023. The Plan paid this amount to BCBS in January and February 2024.

As of December 31, 2024, the Plan owed BCBS \$80,961 in administration fees and excess insurance premiums for December 2024. The Plan paid this amount to BCBS in February 2025.

Claim payment checks are drawn on the insurance company's bank account. The Plan reimburses the insurance company for claims paid. In January 2025, the Plan paid BCBS \$3,400 for claims that BCBS had paid but not been reimbursed as of December 31, 2024.

Claims incurred but not reported are estimated claims from adverse events that have occurred as of the end of the reporting period but have not yet been reported to the insurance program for settlement. As of December 31, 2024, claims incurred but not reported are estimated to be \$97,600.

### **Note 5 - Plan's Benefit Obligations**

Health cost incurred by participants and their beneficiaries and dependents are covered by insurance contracts maintained by the Plan. It is the present intention of the sponsor and the plan to continue obtaining insurance coverage for benefits.

### **Note 6 - Related-Party Transactions**

Certain Plan assets were held in a non-interest-bearing account managed by the custodian of the Plan. As described in Notes 1 and 4, the Plan has several arrangements with service providers. These transactions are party in interest transaction under ERISA.

### **Note 7 - Subsequent Events**

Management has evaluated subsequent events through October 3, 2025, the date which the financial statements were available to be issued. Management has determined that no subsequent events require disclosure in the financial statements.
