## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of Employee Benefit Plan of the Commission on Accreditation of Rehabilitation Facilities (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years then ended, the statement of accumulated plan benefits as of December 31, 2023, the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

### *Opinion*

### ***Basis for Opinion***

December 31, 2024

**1. DESCRIPTION OF PLAN**

The following description of the Employee Benefit Plan of the Commission on Accreditation of Rehabilitation Facilities (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

*General*

The Plan is a defined benefit plan established on September 1, 1986, most recently restated on January 1, 2024, covering all employees of Commission on Accreditation of Rehabilitation Facilities (the “Company”), who have completed one year of service and are age twenty-one or older, excluding independent contractors and employees employed as a surveyor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Company’s Benefits Committee (“Committee”), which is a committee of the senior executives of the Company. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

In January 2024, the Plan was restated to update and improve definitions of plan compensation and operations relating to service and eligibility. Under the restated plan, the employees accrual service accumulated before a break in service will be excluded for nonvested participants or if their latest period of accrual breaks in service is equal to or exceeds five years. The restatement also amends military duty to be included as service with the employer. Additionally, participants who are part-time, temporary, or seasonal who work at least 1,000 hours of service become an eligible employee.

*Administrative Expenses*

As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or by the Company. Expenses paid by the Plan are reported on the statement of changes in net assets available for benefits as either investment or administrative expenses. For the years ending December 31, 2024 and 2023, the Plan paid investment fees of \$95,891 and \$88,543, respectively. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

## 1. DESCRIPTION OF PLAN (continued)

### *Pension Benefits*

Employees with two or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) based on a final average pay benefit formula as described in the Plan agreement. The Plan permits early retirement at ages 55-64. Employees may elect to receive their pension benefits in the form of a single lump-sum payment or an approved annuity. Approved annuity options are a straight line annuity, single life annuity with periods of three, five, ten or fifteen years, Survivorship life annuities with percentages of 66 2/3%, 75%, or 100%, a 50% survivorship life annuity with a period of ten years, a 66 2/3% survivorship life annuity with certain period of ten years, and a single life annuity with full cash refund of the present value of the participant's vested accrued benefits. Employees with benefits totaling \$1,000 to \$5,000 may elect to receive the value of their accumulated Plan benefits as a lump sum distribution upon retirement or termination. If the lump-sum value of the vested accrued benefit exceeds \$5,000, the participant will automatically receive a life annuity unless a signed waiver signed by the participant, and if married, their spouse is witnessed by a notary or a plan representative. Benefits totaling less than \$1,000 are automatically disbursed to the participant at termination.

### *Death and Disability Benefits*

If an employee is married and dies prior to commencing to receive retirement benefits, the employee's spouse will receive a death benefit equal to the minimum spouse's death benefit. The minimum spouse's death benefit is equal to the amount that would have been paid to the employee spouse if the employee had begun receiving distributions under a joint and 50% survivor annuity. If an employee is unmarried, the employee's named beneficiary will receive the death benefits. Active employees who become totally disabled receive annual disability benefits that are equal to the normal retirement benefits they have accumulated as of the time they become disabled. Disability benefits are paid until normal retirement age at which time disabled participants begin receiving normal retirement benefits computed as though they had been employed to normal retirement age with their annual compensation remaining the same as at the time they became disabled.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Fair Value of Investments*

The fair value of participation units in pooled separate accounts estimated by Principal Life Insurance Company ("Principal") is based on quoted redemption value on the last business day of the year.

The fair value of mutual funds is valued at net asset value ("NAV") of shares held by Principal as of the last business day of the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

FASB Accounting Standards Codification 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active market for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

### *Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of net assets available for Plan benefits at the date of the financial statements and the reported amounts of additions and reductions during the reporting period. Accordingly, actual results could differ from those estimates.

### *Actuarial Present Value of Accumulated Plan Benefits*

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employee's compensation during the highest consecutive three years of credited service. The accumulated plan benefits for active employees are generally based on their average compensation during the three years ending on the date as of which the benefit information is presented. Benefits payable under all circumstances – retirement, death, disability, and termination of employment—are included to the extent that they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by a Principal Life Insurance Company Consulting Actuary. It is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

*(continued)*

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The significant actuarial assumptions used in the valuations as of December 31, 2023, include:

- A percentage of employees are assumed to retire each year, with all employees assumed to retire by age 65 or valuation date, if later.
- Investment return is on an assumed average rate of return of 6.50%.
- Life expectancy of participants is based on the PRI-2012 total dataset base rate mortality table projected generationally using the Principal Mortality Improvement Scale.
- The interest rate used to value the obligation for 2024 was 6.00%.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

### *Administrative Expenses*

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in the connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

### *Reclassifications*

Certain prior year amounts have been reclassified to conform to the current year presentation.

### **3. FUNDING POLICY**

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024 and 2023, the Company made contributions of \$1,539,973 and \$628,989, respectively. The Company's contributions for 2024 and 2023 exceeded the minimum funding requirements of ERISA.

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

### **4. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The Plan has entered into investment contracts with Principal. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Principal. Investment information was obtained from data that has been prepared and certified as to being complete and accurate by Principal, the asset custodian.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

#### *Pooled Separate Accounts*

Valued at the net asset value ("NAV") of units held by the Plan at year end based on the market value of its underlying investments. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market. The Plan has no unfunded commitments related to any of these investments and there are no Plan initiated redemption restrictions on these investments. There are no redemption restrictions on participant's holdings in the investments and the Plan can redeem these investments daily.

#### *Mutual Funds*

Valued at the net asset value ("NAV") of shares held by the Plan at period end.

During the years ended December 31, 2024 and 2023, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value by \$1,804,667 and \$2,670,247, respectively. Gain and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

#### 4. INVESTMENTS AND FAIR VALUE MEASUREMENTS (continued)

The following table sets forth a description of the inputs to the valuation methodology for the three levels in the fair value hierarchy.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Investment information was obtained from data that has been prepared and certified as to being complete and accurate by Principal, the asset custodian.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Level 3.

#### 5. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company, by a letter dated March 30, 2018, that the form of the Plan is designed in accordance with applicable sections of the Internal Revenue Code Section 401(a). The Plan has been amended since receiving the determination letter. However, the Plan sponsor and the Plan's third-party administrator believe that the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, generally for three years following filing of required returns. However, there are currently no audits for any tax periods in progress. The Plan administrator believes it has not taken any uncertain tax positions that would subject the Plan to a tax liability or asset.

## 6. PLAN TERMINATION

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBCG) (a U.S. government agency) up to the applicable limitations (discussed subsequently).
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pension. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, a statutory ceiling exists, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. For Plan terminations occurring during 2024, that ceiling is \$5,502, per month. That ceiling applies to the pensioners who elect to receive their benefits in the form of a single-life annuity, the corresponding ceilings are actuarially adjusted downward. Conversely, amounts are higher for benefits starting at ages above 65.

Whether all participants receive benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Sponsor and the level of benefits guaranteed by the PBGC.

## 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **7. RISKS AND UNCERTAINTIES (continued)**

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. The Plan uses an actuary to determine the actuarial present value of accumulated Plan benefits. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

## **8. SIGNIFICANT ESTIMATES**

The estimated fair market value of investments and the actuarial minimum contribution represents significant estimates used by management that affects certain reported amounts and disclosures in the financial statements.

## **9. RELATED-PARTY/PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are pooled separate accounts managed by Principal. Principal is the asset custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Company provides certain accounting, administrative, and investment management services to the Plan, for which no fees are charged.

## **10. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulators for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the asset custodian, has certified that the following data included in the financial statements is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023.
- Schedule H, line 4i – schedule of assets (held at end of year), December 31, 2024.
- Schedule H, line 4j – schedule of reportable transactions, December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Total dataset base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan.

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes’ arithmetic returns of the plan’s target asset allocation, and then converted to the geometric under lognormal distribution assumption. **Treatment of administrative expenses**

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

#### Basis for lump sums

#### Interest rate

Based on the three segment yield curve: 3.55%/3.95%/4.95%

The plan document defines the lump sum interest rate based on IRC §417(e) rates which closely tie to the high quality corporate bond yields. According to our most recent study, the long-term expected yields for short/intermediate/long corporate bonds are 3.55%/3.95%/4.95%. #### Mortality

We have selected the same [mortality](#) assumption for lump sum payments, but with a 50/50 blend of male and female total dataset base rates and mortality improvement scales. This reflects the IRS practice of defining lump sum mortality on a unisex basis.

## Definitions

### Accrued benefit adjustment

The quotient of (a) divided by (b):

The member's accrual service as of such date.

The member's potential accrual service as of the date he reaches normal retirement age, if he remains an eligible employee between the date of determination and the date he reaches normal retirement age.

The accrued benefit adjustment cannot be greater than 1.0.

### Average compensation

The monthly average of "415" pay plus elective deferral contributions received for the 3 consecutive compensation years out of the last 10 prior to normal retirement date.

### Covered compensation

A single amount in any given year equal to the monthly average of the social security taxable wage bases (in effect under section 230 of the social security act) for each year in the preceding 35-year period, for an individual that attains social security retirement age that year.

### Optional forms of benefit payments

The optional forms of benefit payments are:

- Monthly annuity payable for life, or 3, 5, 10, or 15 years certain and life.
- Monthly annuity payable as a survivorship life annuity with survivorship percentages of 66 2/3, 75, or 100.
- Monthly annuity payable as a survivorship life annuity with survivorship percentages of 50 or 66 2/3 with 10 years certain.
- Single sum payment equal to the present value of the accrued benefit.

The optional form conversion basis is 9.5% interest and the mortality table in Revenue Ruling 95-6 for payments other than lump sums.

The optional form conversion basis uses the applicable interest rate and applicable mortality table as set forth in Code Section 417 for lump sum payments. The applicable interest rate uses the second calendar month preceding the first day of the stability period which is the plan year.

## Changes in Principal Eligibility or Benefit Provisions

There have been no changes in principal eligibility or benefit provisions since the last valuation.

## Significant Event

The enrolled actuary has not been made aware that any significant events have occurred during the year.
