### Opinion

## **Note 1 - Description of Plan**

The following brief description of the R & H Mechanical, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

R & H Mechanical, Inc. established the Plan effective as of January 1, 2018. Effective June 30, 2024, R & H Mechanical Holdings, Inc. (the Company) became the Plan sponsor and all activity was transferred from R & H Mechanical Inc. to R & H Mechanical Holdings, Inc. The Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the IRC and is subject to the applicable provisions of ERISA. Effective June 30, 2024, the Plan is administered by R & H Mechanical Holdings, Inc. Prior to this date, the Plan was administered by R & H Mechanical, Inc. The Company conducts its business operations primarily through R & H Mechanical, Inc. and its wholly-owned subsidiary Climate Control Company, LLC. Effective August 31, 2020, employees of Climate Control Company, LLC were covered under the Plan. Effective January 1, 2022, employees of Radar Engineering, Inc. were covered under the Plan. Effective January 1, 2024, employees of EMC Enterprises, LLC, were covered under the Plan. First International Bank and Trust is the trustee.

The Plan purchased Company common stock with a loan from the Company and holds the common stock in a trust established under the Plan. The borrowing is to be repaid over a period of time by fully deductible company contributions to the trust fund. As the plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of stock. The lender has no rights against shares of the common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

1. Accounts of employees with vested rights in allocated common stock (allocated).
2. Common stock not yet allocated to employees (unallocated).

### **Eligibility**

Employees are eligible to participate in the Plan if they have completed one year of service and are 21 years of age. An employee will be credited for one year of service if they have worked at least 1,000 hours during a consecutive twelve-month period. Leased employees, union members, independent contractors and non-resident aliens are not eligible to participate in the Plan.

### **Entry Date**

Employees may enter the Plan on the first day of January preceding the date they satisfy the Plan's eligibility requirements.

### **Contributions**

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted. In 2024, the Company made a discretionary contribution of \$30,926.

### **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

### **Put Option**

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase in cash or installments over a period of not more than five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

**Vesting**

Vesting in the employer contributions and related earnings is based on years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2	25%
3	50%
4	75%
5	100%

A year of service is any fiscal year during which the employee has 1,000 or more hours of service. Participants are 100% vested in their account balances upon attainment of age 65, death, or permanent disability.

**Forfeitures**

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures are used in the same year they are forfeited. Forfeited accounts are used to reduce employer contributions or allocated to eligible participants. During the year ended December 31, 2024, forfeited non-vested accounts totaling approximately \$15 in cash and shares of approximately 1,887 were allocated to eligible participants. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation.

**Payment of Benefits**

Upon death, disability or retirement, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account as defined in the Plan document.

Distributions for other separations from service commence in the sixth Plan year following the separation from service and are made in five annual installments. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock.

If after a participant terminates employment, the value of the vested account balance is \$1,000 or less, the participant shall receive such vested account balance in a lump sum by the end of the following plan year. If after a participant terminates employment, the value of their vested account balance is \$5,000 or less, but more than \$1,000, the participant may elect to receive such vested account balance in a lump sum by the end of the following plan year. If the participant does not elect to have the distribution paid directly to another qualified retirement plan or IRA and does not elect to receive the distribution directly, the Plan administrator shall transfer such vested account balance to an IRA of its choosing and shall notify such participant in writing of the transfer and that the distribution may be transferred by the participant without cost or penalty to another qualified retirement plan or IRA.

**Diversification**

Diversification is offered to participants so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. For statutory diversifications, participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account into an account in his or her name in another tax-qualified plan maintained by the Company, be paid directly to the participant or rolled into another eligible retirement plan of the participant. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of their vested account balance less amounts previously transferred. In the sixth year, the percentage changes to 50% less amounts previously transferred. The Plan also has a special diversification provision that allows participants that transferred funds from a defined contribution plan maintained by the Company to the Plan at the Plan's inception to diversify a portion of their account balance into an account in his or her name in another tax-qualified plan maintained by the Company, paid directly to the participant or rolled over into another eligible retirement plan of the participant. A participant may diversify up to 20% of their investment election account balance in investments other than employer securities. During 2024, there were no participants eligible for diversification.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their account.

**Note 2 - Significant Accounting Policies****Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis using the stock valuation from the prior year end. Net appreciation (depreciation) includes the Plan's gains and losses on the common stock held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

## Payments of Benefits

Benefits payments to participants are recorded upon distribution.

## Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements.

## Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

## Subsequent Events

The Plan sponsor has evaluated subsequent events through September 30, 2025, the date which the financial statements were available to be issued.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes on the methodology used at December 31, 2024 and 2023.

Common Stock - The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, discount rates, return on assets, return on equity, market comparables and estimated fair value of Company assets and liabilities, including certain discounts.

Money market deposit accounts – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

### Note 5 - Note Payable

In December 2018, the Plan entered into a \$2,250,000 term loan agreement with the Company, to be repaid over a period of 20 years. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 15,789 shares being released and allocated for the Plan year ended December 31, 2024.

### Note 6 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated April 7, 2020, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7 - Administration of Plan Assets

The Plan's assets, which consist principally of Company common shares are held by the trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which is reimbursed to the Trustee through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

**Note 8 - Risks and Uncertainties**

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**Note 9 - Related Party and Parties-in-Interest Transactions**

The Plan invests in Company common stock and has indebtedness with or guaranteed by the Company. These are related party and party-in-interest transactions.

**Note 10 - Right of First Refusal**

Company stock that has been distributed to a participant and not immediately repurchased by the Company or Trust, may be subject to a right of first refusal if so, determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company, and then, if refused by the Company, to the Trust at fair market value as determined by an independent appraiser appointed by the ESOP Committee.
