## Report of Independent Auditors

To the Administrator of BAYADA Home Health Care 403(b) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### 1. Description of Plan

The following description of the BAYADA Home Health Care 403(b) Plan (the “Plan”) sponsored by BAYADA Home Health Care, Inc. (the “Company” or the “Plan Administrator”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering Highly Compensated Employees (“HCE”) employed by the Company’s entities that have 501(c)(3) tax-exempt status. As of December 31, 2024, participating employers in the Plan include BAYADA Home Health Care, Inc. (Plan Sponsor), BAYADA Home Care (“BHC”), JeffHome PA, LLC, and JeffHome NJ, LLC. The covered employees (as defined in the Plan Document) who are Highly Compensated Employees of the participating employers are eligible to participate. HCE determination is completed by the Plan Sponsor at the end of the preceding year. Employees who are eligible to participate in the Plan are excluded from making participant contribution deferrals to the BAYADA Home Health Care 401(k) Plan (“401(k) Plan”). As per the Plan provisions, eligible employees who lose HCE status in a future year remain eligible for the 403(b) Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Company’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and is involved with other administrative matters and determining the Plan’s valuation policies utilizing information provided by the investment consultant, trustee, and insurance companies.

#### Participant Contributions

The Plan allows participants to make tax deferred or Roth after-tax contributions of up to 80% of eligible compensation, as defined in the Plan Document. Employee contributions are limited to the maximum amount allowable under the Internal Revenue Code (IRC) (\$23,000 in 2024, plus a \$7,500 catch-up if age 50 or over, respectively). Participants may modify their deferral elections at any time. Qualified distributions from other qualified retirement plans or certain IRAs can also be contributed to the Plan by employees and retained as a rollover contribution.

#### Employer Contributions

Effective as of the 2022 plan year, the Company may make discretionary matching contributions equal to a percentage of the salary an employee elected to defer; the percentage will be determined each year by the Company. During 2024, the Company matched 35% of the first 4% of participant contributions. The Company does not match catch-up 403(b) contributions to the Plan. During 2024, the Plan participants were eligible for discretionary matching contributions upon attaining age 21 and completing 1 year and 1,000 hours of service. For an eligible terminated participant to receive a discretionary matching contribution for the year ended December 31, 2024, the participant must have completed over 501 hours of service during the Plan year or have been actively employed on the last day of the Plan year, unless termination was due to death, disability, or attainment of normal retirement age. For the year ended December 31, 2024, the discretionary matching contribution was \$1,286,451, which the Company paid on March 6, 2025.

#### Vesting

Participants are immediately vested in their voluntary contributions and the earnings thereon. Participants are vested in discretionary matching contributions and earnings based on years of

service. To earn a year of vesting service, employees must work over 1,000 hours in a calendar year. The following table is the vesting schedule by years of service:

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the appropriate employer discretionary matching contribution, Plan earnings, and realized and unrealized gains and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Terminated participants forfeit nonvested Company contributions at the earlier of account distribution or completion of a consecutive 5-year break in service. Upon subsequent reemployment if before a 5-year break in service, these may be reinstated to the participants' accounts in accordance with conditions included in the Plan Document. Participants are not allowed to take loans from the Plan.

#### **Forfeited Accounts**

Forfeitures of terminated participants' nonvested amounts together with related Plan earnings may be used to pay any administrative expenses of the Plan, to reduce the employer discretionary matching contributions, to be reallocated to participants and to be reinstated to the participants upon subsequent reemployment in accordance with conditions in the Plan Document. During 2024, the forfeited vested accounts were used to reduce employer discretionary matching contributions in the amount of \$21,218. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$21,055 and \$34,168, respectively.

#### **Payment of Benefits**

On termination of service a participant may elect to receive either a single lump sum payment equal to the value of the participant's vested interest in his or her account, installment payments over a period of not more than assumed life expectancy, ad-hoc (partial distribution of vested plan account), or if eligible, direct rollover into an IRA or other eligible retirement plan. Required Minimum Distributions, hardship withdrawals and installment payments made over the participant's life, the life of the participant's Beneficiary or for a specified period of 10 or more years are ineligible for rollover. If a participant's Beneficiary receives distribution in a single-sum payment or in installments over a period of less than 10 years, the beneficiary may also elect a direct rollover, as described above. If the beneficiary is the participant's spouse or a former spouse, he or she may rollover the distribution to an IRA (including a Roth IRA) or to any other eligible plan. The non-spouse Beneficiary may only rollover the distribution to an IRA (including a Roth IRA) that is treated as an inherited IRA for required distribution purposes.

The Plan allows for in-service distributions from all money sources upon attainment of age 59.5, and hardship withdrawals based on the safe harbor criteria detailed in the Plan Document. In addition, rollover contributions may be withdrawn at any time with no restrictions.

The required minimum distribution age is age 73 corresponding with April 1 of the calendar year following the calendar year in which the participant attains age 73.

#### **Investment Options**

Participants direct the investment of their accounts into various investment options that are offered by the Plan. As of December 31, 2024, the Plan currently offers eighteen mutual funds, and an investment contract as investment options for the participants.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments of the Plan are stated at fair value, except for the investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. The net appreciation (depreciation) in fair value of investments reported in the statements of changes in net assets available for benefits includes gains and losses on investments bought and sold, as well as held during the year. Realized gains or losses on sales of securities are determined using the average cost method.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Administrative Expenses**

The Plan allows for payment of some or all of the eligible operating expenses from the Plan assets. Eligible Plan operating expenses can be any non-settlor fees, including but not limited to advisor fees, recordkeeping fees and Plan audit fees.

#### **Revenue Sharing Account**

The Plan has an ERISA Fee Recapture Account where Empower Annuity Insurance Company deposits the excess revenue sharing funds collected from the investment products used by the Plan, as well as fees charged to participants accounts. This account is intended for use to pay administrative expenses.

**3. Information Certified by the Trustee and Insurance Company**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. All Plan assets at December 31, 2024 and 2023 were held by Empower Trust Company LLC (formerly known as Prudential Bank & Trust, F.S.B.) and Empower Annuity Insurance Company (formerly known as Prudential Retirement Insurance and Annuity Company), the trustee and insurance company, respectively. Accordingly, investment amounts on the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, investment income (loss) including net appreciation (depreciation) in fair value of investments, interest, and dividends and realized gains on the Statement of Changes in Net Assets Available for Benefits for the years December 31, 2024, and information included in the accompanying supplemental schedule of Form 5500 - Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 have been compiled from statements certified as complete and accurate by the trustee and insurance company of the Plan in accordance with 29 CFR 2520.103-8 of DOL Rules and regulations for reporting and disclosure under ERISA.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Registered Investment Companies**

The fair value of registered investment companies is measured by the daily closing price as reported by the fund, which represent the net asset value of shares held by the Plan at year end. Mutual funds of the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**5. Investment Contract With Insurance Company**

The Plan has a fully benefit-responsive investment contract with Empower Annuity Insurance Company ("EAIC"). EAIC maintains the contributions in a general account. The account is credited with earnings and interest on the underlying investments and is charged for participant withdrawals and administrative expenses.

The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings at guaranteed crediting interest rates, less participant withdrawals, and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The crediting rate for the Guaranteed Long-Term Fund is based on actual cash flow experience and general account earnings but may not be less than 1%-3%. The crediting rate is 4.50% and 2.25% as of December 31, 2024 and 2023, respectively. If a Plan Sponsor decides to terminate the Guaranteed Long Term Fund contract, the plan can receive 6 book value payments over 5 years or a lump sum at market value based on established practices. Also, the Plan Sponsor can also choose to have payments made annually for no more than 10 years.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to Plan documents (including complete or partial Plan termination or merger with another Plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or 5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, or 4) a material amendment to the agreement without the consent of the issuer.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of a Plan termination, participants will become 100% vested in their accounts.

### **7. Risks and Uncertainties**

The Plan invests in various investment funds. Investment funds are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **8. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan Administrator received the determination letter dated March 3, 2025. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for participants of the Plan. The Plan Administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan is qualified and the related custodial accounts are

tax- exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

#### **9. Related Parties and Party-in-Interest Transactions**

The Plan invests in an investment contract managed by Empower Annuity Insurance Company, the insurance company. Interest and dividends and realized gains received by the plan, from the investment contract was \$89,376 and \$1,433,673 respectively, for the year ended December 31, 2024. All these transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### **10. Subsequent Events**

The Plan's management has evaluated all activity of the Plan through October 2, 2025, the date the financial statements were available for issuance, and concluded that there are no other subsequent events that are required to be reflected in the Plan's financial statements and disclosures.
